

REAMES CONFEE COUNTY BONDING GOOD ROADS BILL

SALEM, Feb. 14.—The senate refuses to concur in amendments made by the house to senate bill No. 12, known as the Barrett-Hurd County Bonding Act bill, which passed the house, and has appointed a conference committee of three members to confer with three to be appointed by the house.

The trouble is caused by the wrangling among different paving companies, who want to get a hold upon the business. The senate has appointed Burgess, Farrell and Butler and the house appointed Reames, Forbes and Upton as a conference committee to draw a new bill.

The senate roads and highways committee, of which Senator Von der Hellen is chairman, is one of the busiest of the senate committees. Much important road legislation is pending. Several bills for county bonding acts, a number providing for state aid for highways, and numerous others, embracing less important legislation, each designed as a special panacea for road ailments, are causing this committee to meet often and deliberate at great length. Other members of the committee are Senators Carson of Marion, Day of Multnomah, Ragsdale of Gilliam, Sherman and Wheeler and Barrett of Morrow, Union and Umatilla.

Senate bill No. 41, introduced by Senator Von der Hellen, amending section 6307 of Lord's Oregon Laws, and providing for roads and gateways for lands not reached by public highways, has the distinction of being among the first bills to be signed by the governor.

Senator Von der Hellen was one of a joint committee to investigate the Soldiers' Home at Roseburg, February 12th.
