SALEM, Feb. 26 .- The senate has today accepted the house amendment ander which it is proposed to pay future legislators \$5 per day with a maximum limit of \$200, the intention being to provide for a sixty day session at the increased pay. Mileage is reduced from the present rate of fifteen cents to ten cents. The matter will be voted by the people in 1914 in the form of a constitutional amendment.
