SALEM, Ore., Feb. 26.—Governor West is still limping from a sprained knee received rubbing stumps on his Canon beach ranch Saturday.

"How did you do it governor; sliding down 'in a hole'?" he was asked.

"No, I did that climbing out of the hole," he retorted.

"While I was riding along I overtook a man on a loaded wagon. He was going to let me pass when he recognized me."

"No I won't do it," he yelled at me. "I've got you just where I want you. The longer I keep you here the longer I keep the legislature from raising our taxes."

"And you can believe me, I didn't run across any taxpayers down there who cared whether I got back to Salem or not. They weren't worrying about the appropriation bills not being signed."

According to Jack King, the Portland trainer who has just returned from San Francisco, Wolgast was better pleased with what he saw of Medford and the Rogue river valley than any other section of Oregon. King states that Wolgast intended to return to Medford to close the deal.

**REDDY RECEIVER OLD CHANNEL MINE**

GRANTS PASS, Feb. 26.—Upon the application of lien claimants, Judge Calkins has appointed Dr. J. F. Reddy as receiver for the Old Channel Mining company, a corporation holding one of the most noted of the placer mines of the Galice district. Numerous labor and material claims had been filed against the company during the past winter.

The court has also recently approved the claim of J. R. Harvey of this city to a 10-85ths interest in the Old Channel Mining company, he having brought action against Thos. W. Browning, Geo. Sanders, et al. to establish his right in the matter, and the affirmation of his contention followed. Mr. Harvey was already owner of one-sixth of the stock in the company.

These orders of the circuit court put the affairs of the Old Channel in a fair way to settlement and the adjudication of the claims against the company should follow with the least possible delay. Dr. Reddy is well known as a thorough-going business man, and under his direction the Old Channel will undoubtedly see the end of its difficulties.

**MAYOR ARGUES FOR BONDS WITH FISTS**

Interest in the bond election at Eagle Point reached the fighting stage Tuesday when Mayor William Von der Hellen of that place mixed it for several rounds with Charles Haward, a P. & E. brakeman. Haward held forth against the advisability of bonding Eagle Point for \$10,000 to improve the streets and the mayor took exceptions, using right and left swings to emphasize his objections. Spectators separated the men before the issue was thoroughly fought out. The election is called for Friday, Feb. 28, and has stirred up no end of discussion and excitement.

**SUPREME COURT UNTANGLES OREGON SAVINGS BANK CASE**

SALEM, Ore., Feb. 26.—Decisions in the famous Oregon Trust & Savings bank cases have been handed down by the supreme court. In both cases, the decree of the lower court is modified.

In the principal case, in which Thomas C. Devlin, as receiver for the Oregon Trust & Savings bank, against Walter H. Moore and Henry A. Moore, appellants, while Elmer E. Lytle, W. H. Copland, L. O. Ralston, Leo Friede, Albert T. Smith and W. Cooper Morris were also defendants, the decree of the lower court is changed as to Henry A. Moore, who is out held liable for the losses of the bank. The decree of the lower court is affirmed as to Lytle, Copland, Ralston, Friede and Smith, who were not held liable.

Morris was held liable for the funds but he did not appeal.

"We find that the people demand an hourly service," states Mr. Barnum, "and so we have put one on which will remain indefinitely."

### RAPID FIRE MOTOR RURAL MAIL DELIVERY

A special time schedule on Rural Route No. 3 is to be provided by Uncle Sam for O. G. Vroman of this city who has just received his appointment as a carrier. Vroman will cover the route on a motorcycle which he has especially fitted with equipment to carry 100 pounds of mail. As the cycle make rapid time a new time schedule is to be provided.

The route is 26 miles long and the present schedule calls for a return to the postoffice not earlier than 2 p. m. each day. Vroman can cover the route easily by 10 a. m., so a special schedule is to be provided.
