

DARROW JURY FAILS TO AGREE

Eight for Conviction, Four for Acquittal—Case Will Be Retried—March 31 Set as Date for Rehearing—Darrow Disappointed

DARROW'S STATEMENT.
"Upon the evidence I should have been acquitted at once.
"My innocence has been firmly established twice, but there were some men on the jury who would have voted to convict me even if they had not heard a word of the evidence.
"I will stay here and fight as long as is necessary. I can keep going as long as Fredericks can, and I hear he is going after me again.
"Well, I'm here; and my friends are with me. I wasn't acquitted, but I'm still able to fight."

LOS ANGELES, Cal., March 8.—After deliberating thirty-eight hours and forty minutes the jury that tried Clarence S. Darrow on a charge of bribing Robert F. Bain, a juror in the McNamara trial, reported to Judge Conley today that it was hopelessly disagreed. The jury was discharged after the court's formal poll of its members showed that it stood eight for conviction to four for acquittal.

The court complimented the jurors for their patience, thanked them for their services and dismissed them. Judge Conley fixed March 31, as the time for the next trial. He added that if the prosecution moves that the case be dismissed, any superior court judge is empowered to dismiss it.

MARKED DECLINES IN STOCK MARKET

NEW YORK, March 8.—Standard Oil of New Jersey stock was offered on the curb at \$3.36 in the stock trading here today, a break of twenty points over night. There were few bidders. South Pennsylvania Oil which recently sold at 10.95 was offered at 8.95 at the opening with no takers.

GREEK PRINCE ENTERS CAPTURED STRONGHOLD

ATHENS, March 8.—At the head of his forces, Crown Prince Constantine entered Janina at noon today, according to advices received here. He was met by 15,000 citizens of the city and given a rousing welcome. Perfect order reigns in the city, the Turkish pillagers having fled.

LIVES RUINED BY SMALL WAGES

Starvation Pay of Mail Order and Department Stores Drove Employers Promise Co-operation

CHICAGO, March 8.—Driven to enter a white slave resort by the impossibility of living on \$4 a week, "E. G." told to the senate "starvation wages" probers here in executive session, a story on hell on earth in the white slave dens which made the committee pale with horror. "E. G." today is in a church hospital a wreck. She was carried into the committee's room almost helpless and testified that when her husband died, leaving her with a child to support, hunger forced her into a life of shame.

Get List of Suicides.
The probers today asked the coroner for a list of women suicides who ended their lives because they were unable to obtain employment. These cases are to be exhaustively examined so far as possible to trace them.
Lieutenant Governor O'Hara today personally appealed to a group of employers waiting to testify to lead their aid toward the passage of a law providing a minimum wage of \$12 weekly for all women workers in Illinois. Some promised to do so.

Admits the Truth.
"I don't know the exact relation but I believe the girls will sell themselves rather than starve."
Hillman said he employs 1817 girls at an average weekly wage of \$8.71. Of these, 23 girls, he said, get \$3.50, \$4 and \$5. Others holding positions below that of saleswomen get \$6. Most of the \$3.50 girls, he said, were employed at the request of their parents.

As the employers of these girls, Hillman said, "I feel a moral responsibility. We have social workers and a woman doctor to visit the girls and to see to their health."
Hillman said he had discharged immoral floorwalkers and had had their names listed so they could not obtain employment at any other department store. He declared no worthy girl could be held down because one of her superiors disliked her and denied positively that girls are blacklisted at the local stores if they offend their employers.

Promises Cooperation.
Hillman accepted the suggestion of O'Hara and promised to employ investigators on Monday to learn the truth of statements made by the girls seeking employment. He thought that from \$8 to \$9 a week was sufficient to support a girl but refused to answer any questions as to the profits of his store.
At this Senator Juul said: "If you employers do not help us to find a solution of the social evil some worse means will be used."

WEEKS DEADLOCK TIES UP PARLIAMENT

OTTAWA, Ont., March 8.—Still talking against time in an effort to force a general election on the question of how Canadian aid to imperial defense should be given, the liberals under Sir Wilfrid Laurier today kept the deadlock in the house of commons. The battle of words will end tonight at midnight, when adjournment will be taken until midnight on Sunday when the members will return afresh and the struggle begin anew.

ANOTHER CANDIDATE FOR FEDERAL MARSHALL

EUGENE, Ore., March 8.—Harry L. Brown, who served two years as sheriff of Lane county previous to the first of this year, has today announced his candidacy for the office of United States marshal for the district of Oregon and forwarded his application to the United States attorney general.

POLICE LEAGUED WITH HOODLUMS

WASHINGTON, March 8.—Sworn declaration that the police were in league with hoodlums to break up the suffragette parade here March 3 was given the Jones sub-committee here today by George Canfield of Spokane, Wash. He told the probers of a sneering answer he received from a policeman when he asked him the time the parade was scheduled to start.
"There ain't going to be no parade," Canfield says the policeman told him, "because it's going to be busted."
Former Secretary of War Stimson was among the witnesses testifying today. He told the committee that the law prevented his using regular troops to clear the streets and said he stretched his authority when he finally ordered a troop of cavalry from Fort Meyer to restore order.
General Aumonier, one of the marchers in the parade, characterized the crowd as a "sneering gathering of hoodlums" which the police made no effort to rebuke.

LYMAN OUT AGAIN, IN AGAIN, PENITENTIARY

TACOMA, Wash., March 8.—Dr. John Grant Lyman, convicted of conspiracy to escape from the custody of the federal authorities in San Francisco, enjoyed just two and a half hours of freedom today after serving six months in McNeil's federal prison for his crime.
Immediately upon his release from prison, Lyman, in company of two guards, left for the city. Deputy United States Marshal Davidson was waiting for the party and placed Lyman under arrest. The prisoner must return to Los Angeles to face a charge of using the United States mails to defraud.
Lyman will be taken south today.

M'NICHOLAS ESCAPES FROM JAIL HOSPITAL

CLEVELAND, Ohio, March 8. Search here today for James McNicholas, a Portland, Oregon, broker, recently arrested in Boston as a fake gold mine promoter, revealed no clue to the whereabouts of the man who broke out of the jail hospital last night.

FOURTH CONVICTION FOR VICE CLIQUE

PORTLAND, Or., March 8.—Herbert King, convicted recently of being a member of the vice clique, has today been sentenced by Judge Gatens to six months in the county jail. His was the fourth conviction in the vice clique crusade.

WILSON'S BROTHER DEFEATED FOR JOB

WASHINGTON, March 8.—Joseph Wilson, brother of the president, was defeated for the secretaryship of the senate, after a two days' battle in the Democratic caucus. James Baker, assistant librarian for the senate, gets the \$6,000 job. He was elected on the second ballot.

CALL FOR BIDS FOR NEW COUNTY VAULT

The county court Saturday issued a call for bids for the construction of a new vault in which to keep the county records. The present vault in the recorder's office is far too small and is unsafe.
In addition to building the new vault the county court plans to install an additional set of filing cases in the clerks' vault. All available filing space is used, causing some of the records to repose upon the floor of the vault.

M'FARLAND WINS FROM JACK BRITTON

NEW YORK, March 8.—By putting over everything short of a knockout, Packey McFarland, the Chicago stock yards fighter, won out over Jack Britton, also of Chicago, in their ten-round go at Madison Square here. Britton put a right hand counter to the chin in the fourth that staggered McFarland, but it was the only solid punch he landed.
It was a clean-cut contest from the first bell and there is talk here today of rematching the boys. Except in the fourth, Packey had a clean lead in every round, but Britton fought in a tigerish fashion and what would have happened had the bout gone longer is a matter of conjecture.

OHIO RUBBER WORKERS LOSING THEIR STRIKE

AKRON, Ohio, March 8.—That desperate conditions confront the striking rubber workers here was admitted by strike yeaders today. The sole hope for continuing the strike now rests on outside aid.
The manufacturers claim that 4000 strikers have returned to work, and that hundreds more are applying for their old positions. The legislative probe into the strike was resumed today.

WILSON EIGHT MINUTES TAFT OVER 2 HOURS

WASHINGTON, March 8.—President Wilson today received the justices of the United States supreme court. It required eight minutes only for the president to greet the jurists, shake their hands and say good bye.
When former President Taft first received the court it required two hours and thirty minutes for him to do what Wilson did in eight minutes.

EXPLOSION DEATH LIST NOW THIRTY

BALTIMORE, Md., March 8.—Not more than thirty persons met death in the explosion of 300 tons of dynamite being loaded on the Almachine at Curtis Bay, a Baltimore suburb, according to revised lists compiled here today. The number of injured is placed at 70. The bodies of 20 dead have been brought to the morgue but prevailing cold weather probably will delay the recovery of the other bodies.
Tales of heroism today were numerous. John Goodhue in a launch saved 18 persons and tugs from Curtis Bay saved everyone aboard the tug Atlantic. The United States collier Jason was wrecked along with the Almachine and the tug Atlantic. The monetary loss today was estimated at \$200,000.

AKIN APPEALS FOR FAIR PLAY

STRIPES ABOLISHED SAN QUENTIN PRISON

SAN QUENTIN, Cal., March 8.—Convicts at the state penitentiary here today are jubilant over the decision of the state board of prison commissioners to abolish stripes. A blue cadet uniform will be adopted instead, only the incorrigibles will be kept in stripes.

MARSHALL FIELD'S MANAGER MUM

CHICAGO, March 8.—Refusal to testify before the Illinois legislative committee which is investigating the payment of wages to girls in Chicago's big department stores and white slavery question, may cost James Simpson, vice president of Marshall Field and company, a heavy fine, or possibly a jail sentence.
Simpson, when examined, declared that the Marshall Field company employed 4,222 girls and women. He declared their average weekly wage is \$10.75 but admitted that "short hour girls" are paid on a basis of \$8 per week and that many of them do not make more than \$4 weekly. Asked to state the profits of the Field business so that the probers might be informed as to whether wages might fairly be increased, Simpson refused to answer. Today it will be decided whether he shall be compelled to reply.

ANYONE CAN SEE WOODROW WILSON

WASHINGTON, March 8.—Joseph Tumulty, private secretary to President Woodrow Wilson, announced here this afternoon that the newspaper men would have entry to his office unannounced and unhindered. This means it will be practically impossible for any one to visit Wilson without the correspondents learning the visitor's identity.

CLOWN CONVICTED OF MURDERING HEIRESS

CHICAGO, March 8.—Charles Conway, a former circus clown and his wife Beatrice Conway, were convicted here today of murdering Miss Sophia Singer, a Baltimore heiress, in a lodging house here last October. The jury recommended a life sentence for Conway and 14 years for his wife.
The Conways gave notice that they would enter a motion for a new trial.

WASHINGTON ADOPTS STRONG ANTI-TRUST LAW

OLYMPIA, Wash., March 8.—Senator Nichols' bill to put all trusts out of business is up to the house. This bill, which prohibits any commodity to be sold in Washington at a higher price than anywhere else in the world, was passed by the senate Friday by a vote of 23 to 17 in spite of the positive assertion on the part of many lawyers that it is unconstitutional.

CURE IS GIVEN TO UNCLE SAM

Scientist Presents Culture Without Hope or Promise of Reward to Surgeon-General Blue—Experiments to Be Made in Army

NEW YORK, March 8.—Traducers of Dr. Frederick Franz Friedmann, discoverer of an alleged tuberculosis cure were handed a hard jolt here today when Surgeon-General Blue announced that the young Berlin scientist has given his culture to the United States government without hope of financial reward. This preliminary sets at rest published reports that Friedmann came to America to make millions out of his treatment.

Another important announcement today was that the government is to give Friedmann's culture an immediate and thorough test. With this end in view Surgeon John Anderson and Passed Assistant Surgeon Arthur Stimson have been assigned to the investigation and will leave for New York tonight to remain with Dr. Friedmann until he has taught them how to administer his remedy.
Monkeys will be subjected to treatment first. The tests will be of the most exhaustive nature and will require months of work and examination. If the culture is proven efficacious and the monkey patients show improvement it then will be given to the tubercular sufferers in the government hospitals in Fort Staunton, N. M. If successful there, it then will be extended to the other 26 hospitals in the government's service.

PLAN INCOME TAX TO REPLACE TARIFF

WASHINGTON, March 8.—To raise at least \$100,000,000 to replace the revenues lost through the slashing of the tariff, the house ways and means committee is considering an income tax here today.
Many of the committeemen advocate the passage of an income tax law at the extra session. Some favor taxing incomes down to and including \$3,500 annually. The majority, however, advocate \$5,000 yearly as the minimum income to which the tax could be applied. Tentative bills are being prepared.

BARNUM ASKS FOR 20-YEAR FRANCHISE

W. S. Barnum, president of the Rogue River Valley railroad, has asked the city of Jacksonville for a 20-year franchise for his steam road in Jacksonville and has also asked the privilege of electrifying the line if he sees fit.
According to the terms of the franchise which Mr. Barnum seeks he does not agree to make any return to the city.
The new council will probably order an election on the matter.

TAX COLLECTIONS KEEP MANY BUSY

The money for taxes continues to roll in at Jacksonville, Chief Deputy Wilson and a force of a dozen deputies being kept on the jump handling the collections. In addition to this the several banks over the county are busy receiving taxes.
According to present indications about \$50,000 in taxes will be collected by tonight when the first week closes. Taxpayers have until next Saturday to pay their taxes and get their rebate.

OLNEY OFFERED JOB COURT OF ST. JAMES

WASHINGTON, Mar. 8.—Richard Olney of Boston, a former United States attorney general under Grover Cleveland, today was offered the ambassadorship to England by President Wilson.
