"Their families should," answered the witness. Lyttou promised to furnish an itemized statement showing how a girl could live on \$8 a week. He admitted his company could afford to pay girls a minimum wage of \$12 a week but objected to such legislation, "because raising unskilled labor necessitates an advance in the entire wage scale, and those now getting \$12 would demand \$20 a week."

NATION WIDE ARSON TRUST IN EXISTENCE

SOUTH BEND, Ind., March 10.—Confession that a nation-wide "arson trust" exists was made here today by Ben Fink, alias Finkelberg. He admitted that 29 fires in Chicago and numerous others in western cities, aggregating a loss of \$599,999 were of incendiary origin. Fink implicated 59 Chicago and New York insurance adjusters and 100 others. He declared that Adjusters Spira and Zar of Chicago, whom he says are heads of the trust, paid him from \$400 to \$1500 for each building fired. Spira and Zar sometimes receiving as much as \$10,000 for each building destroyed.

SEVEN PATIENTS GIVEN TURTLESERUM BY DR. FREIDMAN

NEW YORK, March 10.—Dr. Frederick Franz Friedmann, discoverer of an alleged tuberculosis cure, remained in his apartments at the McAlpine hotel here today, and prepared to take his cultures to Canada. He will return to New York the last of the week and will administer his treatment to about 1,000 additional patients here. Much favorable comment was heard today on Dr. Friedmann's work yesterday when he treated seven tuberculosis sufferers, under government inspection, in 30 minutes clinic. The nervousness which marked his first demonstration here was absent, and Dr. Friedmann worked smoothly and rapidly. The tests were given at the Mount Sinai hospital and were witnessed by Surgeon F. F. Anderson and Passed Assistant Surgeon A. M. Stimson of the government health service. The seven cases treated by Dr. Friedmann yesterday are to remain under government observation and upon their development will depend the official report.

NEW LOW POINT FOR UNION PACIFIC

NEW YORK, March 10.—Union Pacific touched a new low point at 148 1/2 in the stock market today. Canadian Pacific dropped four points and Jersey Central 3. Good recoveries followed. Financial strain both here and abroad led to heavy selling. Speculation centered around Union Pacific and Steel, but the market was listless throughout and closed dull. Bonds were heavy.
