

NEWBURY BRANDS MILLAR HEARING GREAT OUTRAGE

Spurred by rulings of Mayor Elbert Wednesday afternoon on points of law, which he branded as "amazingly unfair," and without precedent in "any court in the world," Attorney Newbury branded the Millar trial as the most disgraceful he had ever witnessed. He accused Mayor Elbert and City Attorney Boggs with conspiring to persecute a man who would not do their bidding and admonished witnesses not to answer questions, calling for a conclusion, in spite of the fact that Mayor Elbert ruled that the questions might be answered.

"I am probably in contempt of court," shouted Newbury, "but the manner in which this trial is being conducted leads me to protest in this manner. Fine me if you wish, and I will pay it, but I want the city to know, as it is beginning to know, that this trial is an outrageous farce, with nothing of justice about it. Ask any twelve men in the city what they think of it and nine will tell you that it is a persecution and not a prosecution. The attitude of the court is plainly shown by its rulings."

"You keep quiet," admonished the court, leveling his forefinger at Newbury.

"I don't think I will," retorted Newbury, as he folded his arms.

Applause Follows.

When Newbury completed his arraignment of the trial and the manner it is being conducted, the large number of citizens present demonstrated clearly the sentiment of the people at large by applause.

Wednesday afternoon the defense offered its testimony. Judge Crowell, F. O. Burgess, C. W. McDonald and other prominent business men of the city testified as to Millar's good character and to the fact they had known of nothing derogatory concerning the Manhattan cafe. Witnesses also testified as to the reputation of Menno Davis, chief witness for Boggs, for truth and veracity. It is very poor, according to them.

Mrs. Gardner and Miss Stiles, employed by Millar, testified as to their orders concerning the sale of liquor at the Manhattan.

Attorneys Newbury and Boggs mixed several times during the afternoon session. Newbury at one time accused Boggs of stirring up the indictments against the Medford saloon men.

"How do you know that?" asked Boggs.

"Why, like everybody else," replied Newbury. "It is a matter of common knowledge."

That the spectators have little regard for the dignity of the court is shown by the laughter which greets each ruling in the case by Mayor Elbert. On the other hand, denunciation of the methods employed calls forth applause.

OHIO RIVER RISING AT RATE OF AN INCH AN HOUR

CINCINNATI, March 27.—Cincinnati is threatened with the flood. At midnight the danger line was passed and a stage of 55.6 feet reached. The river is rising an inch an hour. The Union Central station has been deserted.

At Lawrenceburg, the Baltimore and Ohio railroad tracks were dynamited late last night in order to allow the backwater from the Great Miami river to run out and it is believed saved the town from being swamped. Despite this four persons were reported drowned there.

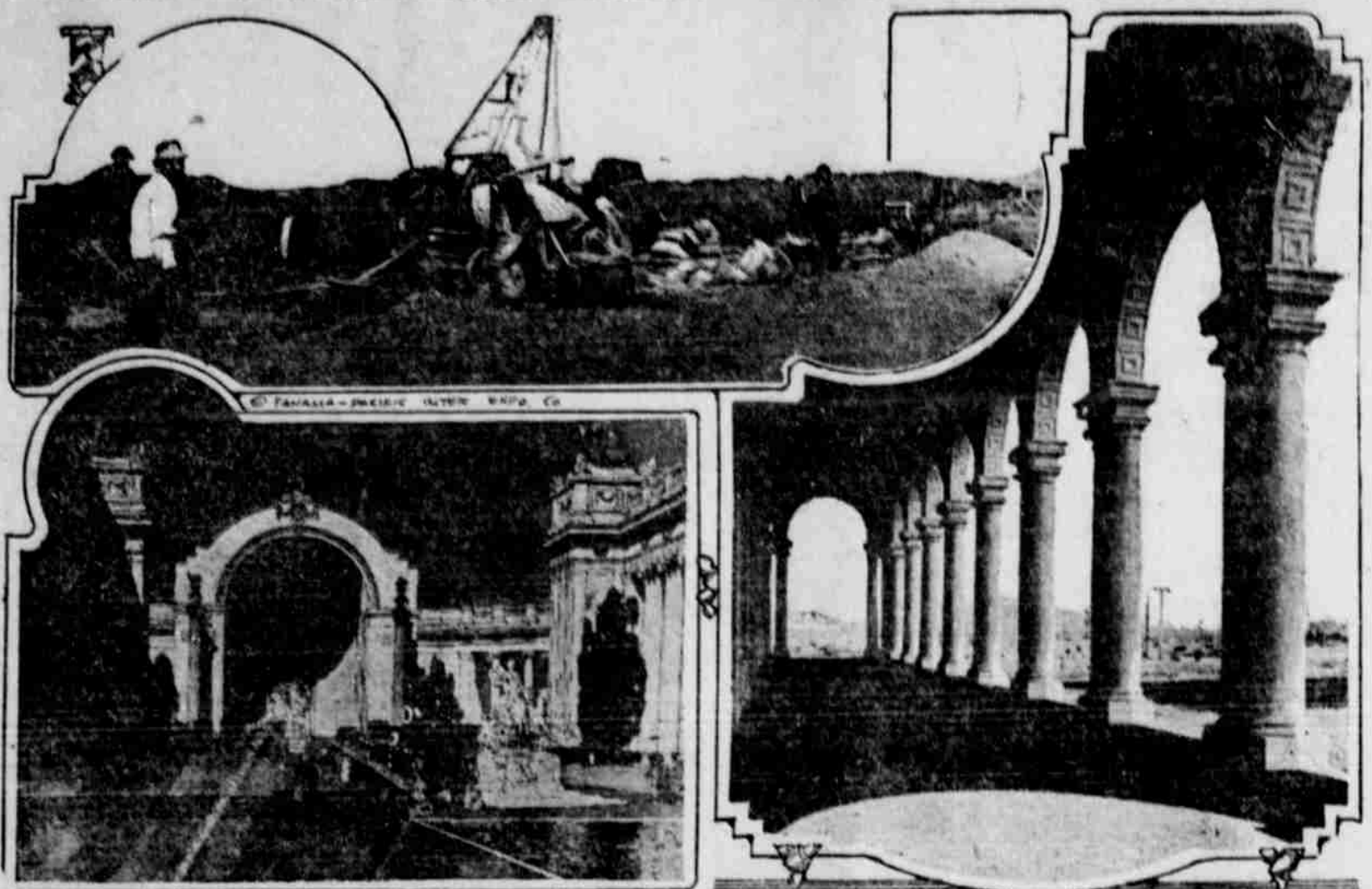

It took much time to prepare card indexes of the sufferers and make requisitions on the central relief station for supplies. While these formalities were being carried through want stalked through the desolate homes from one corner of the city to the other.

PANAMA-PACIFIC EXPOSITION IN THE MAKING; ARMY OF WORKMEN CHANGING VAST GROUNDS INSIDE GOLDEN GATE AT 'FRISCO INTO MAGIC EXPOSITION CITY

The world is watching the Panama-Pacific Exposition in the making. An army of men is busy on the site, extending almost three miles along the shores of San Francisco bay. The preliminary work is finished. All fourteen of the main exhibit palaces will be under construction by the coming summer. All will be completed by June 1914.

W. D. A. Ryan, who has charge of the illumination of the Panama canal, is working out a marvelous night lighting plan in harmony with the glorious color scheme created by Julius Guerin. There will be no glare and no dark places or shadows by night.

Eighty conventions already have voted to meet in 1915 in the \$1,000,000 auditorium to be built at the new civic center. The Welsh National Eisteddfod is offering \$25,000 in prizes for its chorus competition. Twenty-seven nations already have accepted invitations to take part in the exposition. This hosts all records and signifies the great interest with which America's work at Panama is regarded.

To care for motor exhibits a huge Motor Palace, covering five acres, will be constructed. It is said that no single industry will have ever presented an exhibit so vast in extent. The Machinery Hall, which is to be the largest single building on the grounds, will be 267 feet in width and 576 feet long. All exhibits of machinery are to be shown in motion.

Beneath a huge tower, the visitor will enter the exposition city through an arcade, 125 feet in height, to the most splendid of the effects of the exposition, the Court of the Sun and Stars, which will stand out among the most brilliant creations of the great expositions of America and Europe. Some of the towers and minarets will rise 155 feet, 153 and 276 feet. Concessions will occupy 65 acres. The Santa Fe railway is spending \$250,000 on a re-entrance of the Grand Canyon of the Arizona. A model of the Panama canal will cost \$250,000. Japan is to spend a million and a half on her display. France has requested twelve acres.

500,000 RIFLES LOST BY TURKS TO BALKAN ALLIES

BERLIN, March 27.—According to the Frankfort Gazette, the Turks have so far lost five hundred thousand rifles and seven hundred cannon to the Balkan allies.

SOFIA, March 27.—Declaring that the Balkan war was still in a stage that did not make it advisable to give leaves of absence, the minister of war, replying to a question in parliament, regretted that none of the reserves could yet be sent home to commence their farm work.

ST. PETERSBURG, March 27.—The Russian ministry of war is reported to have ordered seven hundred more field guns. This, it is estimated, will give the Russian army approximately 15,000 cannon of all kinds.

DYNAMITE IN POCKET EXPLODES; MAN NEAR DEATH

Chris Swanson, who with his brother owns and cultivates a tract of 700 acres of land adjoining the 401 Ranch, lies at his home today at the verge of death, following the explosion of a half stick of dynamite in the breast pocket of his coat this morning. His entire left side was driven in, his lungs and other internal organs being injured. He was treated by Dr. E. R. Seeley, who reports that Swanson's injuries are very nearly fatal.

Swanson left the house early today to dynamite squirrels. He was alone when the explosion occurred and was only able to state that the dynamite exploded in the pocket of his coat. Whether he ignited a dynamite cap accidentally or whether he jolted the explosive with enough force to set it off will never be known unless he recovers.

Charles Stanley heard the explosion and saw Swanson fall. He rushed to his aid and carried the wounded man home.

Swanson's entire left side is raw and bleeding, while his lungs were seriously injured.
