

MEMORIAL TO MR. AND MRS. ISIDOR STRAUS, VICTIMS OF TITANIC DISASTER, TO BE BUILT AFTER THE MODEL OF MR. LUKEMAN



MEMORIAL TO MR. AND MRS. ISIDOR STRAUS, BY MR. AUGUSTUS LUKEMAN

To Mr. Augustus Lukeman, one of New York's leading sculptors, was awarded the first prize in the competidon for designing a fountain to be erected in Straus Park, New York city, in memory of Mr. and Mrs. Islder Straus, who died together in the wreck of the Titanic.

Four other prizes were awarded in the same competition. They ranged in value from \$500 to \$1,000. In all, fifty-nine designs were submitted. The total cost of these approximates the cost of the completed memorial, which will be \$20,000. The architect named in the award with Mr. Lukeman is Mr. Evarts Tracy, also of

In reaching their decision the committee eliminated the idea of attempting to memoralize the qualities of the man and woman for whom the fountain is to be erected, but accepted the suggestion which Mr. Lukeman has endeavored to embody in the small park—a scheme of penceful contemplation over a sheet of water, leaving it to the public to think over the sacrifice that the same element demanded in the disaster in which Mr. and Mrs. Straus

The fountain will be of granite and bronse, an expansive granite base being surmounted by the graceful brunze figure of a woman reclining. A bronze plate will bear this inscription:—
"To isider and ida Straus, whose lives were unselfishly devoted to the betterment of the State and whose death was a monument to that great bulwark of the State, the family. This memorial erected in the year nineteen bundred and thirteen."
