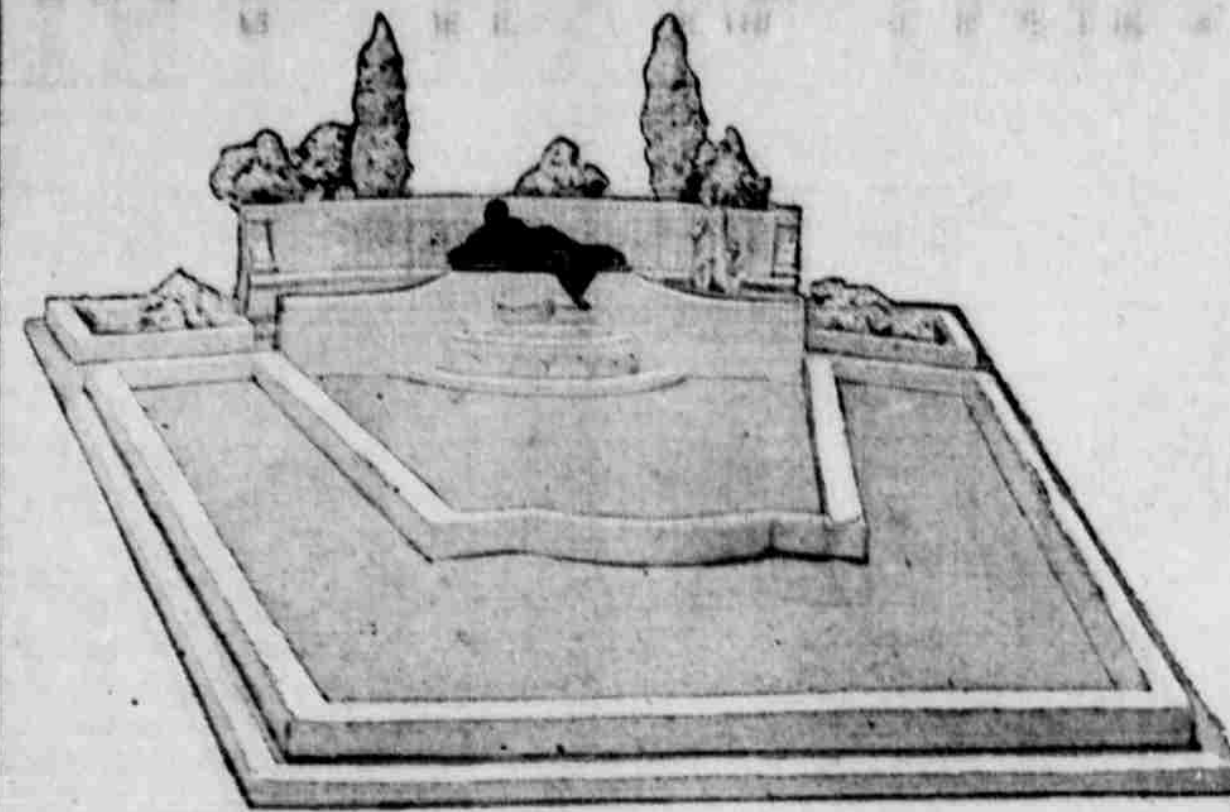

MEMORIAL TO MR. AND MRS. ISIDOR STRAUS, VICTIMS OF TITANIC DISASTER, TO BE BUILT AFTER THE MODEL OF MR. LUKEMAN



MEMORIAL TO MR. AND MRS. ISIDOR STRAUS, BY MR. AUGUSTUS LUKEMAN

To Mr. Augustus Lukeman, one of New York's leading sculptors, was awarded the first prize in the competition for designing a fountain to be erected in Straus Park, New York city, in memory of Mr. and Mrs. Isidor Straus, who died together in the wreck of the Titanic.

Four other prizes were awarded in the same competition. They ranged in value from \$500 to \$1,000. In all, fifty-nine designs were submitted. The total cost of these approximates the cost of the completed memorial, which will be \$20,000. The architect named in the award with Mr. Lukeman is Mr. Evaris Tracy, also of New York.

In reaching their decision the committee eliminated the idea of attempting to memorialize the qualities of the man and woman for whom the fountain is to be erected, but accepted the suggestion which Mr. Lukeman has endeavored to embody in the small park—a scheme of peaceful contemplation over a sheet of water, leaving it to the public to think over the sacrifice that the same element demanded in the disaster in which Mr. and Mrs. Straus perished.

The fountain will be of granite and bronze, an expansive granite base being surmounted by the graceful bronze figure of a woman reclining. A bronze plate will bear this inscription:—"To Isidor and Ida Straus, whose lives were unselfishly devoted to the betterment of the State and whose death was a monument to that great bulwark of the State, the family. This memorial erected in the year nineteen hundred and thirteen."

JAPAN OFFERS EGGS TO U. S. AT 9 CENTS DOZ.

SEATTLE, Wash., April 1.—Japan has entered the egg market of this country with a proposition to furnish its steamship lines with eggs at 9 cents a dozen the year round. With prices in the country ranging from 18 to 50 cents a dozen in the course of a year, it will be impossible for local dealers to compete with the Japs. Alfred Watson, purchasing agent for the company, has received a small consignment of the Japanese eggs sent to him as samples.

ASK RELEASE OF WM. D. HAYWOOD

PATERSON, N. J., April 1.—Attorney Henry Marellie went to Hoboken today to apply for a writ of habeas corpus for William D. Haywood, organizer for the Industrial Workers of the World, who has been sentenced to six months in the county jail here today following his conviction of causing unlawful assemblages. Haywood came here in connection with the millworkers' strike. Marellie will file his application before Justice Minturn, of the state supreme court.

RUSSIAN POLICE CHARGE CROWD INJURING MANY

ST. PETERSBERG, April 1.—Many persons are perhaps fatally hurt here today following a charge by a great body of police on an anti-Austrian demonstration in front of the Servian legation. The action of the police in ruthlessly striking a number of those in the crowd with their whips is to be investigated. FORMER MEDFORD MAN KILLED IN AUTO ACCIDENT

As a result of an automobile accident at Marshfield, Fred Reed, formerly of Medford, is under \$1000 bonds and Louis Ballinger, formerly of this city, killed. Reed was driving a car which struck two men, killing one and seriously injuring the other. Reed went from Medford to Marshfield to work for King & Vorst, former owners of the Jacksonville stage. At one time he was chauffeur for the Taxi company here. Reed has been formally charged with involuntary manslaughter. The victim of the accident was Louis K. Ballinger, who was a resident of Medford a few years ago. He was a brother-in-law of Robert Sears who established the first picture house in Medford.

PARIS, April 1.—That the walls surrounding Adrianople were of brick construction and not "impenetrable concrete fortresses," as was generally believed, is the information sent here today by the Adrianople correspondent of the Paris Journal.
