

BUD LEAVES TODAY FOR LOS ANGELES TO TRAIN FOR FIGHT

Bud Anderson the "Medford Typhoon" and next lightweight champion of the world will leave this afternoon for Los Angeles where he will begin training for his 20-round contest with Joe Mandot, May 20. Bud leaves with the best wishes of hundreds of friends here. He plans to return to Medford after his fight with Mandot and spend three or four weeks in the nearby hills.

Bud spent Wednesday at Grants Pass with friends. Today he was bidding his friends farewell and promising them that he will do his best when he hooks up with Mandot.

Bud is in fine condition now to undertake active work. He weighs about 140, is eager and strong. He has effectively dispelled all doubts which his Medford friends may have had regarding his ability to make weight.

"I am sorry to leave Medford," stated Bud today, "but I have a little business on hand at Los Angeles. I'll be back soon."

WOLGAST WANTS TO FIGHT RITCHIE

SAN FRANCISCO, Cal., May 8.—Ad Wolgast refuses to admit that he is dead. Declaring that he is still good enough, pugilistically, to give Willie Ritchie a hot argument, Wolgast is out here today with a deft to his conqueror.

"I can beat Ritchie," says the one-time monarch of the lightweight, "and if he is going to fight July 1 I want the match."

Wolgast admits that Tommy Murphy beat him in their last battle here but declares he was blinded by his own blood, that otherwise he would have knocked Murphy out.

So far Battling Nelson has made no move to get the match with Ritchie which might give him his chance to "come back."

PORTLAND CONFERENCE ON HUMAN LIFE

PORTLAND, Ore., May 8.—Complete preparation has been made for the conference on "Human Life, Its Wastes and Conservation," at Reed college, Portland, May 9-10-11. Delegates have been named by a great many cities and organizations throughout the Pacific northwest. The gathering promises to be one of great interest as well as much practical value. Reduced rates are offered on all railroads and Reed college, which has an ideal location with beautiful surroundings, has made special plans for the entertainment of the delegates and visitors.

Many speakers of national reputation have been secured for the conference, one of these being Dr. E. I. Cubberley, head of the department of education at Stanford university. He is a graduate of Indiana and Columbia universities and is the author of well known books on educational topics.

MANDOT BEGINS ACTIVE TRAINING

LOS ANGELES, Cal., May 8.—His general condition apparently much better than on his previous appearances here, Joe Mandot of New Orleans began active training today for his scheduled twenty round match at Vernon with Bud Anderson May 20. Mandot did two miles on the road and worked out with his two sparring partners.

For more than a week the little Frenchman has been doing light work at his Venice quarters determined to become thoroughly acclimated before the day of the battle. He declares he is stronger and faster than when he lost to Rivers here upon his last appearance.

Dick Donald, Anderson's manager, is expected late this week to arrange for the coming of his boy. Bud probably will train at Doyle's camp.

JEFFRIES REFUSES TO TRAIN GUNBOAT SMITH

LOS ANGELES, Cal., May 8.—"Sorry, but I do not see how I can accept," was the granted comment of Jim Jeffries today upon a telegram offering him a job as sparring partner to Gunboat Smith, who is scheduled to meet Jess Willard in San Francisco this month. Jeff is not quite sure who sent the message, but the Gunboat's name was appended to the offer.

"I'm a good sparring partner, at that," Jeffries said, "but there's not a chance in a million. The man who framed that message was a good press agent, so I'm willing to be the goat."

Jeffries and a party of Los Angeles fans probably will be at the ringside at the Smith-Willard bout.

DISCRIMINATE FOR FARMERS AND LABOR

WASHINGTON, May 8.—By a vote of 41 to 32 the senate refused last night to accept the amendment to the sundry civil bills by Gallinger striking out the clause exempting the labor and farmers organizations from prosecution under the anti-trust law with funds appropriated by the bill.

Three republicans, Jones, LaFollette and Norris voted with the democrats against the Gallinger amendment and two democrats, Pomerene and Thomas, joined the republicans in supporting it.

MRS. JOHN KAMB RECEIVES MYSTERIOUS FORTUNE

JESS WILLARD, 6 FEET 6 INCHES, AND GUNBOAT SMITH, WHO KNOCKS THEM OUT WITH A PUNCH, FIGHT NEXT

When Jess Willard and Gunboat Smith get into the ring in Jim Coffroth's club, San Francisco, May 17, the result will come pretty near determining who is the best white heavyweight, despite the fact that Luther McCarty carries about a belt to "the champion white heavyweight."

Willard is a giant. Smith has a giant's punch. Willard's measurements show him to be larger than Jim Jeffries was at the same age—25. Here they are:

Height—6 feet 6 inches. Weight—225 pounds. Reach—81 inches. Chest—46 inches, normal. Chest—49½ inches, expanded. Waist—36 inches. Neck—18 inches. Thigh—26 inches. Biceps—15¾ inches. Wrist—9½ inches. Calf—17½ inches.

Smith is about 6 feet 1 inch, and does not weigh more than 185 pounds in fighting condition. However, when he swings his right and it lands they go down. He has all the courage in the world. Like the champions of the past he loves to fight, and that is half any battle. McCarty refused, even when offered \$10,000 to meet him. Nor has it been possible to get the so-called white champion into the ring with Willard since Willard beat him in New York several months ago.

"Say, I would fight wildcats for \$10,000," said Smith. "Once I stood on the streets of New York and asked passersby to give me a nickel so I could get over to Brooklyn."

McCarty proved himself in his recent bouts with Jim Flynn in Philadelphia, and Frank Moran in New York, to be cleverer than either Smith or Willard—also that he did not have a knockout punch concealed in either arm.

OREGON BOY STILL HOLDS POTATO RECORD

SALEM, Ore., May 8.—Evidently potato growers in England have not heard of Oregon, else they would not lay claim to the world's record in the matter of production.

Information has come to State School Superintendent L. R. Alderman that in a potato contest held in England one pound of potatoes was given to each contestant and that the record production was 220 pounds.

In a potato contest held by the school children in this state last year one potato was given to each contestant, and Eugene Dumond of Albany produced over 660 pounds. This amount was exhibited at the state fair, and in addition young Dumond left at home three boxes full of potatoes too small to exhibit, all of which were grown from one potato. He made his remarkable record by first planting each eye of the seed potato in a hotbed, and then carefully transplanting each shoot.

COUNTY TO MOVE DESERT CRUSHER

The county court Wednesday afternoon acted upon the request of a dozen Eagle Point business men that a rock crusher at present installed on the desert be moved to a point on Little Butte creek about two miles above Eagle Point. The court made an order for the removal.

With the erection of the crusher at the new site a great abundance of rock of excellent quality will be available for road purposes. Eagle Point plans to expend \$10,000 in improving its streets and as they will also do some work upon county roads the removal of the plant was ordered. Chris Natwick will do the work.

WASHINGTON, D. C., May 8.—A unique contest was today inaugurated by the Southern Commercial congress, which offers 15 free trips to the Panama canal for the best suggestions for a memorial to commemorate the opening of the canal. The announcement was made today by Senator Duncan U. Fletcher, of Florida, president of the congress.

The congress believes completion of the canal should be marked by some suitable memorial, and the contest will arouse interest in the study of the trade relations of the canal to the United States, Latin America and the world.

The memorial can take any form, a statue, an international celebration, a book, a convention—anything that the jury of award decides is the best suggestion to commemorate the completion of the canal.

Secretary of State Bryan and John Barrett, director general of the Pan-American Union, with others to be selected by themselves, will constitute the jury of award. They will decide the 15 best suggestions.

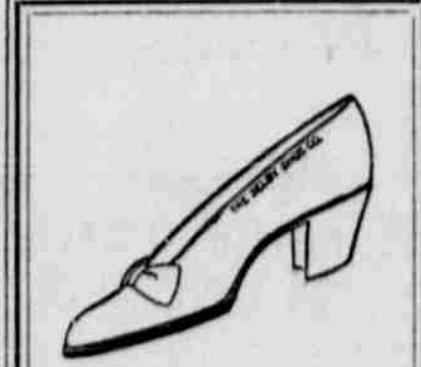
