ASK WOMEN TO AID PEACE PLANS

THE HAGUE, HOLLAND, May 20.—An eloquent plea for help from American women to aid women of Germany, Austria, and other European nations in campaigns in the interest of universal peace was made today by Countess Isabelle Aberdeen, wife of the Lord Lieutenant of Ireland, and president of the World's Council of Women, when she opened the annual convention of that organization here. The convention will continue through Tuesday. Scores of women prominent in movements toward universal peace and international arbitration in Europe and America attended today's sessions. The big topic today was the program to be arranged for the great quinquennial meeting in Rome in 1914. Mrs. Andrea Hofer-Proudfoot of Chicago, member of the International Amity League, and a co-worker with Frau Hainisch, in Vienna, for the past few months, also pleaded for a more hearty response by American women. "We are sadly handicapped in our work," declared Mrs. Hofer-Proudfoot, "for it is difficult to arouse interest in European countries in our work. We need the activities and experience of the western continents to stimulate enthusiasm in the work over here. At present, the women of the states do not play the part that should in this great international question."

OBITUARY.

Rev. William Lucas
Rev. William Lucas, former pastor of the Episcopal church of this city, died Sunday, May 18, at the Ashland hospital, from the effects of an operation. He was the rector of the Trinity Episcopal church of Ashland at the time of his death. He is well known in this city, and often came here to officiate at weddings. He was in Medford last month for the Mathison-McCormack wedding. He was 64 years of age, and leaves a wife and many friends in this section to mourn his death. He was well-loved and highly respected throughout the state. The funeral will be held Thursday at Ashland. His body will be taken to his old home in Michigan for burial.

TO PLACER ALONG BANKS OF ROGUE

Development of a 140 acre placer mining tract, comprising most of the great bar just below the Dowden falls upon the north bank of Rogue river, and three miles distant from this city is assured by the plans of mining men who have for some months past been chiefly engaged in an exhaustive examination of the property, says the Gold Hill News.

Following tests and prospects which determined the richness of the bar beyond question, the properties of George Lyman, and J. K. Moore, constituting the greater portion of the tract to be mined, have been bonded for a large sum by the recently organized company, and will shortly be the scene of extensive mining operations.

Neither local capital nor local mining men are directly interested in the project, the company being composed of Charles F. Luce, a wealthy mining operator of Tacoma, Washington, A. E. Bamber, and others, of Sutherlin, Oregon.

GIBSON AGAIN TRIED FOR STRANGLING ROSALIE SZABO

NEWBURGH, N. Y., May 20.—Confident of a speedy trial and acquittal, Burton W. Gibson, prominent New York lawyer, today, for the second time within a year, faced the bar of justice charged with murder. Gibson, his faithful wife at his side, stood without flinching as the clerk read the indictment alleging he strangled to death Mrs. Rosalie Menschik Szabo, a former client. A former trial on the same charge resulted in a hung jury. Throughout the trial and during the days before Gibson was indicted when a sensational series of events were unearthed regarding the deaths of several of his former clients, Mrs. Gibson has steadfastly remained at his side protesting absolute belief in his innocence and branding as false the stories and rumors told about her husband.

In the indictment against Gibson he is charged with strangling Mrs. Szabo to death while the two were boating on Greenwood Lake, Orange county, on the afternoon of June 10, 1912. Gibson's defense, his attorneys declared today, will be similar to the defense put forth in the first trial. The accused lawyer declares Mrs. Szabo upset the boat and fell into the water when she attempted to change her seat. The prosecuting attorney said today he will again put on the stand witnesses who will swear that they saw the couple struggling in the boat, that Gibson's fingers were about the woman's throat and that their struggles overturned the small craft.

RAILROAD CONTRACTORS GO OVER REDDY'S ROAD

GRANTS PASS, May 20.—W. D. O'Brien of San Francisco, Ed Barnett of Los Angeles, and E. Phelan of Omaha, Neb., arrived Sunday to make further investigations concerning the proposed Grants Pass-Crescent City railroad, as representatives of the syndicate that is considering the financing of the road. They represent three branches of inquiry, Mr. O'Brien being a mining engineer, Mr. Barnett a civil engineer, and Mr. Phelan a railroad contractor. In company with Dr. Reddy they left by auto Monday to go over the line and to visit the mines and the timber bodies along the route.
