ARCHITECTS PLAN PRECOOLING PLANT PROPOSED HERE

Precooling plant architects are here today discussing plans of the proposed cold storage plant with officials of the Rogues River Fruit and Produce Association.

The only difficulty in the way is the successful financing of the project. Nearly \$10,000 has been pledged, about half the amount it is desired to raise. Bonds on the plan will provide the remainder of the money needed after the first \$20,000 is subscribed in 8 per cent preferred stock.

The subject is one of vital interest to the valley and subscriptions in amounts from \$100 up are urged from every fruitgrower.
