## PELKEY AROUSES INTEREST AMONG BAY CITY SPORTS

SAN FRANCISCO, Cal., July 17.—Not since the days of Peter Jackson, Jim Corbett, Bob Fitzsimmons and Jim Jeffries has San Francisco taken such an interest in the heavyweights of pugdom as is manifested here today. All sorts of matches are discussed with Arthur Pelkey and Gunboat Smith, the most likely candidates for a collision in the beef trust class.

Pelkey, who lays claim to the heavyweight title by virtue of his win over Luther McCarty at Calgary last Empire day, already is on the ground, having arrived today from Portland with his manager, former Heavyweight Champion Tommy Burns. Sam Langford, after a long campaign in Australia, is due tonight on the steamer Sonoma, and is expected to cast a dark cloud over the situation. Jess Willard of Kansas and Charley Miller are also clamoring for action.

When he arrives tonight, Langford will be offered a four-round bout with Miller by Louis Parente, the latter's manager and matchmaker for the National club's show August 21. Parente also declares he has posted \$2500 to go as a side bet for a match with Pelkey. Miller is willing to box on a winner-take-all basis, but it is probable that Pelkey will demand a guaranteed purse.

If Pelkey refuses to meet Miller, Promoter Coffroth, who holds the September permit, probably will match Pelkey and Gunboat Smith. Smith, who is in New York, has authorized Coffroth to make the match. In any event, it is probably that the heavyweight supremacy will be decided on the coast within the next few months. With this object in view, Coffroth is planning an elimination contest to decide who is entitled to the laurels laid down by McCarty.

## CANADIAN APPLE CROP UNFAVORABLE

Reliable reports from all sections of the district indicate unfavorable prospects for an apple crop this season. In certain sections there will be no fruit, as orchards have been completely devastated by the tent caterpillar. The damage has been enormous, but definite figures cannot be given. It is estimated, however, that the total loss to the fruit growers of this section will amount to several hundred thousand dollars.

The whole of eastern Canada has been visited by this caterpillar plague, and not only have orchards and gardens been seriously damaged, but whole wooded areas of the countryside have been devastated. The tent caterpillar is not a stranger to this section, but never before, it is said, have its ravages assumed such large proportions. In several instances recently they have been so numerous in their migrations across railways as to cover the rails for miles, causing delay to traffic.

## MILLIONAIRE HORNBY ALIVE IN EUROPE

SAN BERNARDINO, Cal., July 17.

That Alouzo Hornby, millionaire, supposedly deceased, "coffee king" and manufacturer of breakfast foods, who disappeared from Redlands in 1900, is alive in Europe, is indicated here today by the filing of an affidavit in which he seeks to collect \$30,000 on a note signed by W. G. Cown and others.

The paper was filed by G. Allen, an attorney. Hornby disappeared at the same time Mrs. Mabel Watson dropped from sight here. Mrs. Murray brought suit against Mrs. Watson, charging alienation of her husband's affections and secured an order restraining the couple from sailing for Europe. Later the suit was dropped.

The Hornbys are known socially in many Pacific coast cities.

## 480,000 ROUNDS CARTRIDGES SEIZED ON MEXICAN BORDER

EL PASO, July 17.—American officers aided by Mexican consular agents captured the largest consignment of contraband ammunition ever taken here, when they discovered four Mexicans covering cases containing four hundred and forty-eight thousand rounds of rifle cartridges with coal in a car in the Santa Fe railroad yards. The American believed to be the leader of the smuggling party escaped but is being hunted.

## ROBINSON HELD ON NEW CHARGE

PORTLAND, Ore., July 17.—

Charged under the laws of the United States with conspiracy to commit a crime, W. W. Robinson and E. K. Oppenheimer, members of the bankrupt firm of W. W. Robinson, clothiers, were arrested today by Deputy United States Marshals Fuller and Pecker. The specific charge is that they made an effort to conceal from the referee in bankruptcy certain assets of the corporation.

United States Commissioner Cannon released Oppenheimer under \$3000 cash bond. Robinson's bond was fixed at \$10,000.

When the case was first called to the attention of the federal authorities the alleged withholding of \$18,000 of the firm's funds appeared to be merely a case of embezzlement under the Oregon state law, and it was turned over to District Attorney Evans of Multnomah county. Officers arrested Robinson in Bellingham last Saturday night, it being alleged that he was on his way to Canada. He was returned to Portland. The federal charge is the outgrowth of a meeting of creditors before Referee Chester Murphy.

The ammunition is believed to have been a shipment for General Villa destined to a border point near Columbus, New Mexico.

## SENATOR WORKS OPPOSES USE OF HETCH-HETCHY

WASHINGTON, July 17.—Representatives of San Francisco who are here fighting for a permit to use the waters of the Hetch Hetchy valley in Yosemite National park for a municipal supply, were astonished this afternoon to learn that Senator Works of California is determined to oppose any action on the Hetch Hetchy bill at this session of congress.

Works proposes another investigation of the whole controversy, based on the claim of San Joaquin irrigation interests, who have been opposing the San Francisco permit on the ground that other sources of a water supply for the city may be had.

If these claims are upheld, Senator Works says, he will offer an amendment at the next session of congress striking out all the conditions to the grant, and giving authority over the control of the waters on the Hetch Hetchy watershed exclusively to the state of California.

## MRS. B. P. THEISS IS SERIOUSLY ILL

Mrs. B. P. Theiss, one of the leading club women of the city and one of the founders of the public library, is seriously ill at the Sacred Heart hospital, where she was taken after sudden seizure Wednesday evening at her home on North Central. Mrs. Theiss has been in poor health for the past year, having recently returned from California, where she spent the winter hoping that a change of climate would benefit her. Physicians hold out little hope for her recovery.

## JOE HERRICK VICTOR OVER JACK CARROLL

JAUREZ, Mexico, July 17.—Joe Herrick of Chicago knocked out Jack Carroll in sixteen rounds here today. Next Sunday afternoon Jeff Clark of Joplin, Mo., will box Rufus Cameron twenty rounds here.

On the Sunday following Frank Gagg of Los Angeles will box Young Thorpe of Kansas City for the lightweight championship of the south.
