

## Delinquent Tax List

This advertised list of delinquent taxes for the year 1912 for Jackson county, state of Oregon. In pursuance of an act of the State Legislature which is embodied in Chapter 261 of the

### GENERAL LAWS OF THE 1911 SESSION OF THE LEGISLATIVE ASSEMBLY.

The taxes on the following advertised real property became delinquent on April 1st, 1913, and are subject to a penalty of ten per cent on the amount at the rate of one-half cent a month until they shall have been paid.

Any day after the expiration of six months after the taxes charged against the following real property become due, unless the sheriff is authorized, under demand of any person making application, to issue to them a certificate of delinquency upon payment of the taxes, penalty, interest and costs of advertising.

Certificates of delinquency shall bear interest at the rate of ten per cent per annum from the date of issuance until the certificate is redeemed.
