Jacobs made good the loss to the government, but put in a claim for the return of the \$200,000. Julius Jacobs left the claim to his son, Lester, who in turn leaves it to his heirs.

WASHINGTON, Oct. 2.—The desire of certain senators to debate the Hetch Hetchy bill prevented its consideration by the senate today as had been requested by Key Pittman of Nevada. It will be called up after the senate has disposed of the tariff bill.

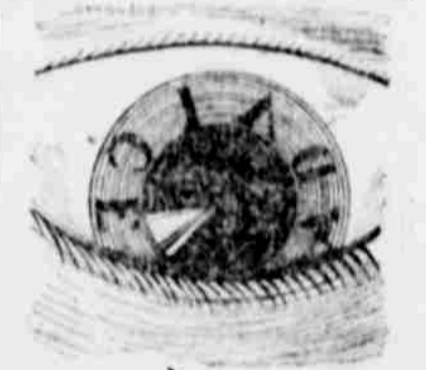
