COST OF HIGH LIVING PROBE BUREAU GIVEN MORE MONEY

WASHINGTON, Oct. 16.—President Wilson has written a letter to Secretary of Commerce Redfield approving the latter's plan for the reorganization of the bureau of foreign and domestic commerce with an annual appropriation for expenses increased from \$225,000 to \$750,000.

It was this bureau which Redfield, in a recent speech, said had the broad powers of inquiry into the cost of production, wages and general factory conditions of American industry and which Majority Leader Underwood referred to as "the tariff board" of the democratic party that would investigate the threats of reductions in wages after the tariff went into operation.

DEPOSED BOSS FLAYS MONEY BILL AS "BRYAN PRODUCT"

NEW YORK, Oct. 16.—Former Senator Aldrich of Rhode Island last night attacked the Wilson administration currency bill, now before congress, which he declared embodied the theories of Secretary Bryan. He denounced the bill as unsound, socialistic and revolutionary, characterizing it as an "endeavor to secure by partisan legislation the triumph of doctrines and principles which received repeated condemnation of the American people at the polls."

BOOSTERS' RALLY UNITES ALL CITIES IN ORGANIZATION

The Rogue River Valley Boosters' rally, held in the Natatorium yesterday afternoon, decided to ask the state for an appropriation for the maintenance of a state exhibit at Ashland, and to meet again in Grants Pass, November 6, and perfect plans for a permanent organization. The spirit of the meeting manifested the strongest traits of progressiveness, community unity and fixity of purpose shown in some time.

Judge Colvig was named chairman, and by-laws will be framed embracing purposes of the organization and electing a permanent set of officers and directors. A committee of fifteen, including leading citizens of the principal valley towns, was named to perfect future plans. The committee is composed of W. M. Colvig, chairman; J. A. Perry, Medford; Ben Sheldon, Medford; Bert Greer, Ashland; C. B. Watson, Ashland; W. A. Reeder, Ashland; Marshall Hooper, Grants Pass; R. E. Kroh, Grants Pass; C. L. Hobart, Grants Pass; William Coleman, Phoenix; A. S. Ames, Talent; Joe Beeman, Gold Hill; E. R. Rosser, Rogue River; Wm. von der Hellen, Eagle Point; Geo. Mims, Tolo.

A sharp debate was precipitated by Judge C. B. Watson of Ashland, who offered a resolution for permanent organization with a secretary at Ashland. This motion was staunchly supported by Bert R. Greer of Ashland, but opposed by Tom Richardson, who thought the time not ripe for permanent organization until another meeting had been held. Addison Bennett of the Portland Oregonian, Amos Stone and G. P. Mims of Central Point, Ed Staples of Ashland and others participated in the discussion, but it was finally decided to leave the question to the committee named by the chairman.

Get together and booster speeches were made by Tom Richardson, Judge Colvig, Mrs. E. E. Gore and others.

The strongest feature of the meeting was the interest shown, and Grants Pass and Ashland showed a willingness to co-operate to the limit with Medford. Speeches were made in which warnings were issued not to let the opening enthusiasm die out. It is planned to have a rally in the different towns every month for a general discussion and love feast of the various interests.

SOLDIER FOUND GUILTY (Continued from page 1.)

ALBANY, N. Y., Oct. 16.—That the Sulzer impeachment court had considered and disposed of all the impeachment articles and that only the final vote remained to be taken was stated unofficially after adjournment at the close of the forenoon's executive session today. Because most of the court's members wish, however, to repeat their arguments in the executive session, that they may go into the official records, it was said the vote probably will not be reached until very late today or possibly not before tomorrow.

Two-Thirds Against Sulzer

It was understood that, when recess was ordered, more than two-thirds of the members of the court were against Sulzer on at least three of the charges against him. Unofficial rumor had it that the governor could command only fourteen votes on the question of his removal. One of these was said to be a justice of the court of appeals. It was understood that the governor would easily, however, on the question of barring him from office in future.

Sulzer's removal from the governorship of New York state is a mathematical certainty. The prosecution has two-thirds of the votes. The test case yesterday when a ballot was taken of a controversy concerning the first charge in the articles of impeachment, in which the governor was accused of filing a false statement of his campaign expenses. On this ballot thirty-nine votes were cast against Sulzer, one more than enough to convict.

MONEY FAVORS TO WESTERN STATES

WASHINGTON, Oct. 16.—Changes in the administration currency bill giving lower interest rates to people of the newer states of the west were advocated today in the senate banking committee.

Senators Hitchcock, democrat, and Weeks, republican, insisted that all sections should enjoy the same rates of discount under the federal reserve bank plan.

They contended that such a system undoubtedly would bring down the interest rates in the west where money is now earning big rates. The bill as passed by the house permits the federal reserves board to tax different rates in different reserve districts.

AMERICAN BALLOON WINS BENNETT CUP

PARIS, Oct. 16.—The balloon Godyear, the American entry, today was declared winner of the international race for the James Gordon Bennett cup. The Frankfort, German entry, landed today near Port Orme, France. All of the entrants have now been accounted for.

The Godyear was piloted by Ralph Upton. It landed at Bridlington at noon yesterday, having crossed the English channel early in the day. The distance between Paris and Bridlington in a straight line is more than four hundred miles. Upton claims to have covered 550 miles in forty-two hours.

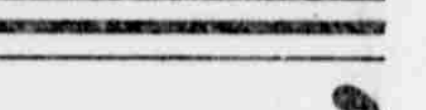
