RUSSIANIZE AMERICA INTENT SAYS HITCHCOCK

WASHINGTON, Feb. 5.—"This bill attempts to Russianize America and would establish a censorship over the press by the postmaster general. The American newspapers will not tolerate it."

This was the comment of Senator Hitchcock to his fellow members of the banking currency committee today at the opening hearing on the stock exchange regulation bill offered by Chairman Owen.

The bill provides for a denial of the mails to stock exchanges which violate the restrictions imposed by the measure and would require the incorporation of stock exchanges under state laws.

Hitchcock said the measure was an attempt to take from the state powers and duties which were purely domestic and in no sense federal.

\$6,000,000 LOSS TO BELL PHONE IF DECISION HOLDS

SAN FRANCISCO, Cal., Feb. 5.—Six million dollars which it collects annually from its twenty subsidiary companies scattered throughout the United States, it was estimated here today, will be lost to the American Bell Telephone company if a decision handed down here yesterday by the state railroad commission is followed by other states throughout the country.

Briefly, the commission's decision, which was handed down in the case of the city of San Jose against the Pacific Telephone and Telegraph company, declared that the American Bell company is not justified in diverting to its own coffers 4 1/2 per cent of the gross earnings of the Pacific telephone instruments whose patents are held by the parent company. The commission fixed the rates to be paid at 2 1/2 per cent of its gross earnings, which means a loss of approximately \$500,000 which the American company will sustain in its dealings with the Pacific company alone.

SENATE O. K.'S GOETHALS FOR PANAMA GOVERNOR

WASHINGTON, Feb. 5.—The nomination of Colonel George W. Goethals as governor of the Panama canal was confirmed by the senate. The appointment becomes effective April 1 next with the president's order creating a permanent civil government for the canal zone.

position on them, that the police department would feed them one meal about midnight, give them a warm room and ask them to leave town in the morning. Those not receiving the night meal would receive a breakfast.

Night Meal Discontinued

Later the night meal was practically discontinued, as it was discovered that a small per centage would return to town and solicit something for a breakfast, knowing that housewives would give them a handout because it was handy. The one meal at breakfast expedites the work of cleaning out the town promptly. Those arriving in the day time are an easier problem, as they can be readily seen, and they are asked to arrange their affairs as best they can for the reason that the idea of securing any employment here would be practically impossible. If for any reason it is found necessary in particular cases to permit a man to remain over, it is done. The department has no standpoint policy, but aims to handle the situation in a reasonable way that will take care of the situation as they find it, and do so practically and with as little expense as possible.

The system seems to be satisfactory to the policemen and to the unemployed, and while it is somewhat presumptuous for one individual to attempt to interpret the judgment or opinion of the entire community, it is plain that the taxpayers will not find serious objection to the expense bill.
