NEW EXPRESS RATES IN EFFECT ON APRIL FIRST

SALEM, Or., March 25.—Express rate changes in Oregon will not be complete until April 1, when new local rates will go into effect, taking the place of temporary rates based upon the interstate block system, which have been responsible for a number of minor complaints within the last few days.

New interstate rates recently were put in force, with modifications correcting certain conditions in Oregon. The local rates to follow on April 1 are expected to meet most of the inequalities now existing, and where this is not done the commission will take up any remaining discrepancies that are called to its attention.

One point for shippers to remember is that commodity rates heretofore existing have not been changed in any respect, except where the new class rates are lower than the commodity schedules, in which case the commodity rate is reduced. Commodity rates are those put in as exceptions to the class rates, and are lower. Most farm products move under commodity rates, which, being lower than class rates, remain unchanged. Failure to understand this phase has caused some confusion.

Another point to be kept in mind is that under the new sliding scale there is a decided reduction on packages weighing 40 pounds or less, even in the few instances where there is a small increase in the 100-pound rate. Statistics show that much more than half of the total express business is carried in packages weighing less than 40 pounds. From Portland to Roseburg, for example, there is an increase of 10 cents on 100 pounds, but a decrease of 20 cents on 50 pounds, of 24 cents on 30 pounds, and of 26 cents on 20 pounds. Between Portland and Medford or Ashland there is a decrease of 16 cents on 100 pounds, of 21 cents on 40 pounds and of 30 cents on 30 pounds.

INCREASED RATES ON FRUIT HELD UP

WASHINGTON, March 25.—The interstate commerce commission today suspended until July 24 a proposed advance of about 16 per cent on transportation by express of carload lots of fruit and vegetables from California to Montana and the east.

ABOLISH THE SENATE

A BILL for an amendment to the constitution of the state abolishing the state senate has been filed at Salem and in all probability will be submitted to electors next November. Such a measure should receive the thoughtful consideration of all citizens. It is another step forward, along the lines of efficient reform.

The two-chamber or bi-cameral legislative system had its origin in the reign of kings and barons who pretended to give the people representative government, but always hedged about with a second chamber to control the popular or representative body. It was stone, fixed up to look like bread.

The bi-cameral system was adopted by the men who framed the federal constitution, because those men did not trust the honesty or intelligence of the great mass of the American people. For that reason they provided the senate to serve as an American house of lords.

When John Randolph of Roanoke came to the convention he brought along a draft of a constitution with a provision for the recall of the members of the lower house, but not for the senators. The idea was to call home any wild-eyed member chosen by the electors who might start an agitation against the sacred property rights of the land-grabbers of that period.

Gouverneur Morris of New York voiced the sentiments of landed classes when he vehemently exclaimed in the convention: "In a few years this will be manufacturing country with a vast number of people without property, and if we give the rabble of this country the ballot and the right to choose all officials, the time will come when they will take the property from the owners for their own use."

"How Morris underestimated that most wonderful of all things human, "the patience of the poor."

This observation and many others of like tenor can be found in the journal of the constitutional convention as kept by James Madison. This journal, by agreement, was not published till many years after, for fear of the effect upon the public mind. Its pages show clearly that the majority of that convention were at heart in favor of a monarchy, and but for the fact that the revolutionary soldiers took their rifles home with them, the efforts of Franklin and Jefferson to secure some recognition of popular rights would have been without avail.

The senate was the demand of the aristocracy, Tories and plunderers of the people of that day. The several states copied the system and great has been the use made of the state senates for a hundred years by those who debase government and live by corruption.

With the referendum there is no place for a senate, and there never was, except for the calm consideration and suppression of measures and men that might help to lift the great mass of the people to a high and higher plane, and to that equality before the law, which could and some day will make all men economically and intellectually free.

Vote to abolish the senate. It is the unloosening of another barnacle that has so impeded the good ship of state that she is still far from that haven for which she was destined by the prayers, the hopes of the real heroes of the revolution, the unknown dead, the men who bore the musket.

CREATING A LAWYERS' TRUST

LAWYERS in Massachusetts are evidently determined to create a lawyers' trust by barring from courts all but lawyers and barring from legal practice any but college graduates.

Senate bill 176 now before the Massachusetts legislature would make the probate court, the last remaining people's court, a strictly lawyers' court by providing as follows: "No proceedings shall be held before the respective judges thereof, where the parties to said matter or case are represented in said court by a person other than an attorney in good standing."

Ordinary matters of probate can be attended to now by any person of ordinary intelligence, and much of the business is transacted by notaries. But the proposed law goes further than the above by the following:

"All persons other than attorneys-at-law in good standing, including officers, clerks, and employees of probate courts are hereby prohibited from advising any and all persons interested in any matter or case now pending or hereafter arising in any probate court of this commonwealth; and all said persons other than attorneys-at-law in good standing are likewise prohibited from drawing or giving the directions for drawing any paper for use in any matter or case now pending or hereafter arising therein."

This is a sample of law made by lawyers, and reminds us of the attempt made in the last legislature to abolish the county court—the last of the people's courts in Oregon.

To bar from law practice all but college graduates would have eliminated Lincoln and many another famous jurist.

BURKE LEADS IN DAKOTA PRIMARY

PIERRE, S. D., March 25.—Incomplete reports received today from yesterday's statewide primary election show Congressman Charles H. Burke, candidate of the minority republican faction is leading Senator Crawford in the race for the United States senatorial nomination. Burke received large majorities here, at Sioux Falls, Rapid City and Aberdeen.

FEARS FOR TORREON EXPRESSED AT CAPITAL

MEXICO CITY, March 25.—Deep concern for Torreón's fate was expressed at the war office here today. The garrison was strengthened recently as far as President Huerta could spare the men, but latest reports—the wire was not working today—were not considered reassuring. General Velasco, the Torreón commander, spoke of a new and unfamiliar type of shell the rebels were using with deadly effect. He added that their marksmanship was good and serious havoc was being wrought by their artillery fire.
