

TURK SITUATION CAUSES ADVANCE CHICAGO WHEAT

CHICAGO, Sept. 29.—Wheat advanced sharply today in consequence of the reported closing of the Dardanelles. The market was also bullishly affected by reports in the American spring crop belt falling off to well under the figures at the corresponding time a year ago. Commission houses almost unanimously took to the buying side and found offerings light. The start, which ranged from 1/4 to 1/2 higher, was followed by a slight reaction, but then prices rose higher than before.

Corn hardened a little with wheat. Favorable weather for maturing the new crop, however, tended to prevent any decided advance in quotations. After opening 1/4 off to a like advance, the market secured fractionally.

Assertions that the government of Greece was purchasing oats on a large scale made that cereal firm. Price changes, though, were small. Provisions lacked support. An advance in the hog market was virtually ignored.

DARDENELLES TO BE REOPENED

LONDON, Sept. 29, 8 a. m.—A dispatch from Constantinople to the Reuters' Telegram company says there is good reason to believe that the Dardanelles, ordered closed yesterday, will be reopened to navigation in two or three days.

In reference to the closing of the foreign postoffices, an understanding has been reached between the British, French and Russian embassies, and the ports, according to which the postoffices will close on October 1, but the staffs will be transferred to the respective embassy buildings, where they will continue to receive European mails on October 25, although they will discontinue the dispatch of mail from Constantinople on October 20. The Austrian, German and Italian postoffices will close on October 10.

ARMOUR III. GOES TO HONEST WORK

CHICAGO, Sept. 29.—A very rich young man arose before dawn today and at daylight was trading about the mud of the cattle pens at the stockyards, "learning all about it." The very rich young man is Philip D. Armour III, grandson of the founder of Armour & Co., and following the rule laid down by the late head of the house, if he expects to enter the business at all he must learn it from the ground up. His work today is but a sample of what he must follow for months until he becomes qualified as a buyer. Some day it is planned by his uncle, Ogden Armour, that he shall be president of the company. He is 21 and a graduate of Yale.

FRENCH WARSHIP SINKING FALSE

WASHINGTON, Sept. 29.—Official denying of the sinking of a French warship by the Austrian forts at Cattaro was made today by the French admiralty through the embassy here. The French secretary for the navy has made known that this news is entirely false and there is nothing to justify such a report. "Up to date, (September 28) no French warship has been touched by an Austrian projectile," said the admiralty statement, which attributed the report to the Cologne Gazette.

FIRST YANKEE REGISTER SHIP BURNS AT SEA

NASSAU, Bahama Islands, Sept. 29.—The American steamer Foxton Hall was burned off Watling's island, September 23. The members of the crew, with the exception of two men who are missing, have arrived here.

The Foxton Hall was among the first vessels to take out an American register since the outbreak of hostilities in Europe. She was originally a British steamer, and the change of registration was made at Colon, September 19, on which date the Foxton Hall sailed from the harbor for Perth Amboy, N. J.

NEWS FROM COUNTRY CORRESPONDENTS

ASHLAND AND VICINITY

Returns from the M. E. conference received, indicate that Rev. W. J. Douglass will remain in Ashland, an assignment that gives universal satisfaction. Rev. L. C. Poor, who was here two years ago, goes to Woodburn, from Portland. The new pastor at Talent will be Rev. J. H. Adams, recently located at Ten Mile, in Douglas county.

O. H. Sneed, expert electrician with the Western Union, has resigned and will enter the service of the Southern Pacific, exchanging a traveling assignment with the telegraph company for a stationary appointment at Grants Pass as inspector of electrical apparatus on locomotives.

Trips to view the completed portions of the Pacific highway over the Siskiyou are in order. These jaunts serve a three fold purpose—first to note the progress of the big job, and secondly they cannot fail to flatter the contractor as to interest being taken in the work. Thirdly, now that Crater Lake's barriers are nearly closed, the Siskiyou trip affords a wealth of scenic views at close range. Hardly a day passes but what some local tourists are headed in that direction. Sunday over a score of city people motored over in that direction, making the event a picnic outing.

Herman Mattern, manager of the Taylor Lake mines in the Salmon river district of Siskiyou county, Cal., was in from that locality the last of the week, visiting his home town and attending the Shriner festivities. While here he exhibited in Whitely's jewelry store window a single specimen of rock from the Big Cliff mine valued at \$240, also four specimens of black quartz from the Homestake mine valued collectively at \$1000. All these properties are in the Salmon river district.

Carl Hilby was home recently for a visit. He is at present at the head of the shoe department in the lumber company's big store at Weed, Cal. There are two notable eyeores in this burg. One has become chronic and no longer causes comment except by strangers. The first refers to the old opera house property erected in the prehistoric era of the '70s. It was destroyed by fire over two years ago and the ruins still remain an unsightly spot, located on one of the most important corners of the business section. For months rumors were current of rebuilding. City councils have wrestled with the problem of an enforced removal of the rubbish, but the quiet, the peaceful and undisturbed wreckage still remains in that locality. The second eyeore is the surroundings about the spacious and armory. This, however, is merely in the acute stage, and could be remedied on short notice. At present that fine building is surrounded by a mess of weeds and rubbish disgraceful to behold. It seems a bit of irony to plant a frowning brass howitzer as a challenge to "keep off the grass," when there isn't a blade of real verdure on the entire park row.

Jim Potter, willow banker, and at present real estate agent and editor of Montague, Cal., was in the city Monday on a brief visit with relatives and attending to business matters. Between other duties he finds time to wield the editorial pen on the Messenger of that enterprising town.

During the recent Normal rally, stores were not only closed but craps were found hanging on the door of a prominent business house on Main street. Tradition has it that this was the first aid to the closing movement inaugurated by this particular store in six years. Some way evidently wanted to emphasize it by a hint that the closing was permanent and the regrets correspondingly sorrowful.

The municipal payroll provides an annual salary of \$100 for the mayor; \$75 each per year for the six councilmen. The treasurer gets \$240, the attorney \$600, and the recorder \$1200. The clerks of departments draw a total of \$914.25. The chief of police gets \$1080, and the members of his staff \$1241.70—or these various officials did get these sums in 1913, as the foregoing figures refer to that yearly period. It cost \$24.35 to feed prisoners. The notable improvements on city hall footed up \$4126.84, well worth the money. Sundry expenses footed up \$3385.82, and street lighting is charged up to the tune of \$6949.31. The city bought a motorcycle costing \$260. Expenditures aggregated \$24,691.57. The receipts were \$26,172.73, the largest item of which was \$16,100.03 in taxes. The street car election cost \$30.50, but the city scored a touchdown in the difference between that sum and \$1000, owing to forfeiture of the franchise. Licenses brought in \$563.50, but fines were a low bid, yielding only \$66.80. Jan. 1, 1914, there was a balance of \$2051.15 in the treasury. The foregoing figures are in reference to the
