Fire at Ashland at 9 p. m. Thursday night destroyed the sub-station and transformers of the power company at Ashland.

Friday morning two spare transformers of 300 horsepower capacity each were loaded on motor trucks at Medford and hanled to Ashland, The transformers weighed four tons each and were nine feet high. They were loaded on two trucks and a heavy wagon trailer, one truck belonging to Will Barnum and one to the power company.

It required the combined efforts of the two heavy trucks, four automabiles and two teams of horses to hand this load up the Eagle hill near Ashland.

The transformers were delivered at Ashland, a temporary sub-station erected and service resumed by 9 p. m. Friday, just twenty-four hours after the fire.



The beet sugar situation today is that everybody wants to see the establishment of a half million dollar factory in the valley, but no one wants to do the work necessary to the suc cessful production of beets. The committee in charge of securing acreage has ran afoul of this sentiment, and when they overcome it, secure signatures from five acres up. According to the committee between 500 and 600 acres has been signed up to date, with an excellent chance that this amount will be trebled. A peculiar feature of the campaign is that none are opposed to the beet sugar factory, but everybody is waiting for others to take the chance. There is also the fear that the beet sugar acreage will cut down the hay crop and make feed for stock short. The factory would produce the best stock feed in the world, besides there is plenty of room for both hay and beet production. A good meeting was held at Phoe-

nix Friday and quite an acreage signed up.

### TO THE CITIZENS OF MEDFORD:

The Rogue River Public Service Corporation has submitted a business proposition to your city council to furnish electric current in wholesale quantities, to be delivered at your city limits, the city to acquire, own and operate the distributing system for the distribution of current to the consumers. The proposition, if accepted, will place electric current on a basis whereby a reduction of approximately 50 per cent may be had by the consumers in their lighting and power bills.

Based on these rates, the city will be able to acquire, own and operate a modern distributing system, and retail electric current to the consumers on a sliding scale, with the present consumption of electric current in the city, with 5c per K. W. hr. as the maximum rate, which will reduce your lighting and power bills approximately 50 per cent.

So that the layman may understand the difference in cost of electric current at the present rates and the cost under this company's proposition, the following comparison of cost for operation of the various electrical appliances is given:

## PLAN TO RUSH WORK UPON POWER PLANT

Beginning Monday the Rogue River Public Service corporation will double its force of workmen at Gold Hill and rush the work of installing machinery, making improvements, etc., on their new plant. Sign lighting and decorative lighting rates are based on the same schedule and the same reduction per watt of the consumption applies.
