ARANTCONTENDING FOR WILL G. STEEL'S POSITION

WASHINGTON, May 4.—Secretary of the Interior Lane must show cause before the supreme court of the District of Columbia by May 11 why a mandamus should not be issued compelling him to reinstate William F. Arant as superintendent of Crater Lake National park.

Arant was removed June 30 after having refused to resign at the request of Secretary Lane. On that date Arant asserts, a United States marshal and posse ejected him and his family from the superintendent's house and took possession of the building.

Arant contends he was a civil service employe and could be removed only for cause. He is represented by J. A. Carnahan, of Klamath Falls, and by Washington counsel.
