

# ASHLAND ADOPTS SIX AND SIX PLAN FOR CITY SCHOOLS

ASHLAND, March 10.—After considering the six-and-six plan of schools for practically a year, the school board, at a special meeting held March 8, 1916, decided to reorganize the city schools on that basis. Under this plan, six years will be devoted to strictly grade work, three years to the work embraced in the intermediate or junior high school, and three years to the work of the senior high school. In the junior as well as the senior high school departmental teaching will provide better instruction for the pupils, enabling them to save time and accomplish more by permitting them to select work along the line best suited to the special needs of each. Promotions will be by subjects, thus the repeating of studies where one has become reasonably proficient will be saved to the pupil and to the school management.

Grade schools, the first six years of the course as now known, will be held in both the east and the west side buildings. The intermediate or junior high school will, for the present, be held in the west side building and the senior high school will continue in the new high school building. No pupils will be withdrawn from the present high school building, but the ninth year pupils for September, 1916, will continue to attend the junior high school or the west side building. The courses in vocational work will be greatly strengthened during the seventh, eighth and ninth years of the school work. In this trial period the pupil will find himself so that upon entrance to the senior high school he may at once pursue the line of work which he has decided to make his life occupation.

Fortunately, the west side building lends itself to the new plan without any modification, as it was originally built for the accommodation of the city high school.

## ORDINANCE NO. 844

An Ordinance declaring certain popular trees within the City of Medford, Oregon, a nuisance, and providing for the abatement of the same, describing the nuisance, where said nuisances exist, and declaring an emergency.

The City of Medford Doth Ordain as Follows:

Section 1. That because of the destructive character of the roots of the poplar trees, in the upheaval of sidewalks and the stoppage of sewer pipes, located and growing either in and upon the hereinafter described premises, or upon what is called the "parking strip" in front of or adjacent to said premises, in the streets of said city, said trees are hereby declared to be a nuisance in each particular instance.

Section 2. That upon the passage of this ordinance, and immediately after it becomes operative the street commissioner shall cause said trees to be removed, and said nuisance forever to be abated.

Section 3. That the properties on which said nuisances exist are particularly described as follows, to-wit:

In parking strip on South Fir street in front of lot one (1) block one (1), of Helms Addition to Medford, according to the plat thereof.

In parking strip on Summit avenue in front of lot nine (9), block one (1), Summit Addition to the City of Medford, according to the plat thereof.

In parking strip on East Third street on side of lot six (6), block 10, original townsite of Medford.

In rear of parcel of land 70x100 feet, and situate at the northwest corner of Fifth and Apple streets, in the City of Medford.

Section 4. Inasmuch as it is necessary in order to preserve the property of the city, which said nuisances are hereby declared to exist, and this ordinance shall be in effect immediately after its passage and approval by the mayor.

All ordinances and parts of ordinances in conflict herewith are hereby repealed.

The foregoing ordinance was passed by the city council of the City of Medford, Oregon, on the 7th day of March, 1916, by the following vote:
