

PROBE OF BORDER PROBLEMS TAKEN UP BY COMMISSION

NEW LONDON, Sept. 18.—Contrary to the plan of the American members, the joint Mexican-American commission, which resumed its conference here today, took up again the consideration of plans for control of the border.

Luis Cabrera, chairman of the Mexican delegation, who presided today, admitted that reports of the discussion of the internal affairs of his country had brought to him an inquiry from his government as to why the border question was not made paramount.

Members of the American commission did not regard the insistence of the Mexican representatives in insisting upon discussion of the border situation as anything endangering the success of the conference.
