ASK FORMER PREMIER VENIZELOS HIS POSITION

LONDON, Oct. 5.—"Former Premier Venizelos" says the Daily Mail's Canea, Crete correspondent "has been sounded from Athens by a personage close to King Constantine as to whether, in the event of war being declared on Bulgaria, M. Venizelos would demand the premiership in a cabinet of his own choosing, or be content to support a coalition cabinet, or whether he would support a cabinet which, the non-containing members of his party would declare war and act along the lines of his policy. M. Venizelos answered that he was ready to support any cabinet which would put Greece's forces on the field beside those of the entente powers."

OMAHA, Oct. 5.—Omaha drew first blood in the post-season baseball series, being staged with Louisville for the minor league championship of the country by 11 to 7. The game was played in the morning on account of the afternoon parade.

NO JOKER IN CHILD LABOR LAW

CHARGES have been made by those who have never read it that the child labor law passed by congress upon the insistence of President Wilson contains a joker. Such is not the case.

Senator Cummins of Iowa declares charges of a "joker" without any foundation whatever, and stigmatizes those making them as "either insincere or incompetent," and asserts that the act is certain to effectuate the humane purposes toward which the friends of child labor legislation have for a long time been striving.

"If republicans are making any such charge against the law in order to discredit the administration," Senator Cummins says, "the effort is disreputable and must react upon those who are foolish enough to give currency to the charge."

The alleged possible "joker" was the provision forbidding the entrance into interstate commerce of products from any manufacturing establishment in which "within thirty days prior to the removal of such product therefrom children under fourteen years of age have been employed."

It has been alleged that manufacturers and industries can evade the law by keeping their products in storage or warehouses for a thirty-day period before offering them for transportation.

The national child labor committee, which is largely responsible for the law, declares in a statement just issued that the clause in question refers to removal from the actual factory and not to any removal for purposes of interstate transportation. If child labor was employed for thirty days before the goods were removed to storage or warehouse, they cannot be shipped thereafter, no matter how long they remain on hand.

The bill was carefully framed and considered three years before enactment, is satisfactory to its sponsors and will prove effective in the only way the federal government can act to regulate child labor—through interstate commerce.

"HOW-DE-DO"

Lorimer, Guggenheim, Barnes, Gallinger and their like in defiance of the will of the people"; and, finally, with the chief executive of "a government under which the people are defrauded of their rights."

These are the honest opinions of each other entertained by the only living ex-presidents who have united with the steel trust and the harvester trust and the Standard Oil, with Guggenheim, Penrose, Gallinger, Barnes, Lorimer and Cannon, and joined the alliance of "crooked privileges," "crooked politics" and "crooked business," "special privilege" and "special interests" to elect Hughes and defeat Wilson.

What a touching and appealing spectacle it made—the "demagogue" and the "honeyfugler," kissing and making up with the "beneficiary of crooked business" and "upholder of privilege," in a supreme effort to ensnare voters for Hughes, the human dragnet for anti-Wilson votes, who, with the damp platitudes of an undistinguished candidate, is touring the land without a vital issue.

MILK DEADLOCK NEW YORK CITY

NEW YORK, Oct. 5.—Efforts to compromise the controversy between the milk producers and the city distributors having failed, consumers today pinned their hopes upon the state investigation which is to begin before a referee here tomorrow.

Some indication of a possible settlement also was seen in an offer by one of the big distributors to give the farmers an advance of 35 cents per 100 pounds over the prices heretofore prevailing. The Dairymen's league insists upon an advance of 45 cents a hundred pounds. It was rumored that one of the distributors had decided to withdraw from the conference over the price and to make a separate peace with the producers.

From up-state counties and New Jersey came news of more rioting and raids by masked farmers.

ZEPPELIN SIGHTED SINKING IN NORTH SEA

ESBJERG, Denmark, Oct. 5.—Fishermen who arrived here today reported that at noon Monday they sighted a partly submerged Zeppelin 35 miles northwest of Island of Sylt in the North sea, off the coast of Schleswig. Several German destroyers and two large vessels were surrounding the Zeppelin, the fishermen said, in an attempt to keep her afloat.

WOMAN KILLED, THROWN IN POND

CHICAGO, Oct. 5.—The identity of the well-dressed young woman, whose body was found in a lagoon in Jackson park last night, remained a mystery today.

Police believe the victim was slain possibly by robbers, as the pendants of her earrings were missing, only the gold clasps being fastened to the lobes of the ears. A white shoe also is missing. It apparently had been torn from the victim's foot. The other shoe was properly laced.

Bruises on the body of the victim, who was apparently about 26 years old, showed she had been struck probably with a hammer. The victim was about to become a mother.

FAIRBANKS OFF ON OREGON TOUR

SAN FRANCISCO, Cal., Oct. 5.—Charles Warren Fairbanks, republican vice-presidential candidate, planned to leave San Francisco shortly before noon today for Portland, Or., on his political tour through western states. Several days were to be spent by the nominee in northwestern cities before his return to the east.

One political speech was delivered by Mr. Fairbanks while in this city yesterday, and he was expected to have a morning of rest today before boarding his train for the north.

WIRELESS SENT DIRECT TO JAPAN FROM 'FRISCO

SAN FRANCISCO, Oct. 5.—The San Francisco Marconi wireless telegraph station was in direct communication today with a Japanese government wireless plant at Ochi Ishi, Japan, 5,800 miles away. The "conversation" with the Japanese station was one of a series of successful tests being carried on preliminary to inauguration of "the longest wireless commercial service in the world," which is to be established soon, according to Marconi officials here.

BERLIN SHY OF FOOD SUPPLIES

LONDON, Oct. 5.—Great difficulty is being experienced in provisioning Berlin, according to the Socialist newspaper, Vorwaerts, of that city, as quoted by Reuter's Amsterdam correspondent. The potato supply is said to have been stopped during the last few days, the interruption being attributed to lack of field laborers. The decrease in the milk supply is the subject of anxious discussion by the authorities. The newspaper says many of the large milk dealers have discontinued their consignment to the
