

AMERICA READY TO FIGHT IN JUST CAUSE--WILSON

OMAHA, Neb., Oct. 6.—President Wilson discussed the European war, peace and American business in three speeches here yesterday. He declared America is as ready to fight as any nation in the world but that its cause must be just. After the war, he said, this nation must join a league of nations to preserve the peace of the world.

President Wilson declared at last night's dinner that he had been greatly pleased by the reception accorded him during the day. "The thinking, planning brain is the master of America," said the president in discussing the broad view of the people of Nebraska.

Governor Morehead introduced the president. Every mention of Mr. Wilson's name evoked applause.

"It would be very difficult to do justice to an occasion of this kind," began the president. He spoke of the importance of the west, mentioning Nebraska particularly and praised the people who come from Europe to seek freedom. The doors of the United States, he said, were built to be kept open, not to be closed. He paid tribute to the western pioneers.

Since 1899 when internal frontiers in the United States disappeared, the president declared, America has taken on a new aspect and the nation has grown closer together. It was no coincidence, he said, that soon afterward interest was shown in Cuba, the Philippines and Porto Rico.

"Ever since then," he continued, "we have been caught inevitably in the net of the politics of the world. Therefore, I want to discuss our connection with the rest of the world at present and in the future.

"Those great central plains are unlike either coast," he declared, adding that on the Pacific coast many rumors are heard of troubles in the Orient, while on the Atlantic coast the influence of Europe are sometimes felt.

"In order to carry out a program you must have unification of spirit in America," he continued. "There can be no program without a unified course behind it.

"It is very important that the statesmen of other nations should understand America. We have held off from the conflagration in Europe because we wanted to play a different part."

The president was interrupted by applause and shouts of "we thank you."

The causes of the European war, the president said, were not plainly known.

"But Europe should understand us," he said. "We are holding off because when we use the force of this nation we want to know what we are using it for.

"There is as much fight in America as any nation in the world.

"We want always to hold the force of America to fight for the rights of mankind, not for the rights of property. But in fighting for these things we should know what the one is. We must have absolute allegiance to America. We must be truly American. The rights of humanity are the essence of freedom.

"We want all the world to know that we are ready to use our force to maintain peace among mankind. The starting of wars never again can be the private concern of any one nation. We must use all our force, moral and physical, to uphold a league of nations, to uphold the peace of this world."

The president declared there was no use fighting over petty things. He discussed the attitude of George Washington on entangling alliances, saying he did not believe Washington meant the United States should not come into contact with the world.

NEW YORK, Oct. 6.—The police promised more arrests today in connection with the plot to kill President Theodore P. Shonhs of the Interborough Rapid Transit company and Frank Hedley, manager of the New York Railways company.

The police declared they had evidence that men arrested early today were involved in the supposed conspiracy, but refrained from bringing such a charge against them until officers were arrested.

Detectives got evidence ten days ago that plans were being laid to kill Shonhs and Hedley. The two traction officials were warned and given permission to enter plots.
