PARIS, Jan. 22.—Two attacks were made by the Germans last night on the Verdun front on the right bank of the Meuse. Today's official announcement says that they were driven back each time by the French fire.

BERLIN, Jan. 22.—The repulse of a minor attack by the British on the German lines near Lens is announced in today's German army headquarters statement regarding operations on the Franco-Belgian front.

COAST BASEBALL PENNANT RACE DECLARED "FIXED"

SAN FRANCISCO, Jan. 22.—A charge that last year's pennant race in the Pacific coast baseball league was "fixed" so that the Vernon club could not win was made today in a statement by Edward R. Maier, former owner of the club, printed here today. Maier was expelled from membership in the league last September.

At that time the explanation of his departure generally accepted was that he did not get along with the directors.

"From the start everything was framed against me and against the Vernon club," the statement said. "Two of the glaring things that were allowed by the league were the Crandall and Davis deals.

"It has been brought to my attention that as far back as 1912 when the Vernon club was beaten by the fraction of a point in the race for the pennant with Oakland, members of the Los Angeles team upon its departure for San Francisco, the scene of the final series, declared that Vernon would never win the pennant if they could help it.

Resolution No. 2.

Resolution accepting the bid of Kalman, Matteson & Wood for Thirty Thousand (\$30,000) Dollars Refunding Bonds of 1917, authorized under and pursuant to Ordinance No. 558 of the City of Medford.

WHEREAS call for bids for the sale of Thirty Thousand (\$30,000) Dollars, five (5%) serial bonds of the City of Medford to be styled "Medford Refunding Bonds 1917" was duly made by publication in a newspaper of general circulation in the City of Medford and published therein, under and pursuant to Resolution of December 5, 1916 and the charter of the City of Medford and the Laws of the State of Oregon, AND WHEREAS on the date set for the opening of the bids, to-wit: January 16, 1917, at 7:30 o'clock p. m. in the office of the City Recorder of the City of Medford and in the presence of the city council in open session, all bids were duly opened, and whereas, after some consideration, said bids the city council adjourned said meeting until January 17, 1917 at 7:30 o'clock p. m. and whereas, on January 17, 1917 at 7:30 o'clock p. m. after some further consideration of said bids the council adjourned said meeting until January 18, 1917 at 7:30 o'clock p. m. and it was then found that the bid of Kalman, Matteson & Wood was the highest and best bid received for said bonds, said bid being as follows:

"For Thirty Thousand (\$30,000) Dollars Refunding Bonds, bearing 5% interest and otherwise as described in the attached advertisement, which is hereby made a part of this bid, we will pay for the entire issue par and accrued interest, if any, to date of delivery, and a premium of Eighteen Hundred Fifteen Dollars (\$1,815.00).
