

BRITISH IMPORTS SHOW A DECREASE

LONDON, April 27.—British Board of Trade figures show that March imports decreased 5,100,000 pounds, while exports increased 6,513,000 pounds. The imports of raw material decreased nearly 3,000,000 pounds chiefly in cotton and wool. The imports of foodstuffs increased 663,000 pounds.
