

TURKS PERSECUTE JEWS OF JOFFA AND JERUSALEM

CHICAGO, May 23.—Privations of the Jewish population of Jaffa in their flight from their homes before the Turks were described in a letter received here today by Adolph Kraus, president of the Independent Order of B'Nai B'Rith, from Sir Cecil Arthur Springs-Rice, British ambassador at Washington. The letter enclosed a copy of a cablegram received at the British embassy from the foreign office in London for the information of the various Jewish bodies in the United States. The cablegram said: "During the Passover the entire Jewish population of Jaffa was expelled toward the north. Homes and property were sacked. The population in flight was robbed with the complicity of Turkish authorities. Jews resisting pillagers were hanged. Thousands are wandering helplessly on the roads and are starving. The overcrowding of the colony is increasing misery and disease. Masses of young Jerusalem Jews have been deported northward to an unknown destination. The forcible evacuation of the colony is imminent. British authorities favor constitution of special local committees to gather funds for the relief of Jewish population, whose plight is lamentable. Remit funds immediately to Professor Weiman of Manchester. A special committee can be addressed care of general headquarters, Cairo."

WOMAN BITTEN BY MAD DOG

ELENSBURG, Wn., May 23.—Mrs. Geneva Barkley, former superintendent of schools of Kittitas county and at present a teacher at Boylston, was bitten many times by a mad dog last night. She was walking across a field half a mile from any building when the dog attacked her. Mrs. Barkley was bitten on both arms and legs and several places on the body. She finally managed to get help and was carried to Boylston on a gasoline speeder. Mrs. Barkley will be taken to Seattle for treatment and her recovery is hoped for. Her flesh was torn open in eleven places on the arms, the dog's fangs penetrating in some places to the bone. Rabies first broke out among the coyotes of Central Washington in January. Many dogs have been attacked, and numerous animals of several kinds killed to prevent spread of the disease. Central Washington has been under quarantine by the state department of agriculture several weeks.

An Ordinance amending Section 18 of Ordinance No. 874, the same being "An Ordinance regulating the use and sale of water in the City of Medford, Oregon, and prescribing rates for the use thereof and repealing all ordinances and parts of ordinances in conflict herewith. Approved February 10th, 1917. THE CITY OF MEDFORD DOETH ORDAIN AS FOLLOWS: Section 1. That Section 18 of Ordinance No. 874, entitled "An Ordinance regulating the use and sale of water in the City of Medford, Oregon, and prescribing rates for the use thereof and repealing all ordinances and parts of ordinances in conflict herewith, passed by the city council and approved by the mayor February 10th, 1917, is hereby amended so as to read as follows: "Section 18. Water rentals shall be paid to the city treasurer as follows: Water users in the first ward of said city shall pay their water rent on the first days of January, April, July and October of each year in advance for a period of three months; water users in the second ward of said city shall pay their water rent on the first days of February, May, August and November of each year in advance for a period of three months; water users in the third ward of said city shall pay their water rent on the first days of March, June, September and December of each year in advance for a period of three months. In case any person begins the use of water on any premises where the same has not been previously used, he shall pay the proportionate amount in advance up to the next quarterly payment period. "Section 2. Inasmuch as the subject matter which this ordinance seeks to regulate is in constant use, and is for the convenience of the inhabitants of said city that such matter should be regulated, and inasmuch as the reorganization of the water department of said city of Medford is of the utmost importance to the general welfare of said city, and the peace, health and safety of said city is directly involved, an emergency is hereby declared to exist and this ordinance shall be in full force and effect immediately after its passage by the council and approval by the mayor. "The foregoing ordinance was passed by the council of the City of Medford, Oregon, on the 22d day of May, 1917, by the following vote: Emmens, absent; Gaddis, "aye"; Keene, absent; Carlin, "aye"; Davis, "aye"; Harrgrave, "aye." ORDINANCE NO. 886

An ordinance fixing the time of payment for the monthly salaries and bills. THE CITY OF MEDFORD DOETH ORDAIN AS FOLLOWS: Section 1. From and after June 1, 1917, all monthly salaries and wages of officials and employees of the City of Medford shall be paid on the 10th day of the succeeding calendar month, and all bills and claims against said city or any of its departments thereof shall be payable on the 25th day of the succeeding calendar month, except such as are subject to discount which shall be payable on the 10th of such succeeding calendar month. Section 2. No bill or claim against the City of Medford or any of its departments shall be added or allowed for payment in any calendar month
