

DROUTH DESTROYS GERMAN CROPS FOR SECOND TIME

COPENHAGEN, June 19.—Thruout Germany, according to reports here all valuable grain crops are burning up as they did in 1915 in an unprecedented heat wave.

Many horses were scratched on the opening day of the Hamburg derby week, because the track, built on a marshy corner moor, was baked too hard for safety.

The effect of the drouth on grain crops around Berlin where only eight millimetres of rain have fallen since May 1 is described by a neutral who arrived on Saturday as almost catastrophic.

The Sunday sermon writer in the Berlin Kreuzzeitung who recently indulged in a startling blending of religion and politics, declared on Sunday that the drouth was sent as a punishment for the sins of the people for listening to the editors of irreligious newspapers and asked how long it would be before this divine chastisement would bring the people to a sense of their iniquities.
