

TEN REGIMENTS OF INDIAN CAVALRY FROM 189 TRIBES

WASHINGTON, July 25.—Ten or more regiments of Indian cavalry to make available the military resources of 189 tribes are proposed in the Kahn bill which Dr. Joseph Kossuth Dixon of Philadelphia, head of the Rodman Wanamaker North American Indian researches, advocated today before the house military committee.

WANT REGIMENT OF COOKS FOR ARMY

WASHINGTON, July 25.—The quartermaster general has been directed to organize at once forty bakery companies in addition to the ten companies now within the continental limits of the United States.

The personnel of these companies will consist of: One first lieutenant. One second lieutenant. One sergeant, first class, \$51 per month. Twenty-three sergeants, \$44 per month. Fifteen corporals, \$36 per month. Forty-five privates, first class, \$33 per month. Fifteen privates, \$30 per month. Two cooks, \$38 per month. In addition, the government furnishes food, lodging and clothing. The equipment consists of the army field bakery No. 1 oven with equipment. One of these ovens with equipment is designated as a unit, and is so equipped that it is a field bakery complete in itself with a personnel of six men capable of supplying 1800 men per day with bread.

EUGENE BARBERS STRIKE FOR SHORTER HOURS

EUGENE, Or., July 25.—Eugene journeymen barbers, numbering about twenty, and including every one in the city, according to their leaders, went on strike here today for shorter hours. As a result, none but proprietors of shops are working at the chairs, and there is a long line of waiting customers at every shop.

STATES IN DRAFT RACE

War department employees who enter the militia establishment with the approval of their immediate chiefs will be reinstated in their civil positions when their military service ends. A previous war department regulation required employees who entered training camps to resign their civil posts is rescinded. Approval of department chiefs will be required hereafter before employees of any executive department of the government will be accepted in any army organization.

SECOND PORTION NATIONAL GUARD ENTERS SERVICE

WASHINGTON, July 25.—The second increment of national guard troops was called into the federal service today. All troops from Maine, New Hampshire, Vermont, Massachusetts, Rhode Island, Connecticut, New Jersey, Delaware, Maryland, District of Columbia, Virginia, North and South Carolina, Tennessee, Illinois, Montana, Wyoming, Idaho, Washington and Oregon came under President Wilson's proclamation preparatory to mobilization in southern training camps to be equipped and outfitted for duty in France.

The remainder of the states, the far western and southwestern states, will be taken in August 25, when the draft clause of the national defense act will be applied to the entire force and the guardsmen will cease to have any connection with the state authorities for the period of the war. The first increment which included the New York and Pennsylvania divisions was called out July 15, and has been held at state armories for preliminary equipment or started south to the training camps. The same process will be carried out with the men called out today and the federalization of the force for war purposes will be completed on August 5. Thereafter there will be no constitutional or other legal barrier to the immediate transportation of guard organizations to France.

IRISH CONVENTION MEETS IN DUBLIN

DUBLIN, July 25.—The convention which is to attempt to reach a solution of the Irish problem was opened this morning at Regent house, Trinity college. John Redmond, the nationalist leader, and Joseph Devlin, one of his prominent party associates, were among the early arrivals. Protestant and Roman Catholic clergymen arrived soon afterward, followed by representatives of public organizations, trades and labor councils. There was a noticeable lack of enthusiasm among the spectators. Joseph Devlin was the only delegate who was cheered.

RUSSIANS STILL IN RETREAT

BERLIN, July 25.—The advance of the Austro-German forces in eastern Galicia continues uninterrupted, the war office announces. Tarnopol has been captured and the Germans are nearing Buczaca. Russian troops, taking the offensive south of the Carpathians, penetrated the Austro-German lines. They were brought to a standstill, the war office reports, at the German protective position west of the point of attack. The statement also reports the capture of Stanislaw and Nadvorna. Heavy artillery fighting is in progress in Rumania.

Western Front.—West of Dinvik our forces occupied enemy trenches on both sides of the Drinsk-Vilna railway. North of Krovo the enemy occupied one height near Bogush, which we captured July 22. The officers with difficulty restrained the men from withdrawing to the rear in great numbers. In the region of Mikulice the enemy occupied the village of Volya Masovecava. On July 23 he occupied Bernaduvka, Dorohav and Kolaruv. Northwest of Busaznez our troops are holding Galvoronka-Monasterzyaska line.
