GORE ARRESTED FOR NOT DIMMING AUTO HEADLIGHTS

"I am innocent of the charge and it will have to be proven against me in court before I will pay a fine," said W. H. Gore today in explaining why he entered a plea of not guilty before Justice Taylor following his arrest by County Prosecutor Roberts' motorcycle cop on the Pacific highway because of not having his auto lights dimmed, in compliance with the state law, as the cop claims.

The motorcycle cop had just arrested a Portland auto dealer on the same charge, and the two were standing by the car at the side of the road, engaged in a loud word wrangle when Mr. Gore and his son Jay came driving by. The cop ordered Jay, who was at the wheel, to stop, but Mr. Gore, who was in the rear seat, thinking that the motorcycle cop and the other man were returning from Hornbrook, ordered Jay to speed up.

The cop then speeded after them on his motorcycle and rode beside their car, calling upon them to stop, without showing his badge or telling them that he was an officer. They also claim that he swore at them repeatedly and was otherwise abusive. Finally, when he showed his badge, they stopped the car and submitted to arrest.

"The law says that the front lights shall be dimmed when the safety and convenience of the public demand," said Mr. Gore today, "and there was certainly no occasion for us to dim our lights that night, as there was no one on the highway ahead of us except these two, who were standing by the car at the side of the road and wrangling."

Otto Schneider, the Portland auto dealer arrested that same night, pleaded guilty before Justice Taylor yesterday and was fined \$5 and costs.

MARINE CORPS TO CEASE RECRUITING

The marine corps, after having maintained a recruiting office in Medford for the past six months, will close up that office for good on October 1. Captain L. P. Pinkston, in command of the Portland district of the marine recruiting corps, arrived in the city late yesterday from Portland by auto en route to Mare Island San Francisco, and gave Sergeant James Brooks the closing up orders.

He has also ordered the recruiting offices at La Grande and Eugene to be closed at the same time. This shutting down of the three offices is due to the fact that the marine corps is already far over-enlisted, and only 21 more enlistments can be made in the entire Portland district of which appointment Medford can only have two or three more.

After closing up the office in the federal building on October 1, Sergeant Brooks has been ordered to report for duty at the headquarters office in Portland. He has been on duty here for the past five months. Mrs. Brooks and their little son will accompany him to Portland.

CATHOLICS PLEDGE LOYALTY TO WAR; COMMEND POPE

KANSAS CITY, Aug. 28.—Resolutions "acclaiming" the peace proposal of Pope Benedict and pledging all Catholics of this country to the war program of the United States, but containing no clause urging acceptance by the American government of the papal suggestions, were reported favorably today by the resolutions committee of the American Catholic societies.

The loyalty resolution declares that "in accordance with the unbroken tradition of loyalty for the foundations of this republic, we solemnly affirm our inalienable attachment to the principles of American government and we pledge without reservation our blood and our treasures for the defense and perpetuation of our beloved country."

The pope's proposal was spoken of as follows: "We reverently and joyfully acclaim the action of our most holy father, Benedict XV, in his proposal of a basis for the negotiation of peace between the warring nations, and we mark with pardonable pride the accord between the articles of agreement offered by the supreme pontiff and the tentative suggestions formerly made by the president of the United States."

WEDDING IMPROVES LOYALTY TO U. S. A.

A peculiar change in loyalty due to the war came to notice last Saturday evening when a German couple who are residents in this vicinity entered Johnson's jewelry store and asked John W. Johnson if he could erase the German inscription in their wedding ring and engrave the same inscription in English instead.

They were told that it could easily be done, and when asked why they wanted the change made, the husband replied: "When we were married we had the inscription engraved in German and were proud to have that language used. Since then we have parted with those people and want the words in good old U. S. A."

The wife also spoke along the same lines, and the incidental conversation showed that their deep sympathies and loyalty were with the United States in the war, than which no better proof could be offered than to have their sacred wedding ring inscription changed. They left the ring to be changed.

AUSTRIA LIKELY TO DECLARE WAR

WASHINGTON, Aug. 28.—The possibility that Austria and perhaps other allies of Germany may soon declare war against the United States because of the financial aid given Italy is recognized by administration officials.

It was carefully explained today that there is nothing in the existing situation, either diplomatic or military, that would cause the United States to take the initiative, but that an anomalous state of affairs which may result in broadening the war does exist was not denied.

Relations of the United States with Germany's allies are defined as still a state of broken diplomatic relations. Officials hesitate to describe them as unfriendly, although admitting that they could scarcely be called friendly. The policy of extending aid to countries fighting certain of Germany's allies will be continued, and it was admitted that Austria might not improbably construe such assistance as a warlike action.

ELEVEN BILLION BOND BILL BEFORE HOUSE

WASHINGTON, Aug. 28.—Passage by Saturday night of the \$11,538,000,000 war bond and certificate bill now before the house ways and means committee was predicted on the house floor today by Democratic Leader Kitchin.

The house adjourned until Thursday, with the intention of taking up the measure upon reconvening.

GERMAN REPLY TO ARGENTINE SATISFACTORY

BUENOS AIRES, Aug. 28.—Germany's reply to Argentina's note embodying demands in connection with the submarine campaign as affecting Argentine shipping has been received. In official circles it was said that the report was satisfactory. According to the newspaper La Razon, the German note meets all the demands of Argentina.

PORTLAND, Aug. 28.—Two forest fires in the Siskiyou mountains of Josephine county, Southern Oregon, were uncontrolled today, according to reports reaching the federal forestry offices here. They have been burning for several days, the report said.
