ASHLAND AND VICINITY

Ashland's patriotic fund has reached \$18,000 or thereabouts and the desire is to place it on a basis of \$20,000 in round figures. Most of the subscriptions are on the monthly payment basis, yielding fixed returns of approximately \$1,800 per month. Of the sum total of the fund, \$5,000 will go outright to the Red Cross, making Ashland's quota assured in this respect, which is merely confirming a previous guarantee that this appropriation would be forthcoming on short notice. The campaign proper has closed without frantic appeals, the proposition having been presented on the basis of moral suasion and sound business principles. Before the drive was fairly under way, E. V. Carter, manager of Red Cross activities for this district, wired headquarters that Ashland's quota was pledged unequivocally, backing this statement with a personal guaranty, a circumstance which goes to show the faith the workers had in the merits of the appeal in behalf of the great relief movement, and the assurance that the response would be both speedy and liberal. 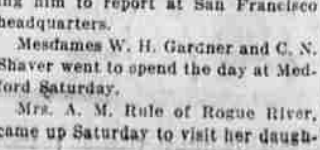
