FOCH SATISFIED WITH FIGHTING ON MARNE FRONT

LONDON, July 16.—Andrew Bonar-Law, chancellor of the exchequer, announced in the house of commons last night that the Americans had captured a thousand or more prisoners south of the Marne, after having driven back the enemy.

Mr. Bonar-Law read the following communication to the house: "The enemy attacked early this morning on a front of 90 kilometers, pretty evenly divided east and west of Rheims. The city itself was not attacked."

"West of Rheims the Germans penetrated on a front of 36 kilometers (22.37 miles) to an average depth of from four to five kilometers.

"South of the Marne, by a brilliant counter-attack, the American troops drove the enemy back and took a thousand or more prisoners.

"East of Rheims the enemy has been heavily repulsed and has suffered a complete check."

Sir Walter Runciman said the house would wish to offer congratulations not only to the French troops but also to the Americans, who had justified the fine things said about them.

Before reading the communication Mr. Bonar-Law said he had reached his house shortly before 11 a. m.

"I may add," he said, "in addition to what I am going to read, that the premier has been in telephonic communication with headquarters, and he report given to him as coming from General Foch is that he is well satisfied with the results of today's fighting."

YANKEE FIGHTERS "SPLENDID MEN" —LONDON TIMES

LONDON, July 16.—The brilliant contribution of American troops to the allied defense at Poesoy figures conspicuously in the battle reports and is made the subject of special mention in the editorial columns of the morning newspapers.

"Splendid men" is the description contained in the Times while another paper calls the American defense, "The most encouraging feature of the day's fighting."

It is regarded here as being too early to pronounce any opinion on the great battle east and west of Rheims, but the fact that the Germans have not been able to make any substantial advance has been received with relief.

As far as is known nothing developed Monday to show whether the enemy's extensive attack is the main blow.

It is suggested that the present assault may be a diversion to draw the allied reserves from the Flanders front to prepare the way for a German attack in that region.

12,000 DRAFTED MEN ARRIVE AT CAMP LEWIS SOON

CAMP LEWIS, TACOMA, July 16.—Preparations here are now actively under way for the assignment and equipping of the draft of approximately 12,000 men who will begin to arrive in camp beginning next Monday.

The headquarters of the 169th depot brigade were moved today and barracks which have been only half full are being emptied and others filled up, so that the new men will have ample quarters. Company supply sergeants will be designated in a few days and men equipped with uniforms as soon as possible after their arrival.

With but a few days before the men entrain, officers of the depot brigade again today emphasized the importance of not bringing to camp anything that is not absolutely necessary. While uniforms are issued as soon as possible, several days elapse before the men are supplied with underclothing, and such drill and work must be performed in the civilian clothes which they wear when arriving here. Everything that is necessary can be placed in a suitcase. Officers urge relatives and friends not to begin writing to the men as soon as they arrive, but to wait until they arrive and are assigned, and in possession of their correct addresses. Hundreds of letters with merely the address "Camp Lewis," remain.
