Hillah Temple, A. O. N. M. S., will hold a fall ceremonial in Ashland, at Mason's hall, on Friday, Nov. 1. Business session, 7:30 p. m.; memorial session, 8:30; ceremonial session, 8:30; banquet, 10:30. The executive committee includes W. E. Newcombe, W. H. McNair, Stuart Saunders, O. Winter, H. C. Sparr, and C. F. Bates will attend to decorating the ceremonial headquarters. M. F. Cyster, Stuart Saunders at 1 C. C. Weisenburger constitute the refreshment committee. The temple's roll of honor contains the names of 15 members who are serving in various capacities in the army and navy, and during the past year five of the membership are inscribed among the mortuary records as having "entered the unseen temple." According to formal announcement the customary second section of the ceremonial will be dispensed with, other features being substituted. Geo. T. Collins, of Medford, is illustrious potentate, and other out-of-town officers include the names of W. A. Folger, C. E. Gates, Wayne Leever, W. H. McGowan, W. M. Colvig, L. B. Haskins, and Geo. B. Lundbury. It is taken for granted that the holding of the ceremonial on the specific date indicated is contingent upon whether the ban on public gatherings shall yet be in force on Nov. 1. If such is the case, further arrangements will be made accordingly.

Mr. and Mrs. Jeff Neil, of Eugene, well known former residents of this vicinity, are visiting their numerous relatives and friends hereabouts. Lieut. Cleveland C. Frost, of Berea, Ky., who lost his life incident to the submarine of the transport Ticonderoga, Sept. 29, was an intimate personal friend of the C. L. Hanson family of this city, who speak in the highest terms of the young officer's character and attainments. This tragedy of the sea witnessed the loss of over 100 American soldier boys, some of whom were reported to have been shelled in the lifeboats after leaving the doomed vessel.

The finals connected with the Liberty loan campaign here reveal total subscriptions, all voluntary, of \$190,930 by 1174 purchasers. The amount of purchases thru banking channels was \$168,400. Investments by railroad employees, thru the Southern Pacific specifically, were \$20,050, this amount not including purchases by railroad men thru other agencies. The proportion of medium and small investments in this fourth series was overwhelming. The district quota of \$181,600 was oversubscribed by \$8450. Very few corporations invested, neither did the banks subscribe, except by their respective persons as individuals. All of which goes to show that, in this vicinity at least, the investment was a popular one among the people at large, a circumstance mutually satisfactory as well as gratifying to the government and its loyal citizens.
