

TWO RAILROADS TO BE OPERATED ON DOUBLE TRACK

SAN FRANCISCO, Oct. 28.—In order to most efficiently operate the Southern Pacific and Western Pacific railroads under federal control plans have been made and will become effective in a few days for operating lines of the two systems as a double track for about 182 miles in Nevada where the roads are close together.

When the new plan becomes effective, all eastward trains will move over Western Pacific tracks, and western trains over Southern Pacific tracks.

This does not mean, as seems to be the impression by some, that all traffic east or westbound between Salt Lake and Ogden and San Francisco will be handled by the Southern Pacific or Western Pacific. Both roads will retain their identity and will handle only their own trains.

Such an arrangement is only carrying out the plan that was worked out by the officers of both roads before the Western Pacific went into the hands of a receiver.

SELECTED BEAN SEED PROFITABLE

OREGON AGRICULTURAL COLLEGE, Corvallis, Oct. 28.—The value of disease free bean seed selected from high yielding plants in the field is cited by B. F. Sheehan of the far-crops department here.

"The benefits of selection are not fully appreciated by the average grower," he admitted, "but selection is essential to maximum returns. It has proved beneficial in many instances, and should be resorted to whenever possible."

"Alfred Butterfield of Molalla has grown beans for many years. Each year he noticed considerable variations in the yielding power of different plants. He began to select seed first from plants that bore six or seven beans to the pod, then those with four to six, and lastly from non-selected plants. All these he planted side by side in the same field.
