

### CHAMBERLAIN CITES APPEAL OF M'KINLEY

Senator Chamberlain, who is en route to Oregon from Washington to attend his daughter's wedding, has wired his followers his position on the appeal of the president for the people to rally to his support:

KEARNEY, Neb., (On train, en route to Oregon.)—It is a far cry from 1898 and 1900 to 1918, but what President Wilson is doing now, in appealing to the people to elect a congress friendly to the policies of his administration, was done by President McKinley in more than one public address in 1898. On October 11, 1898, in a speech at Boone, Iowa, he said:

"This is not a time for divided councils. If I would have you remember anything I have said in these desultory remarks it would be to remember at this critical hour in the national history that we must not be divided. The triumphs of the war are yet to be written in the articles of peace."

Again in a speech delivered at Carroll, Iowa, October 11, 1898, he said:

"Just at this hour, although hostilities have been suspended, we are confronted with the gravest national problems. It is a time for the soberest judgment and the most conservative and considerate action. As we have stood together in the war, so must we stand together until the result of that war shall be written in peace."

#### Roosevelt Also Issued Plea

On August 18, 1906, Roosevelt, then president, wrote to Congresswoman James Watson of Indiana, as follows:

"If there were only partisan issues involved in this contest, I should hesitate to say anything publicly in reference thereto, but I do not feel that such is the case. On the contrary, I feel that all good citizens who have the welfare of America at heart should appreciate the immense amount that has been accomplished by the present congress organized as it is, and the urgent need of keeping this organization in power. To enhance the leadership and organization of the house at this time means to bring confusion upon those who have been successfully engaged in the steady working out of a great and comprehensive scheme for the betterment of our social, industrial and civic conditions. Such a change would substitute a purposeless confusion, a violent and hurtful oscillation between the positions of the extreme radical and the extreme reactionary, for the present orderly progress along the line of a carefully thought out policy."

This was written to be published, which it was, and to serve as the appeal for the election of congressmen of Roosevelt's political party.

#### Others Backed, Why Not Wilson?

But perhaps I should look for precedents other than the action of Colonel Roosevelt. I find such precedents readily and, as Roosevelt's and McKinley's appeals were heard by the American people, so ought and will be that of Wilson. And as Oregon has so far played a splendid part in this war, why should she not do her still further duty and grant ungrudgingly the president's appeal, not for partisan purposes, but to assist in formulating policies to meet peace and war conditions so that there may be no division. President McKinley's appeal was made in the closing days of the Spanish-American war. President Wilson's appeal is made near the close of the present war. The first was answered and why, for the same reasons, should the last not be answered? The Spanish-American war was mere child's play, compared with the present war, waged as it is in defense of civilization itself. Those who now criticize Wilson approved McKinley's appeal for unity of counsel between the executive and congress.

### NO CONTEST IN CITY ELECTION AT ASHLAND TUESDAY

ASHLAND, Nov. 3.—C. B. Lamkin for mayor, G. G. Eubaaka for treasurer, and Miss Gertrude Biede for recorder, head the municipal ticket here on Tuesday, Nov. 5, the city election hereafter to be merged with the general one, provided a charter amendment is adopted to this effect, and no doubt is entertained but what this will be the case. This plan will not only simplify matters but will reduce materially the overhead expense. All three of the foregoing officials are candidates for re-election. Miss Biede for over a decade has been connected with the recorder's office in one capacity or another. Her candidacy presents the anomaly of a woman being the city's "right hand man" for the job, and faithful efficiency in the performance of exacting duties has won her approval. In her behalf, the mayor and city council have unanimously joined in a hearty endorsement of her qualifications for the position.

The personnel of the city council will be only slightly changed, one new member being added. First ward candidates are P. J. Shinn and C. W. Banta; second ward, C. W. Root and W. A. Turner; third ward, A. C. Nialger and J. H. McGee. A. L. Lamb has been one of the third's representatives, but inasmuch as outside contracts will necessitate his removal from town, a new member of the board will take his place in the person of J. H. McGee, local merchant.

Two members of the park commission are to be chosen. The board now includes Mrs. W. M. Poley, F. E. Watson, Mrs. C. H. Vassel, G. S. Butler, and W. H. McNair. Mrs. Poley and Mr. Watson will be their own successors.

Nine polling places in a town of this size seems a superfluity, but the city in this respect is paying the penalty of its elongation, especially from north to south. The Boulevard precinct will vote at H. F. Pohland's residence, No. 678 on that thoroughfare; East Central, city hall; West Central, McCarthy bloc, upstairs, on North Main; East Main, Hawthorne school; Oak street, near telephone exchange; North Ashland, stone building, north Main; East Ashland; Fourth street engine room; Southeast Ashland, corner of Iowa and Avery; Northwest Ashland, Junior high school.

Among neighboring precincts the Barron section will vote at Nell creek schoolhouse; Bellevue at its schoolhouse; and the Dead Indian country at a cabin on the Mayer-Calkins ranch.

Very little interest is displayed in the city election. Everything outside of national issues centers on the normal school proposition, in behalf of which both town and country have been thoroughly canvassed, while big pictorial specialties on the bulletin boards prominently call attention to a measure which is not only vital to southern Oregon but the state at large. Surely the citizens of Ashland will not allow this specific factor in the election to be overlooked entirely or given lukewarm support. Hunt up No. 200 on the official ballot and vote "Yes" accordingly.

### FIRST LINER ARRIVES WITH LIGHTS ABLAZE

### GERMAN PRESS HOPES FOR DEFEAT OF THE PRESIDENT

WASHINGTON, Nov. 4.—In a savage attack on President Wilson, the Cologne Gazette, imperial organ of the kaiser, in its issue of October 29th, expresses a hope that Wilson may be defeated in the congressional election in America. It says:

"Little by little the winter discontent is setting in for Wilson, the dictator. At the beginning of November the people will, in the congressional election, sit in judgment over him and his war policies."

The Gazette refers to the president's appeal for unified leadership at home, and says it is an attempt to "curtail the opportunity of a people of one hundred million to exercise to the limit its constitutional rights."

Declaring that Wilson is a "desperate man" and that "in 1917 he thought less than nothing of international law when it suited him to do so." The kaiser's organ goes on to say of the American elections: "It is a trial of strength which Wilson thus provokes. If he succeeds, his dictatorship rests upon a foundation enabling him to proclaim himself czar of America, without fear of encountering opposition, but the probability is that he will not succeed. In any event, the November elections will have a significance such as they never had before."

The hope from the kaiser's organ for the defeat of President Wilson in the congressional elections has attracted attention here. The language is almost identical with that used by Roosevelt and others in America now assailing the president.

### FEDERAL FISH BUREAU OPPOSES ROGUE RIVER BILL

The U. S. Bureau of Fisheries supports the attitude of the state fish and game commission in opposing the Rogue river fish bill that gives the Rogue river fishery to the state, holding that fishing regulations on the Rogue should be placed in the jurisdiction of the fish and game commission. The following statement is made by the state superintendent of fisheries:

Clackamas, Ore., Nov. 1, 1918. The United States Bureau of Fisheries has operated a hatchery on the Rogue river for twenty years; having been in charge of that work and all other government hatchery work in Oregon I am entirely familiar with all the conditions on the Rogue river.

The Rogue produces more canned salmon than any other river lying in Oregon. The hatchery work has caused a greatly increased production of salmon and the Rogue is now a stream of prime importance as a food producing river.

In my capacity as superintendent of the Bureau of Fisheries for this state, and with the express approval of Mr. Henry O'Malley, field assistant, I consider it my duty, in view of placing the jurisdiction of the fish and game commission, and in the interests of food production, to earnestly recommend a vote of 304 X No on the Rogue river referendum.

### QUIET CAMPAIGNS THRUOUT WEST ACCOUNT OF FLU

SAN FRANCISCO, Nov. 4.—Political campaigners of the far west rested today from their labors and looked confidently forward to the decision at the polls tomorrow. In a few of the 11 western states where candidates will be chosen for state and national offices the contests were as bitter as any in the history of their statehoods, but for the most part the campaigns were conducted quietly, but with no lessening of a determination to win. Influenza epidemics compelled an abandonment of public meetings and candidates turned to the mails and newspapers to reach the voters.

The west is particularly interested in the outcome of the United States senatorial contests in Nevada and Montana where Miss Anne Martin, the well-known suffragist, and Rep. Jeannette Rankin, respectively, have made strenuous campaigns.

Thirty-three representatives and nine senators are to be elected in Arizona, Colorado, Washington, Oregon, Nevada, Montana, Idaho, Utah, New Mexico, Wyoming and California. Most of these states also will choose governors and entire state tickets.

### SHERIFFS OBJECT TO ELIMINATION OF TAX PUBLICATION

OREGON CITY, Nov. 4.—Sheriffs and tax collectors all over Oregon are aroused over the possibility of the enactment of the tax measure submitted to the voters by G. S. Jackson, of Portland, and appearing on the ballot as 298 Yes and 299 No. Sheriff Gellatly, of Benton county, and Sheriff Bodine, of Linn county, made strong statements this week denouncing the measure as impracticable and dangerous and W. W. Everhart, for the last two years assessor for Clackamas county, made the following statement concerning the proposed measure:

"Notice to the public thru the newspapers is a protection to the owners of the property. It is bad business for a county to sell a man's

property for taxes without a public notice, which can be obtained only by publication. There is no merit in sending the delinquent taxpayer a notice by mail, for we have that provision in the present law, and it does not get the money for the county. What the county needs and must have, is the tax money, and the publication method got it, as no other method will, for in many cases under the present law, the delinquent will pay up his taxes rather than have his name appear in print.

"The publication of the delinquent tax list does not cost the man who pays his taxes a red cent, as the cost of publication is assessed against the property upon which taxes have become delinquent and the publication fee is collected along with the interest and penalty. If a mail notice law should be enacted, then the taxpayer who does pay his taxes will be assessed for the expense.

"I have been the tax collector of Clackamas county several years and my experience tells me that the people should vote No on this measure next Tuesday."
