The following letter has come into the Red Cross office: Because of the fact that certain production activities have been discontinued some of the workers have inferred that the need for Red Cross service in sewing and knitting is over. This is not the case, however, and one of the important future activities of the American Red Cross is the production of refugee garments both knitted and sewed.

The handling of these immense shipments cost at Seattle for drayage, lighterage and clearance only \$3,000. The freight alone to the Atlantic seaboard would have been well over \$100,000 had it not been for arrangements consummated by Mr. Hilton for the northwestern division of the Red Cross which were routed through the northwestern division.

Lowman, Seattle representative, who recommended to Washington that a certain amount of space be allotted to the Red Cross on vessels sailing direct from Seattle to France. The plan was approved and the local representatives of the Shipping Board were authorized to accept Red Cross supplies for overseas shipment without cost of freight.

PREPARE PLANS FOR STATE BUILDINGS
