

GIRL, ILL WITH FEVER, MARRIED AT SANITARIUM

A wedding of unusual sentimental interest in that the bride was ill in bed with typhoid fever took place at the Medford sanitarium at 2 p. m. Monday, when Miss Pearl Watkins, 19 years old, and Vorn F. Stephenson, 21 years of age, of the Applegate district were made husband and wife by Rev. D. E. Millard. Shortly after the ceremony the groom returned to his ranch. When Mrs. Stephenson is sufficiently recovered to be out of bed and is able to be moved, which will be in two or three weeks, the couple will make a honeymoon trip to some resort in California where she will remain until the convalescence stage is passed.

Mrs. Stephenson has been ill with typhoid fever for the past six weeks and was brought to the sanitarium from her home in the upper Applegate section last week. Long before she was taken ill she had planned their wedding for May 21st and each was determined that there should be no postponement. Only the parents of the bride and the members of the hospital staff were guests at the wedding. The nurses had the bride's room beautifully decorated for the occasion.

WINNIPEG MAYOR HAS CONTROL OF STRIKE SITUATION

WINNIPEG, Man., May 20.—The central strike committee of organized labor in Winnipeg made public this forenoon in a letter to Mayor Charles F. Gray the terms upon which it will consider a settlement of the general strike. Recognition of all the unions involved and reinstatement of all employees on strike are asked. The announcement does not specifically refer to wages and hours.

Mayor Gray stated later that the basic offer of strike settlement received from the central strike committee was to be considered this afternoon. He indicated that recent developments did not forecast a settlement of the dispute between labor and their employers.

The mayor continued: "Law and order have been maintained. Law and order will be maintained at all costs. If any radical element attempts to interfere with enforcement of law and order, we are prepared to smash it immediately. The mayor is directing city affairs from his office in the city hall and the British flag is flying over the building."

MEMBERS CHILD WELFARE BOARD ARE ANNOUNCED

SALEM, Ore., May 20.—Governor Oleott today announced the appointments to the new child welfare commission provided for by the recent legislature.

The law provides that the president of the University of Oregon shall appoint one member and the president of the State Medical association another, and the governor the remaining three.

The appointee of President Combel of the State University was Dr. DeBusk, member of the faculty of the university and expert in psychology and sociology; the medical association named Dr. Robert G. Hall of Portland. The appointees by the governor were Miss Millie R. Trumbull and Fred Lockley of Portland, and Mrs. Fred G. Schilke of La Grande.

FEDERAL BILL TO EXPEL SLACKERS FROM COUNTRY

WASHINGTON, May 20.—Bills for the expulsion from the United States of aliens who escaped military service withdrawing their applications for citizenship, and defining sedition, were introduced today by Senator Jones, republican, of Washington.

WASHINGTON, May 20.—Investigation of the shipping board, and the Emergency Fleet corporation, with a view to legislation to promote the merchant marine, was proposed in a resolution today by Representative Greene, of Massachusetts, chairman of the merchant marine committee.

Senator Kenyon, republican of Iowa, put in bills to create a federal industrial relations commission.

A bill to change the name of the Panama canal to the "Roosevelt canal" was offered by Senator Calder, republican, of New York. He also proposed measures to repeal the luxury taxes.

WASHINGTON, May 20.—Representative Mondell of Wyoming, republican leader, announced in the house today that the resolution proposing submission of an equal suffrage constitutional amendment would be called up tomorrow for passage. His announcement followed a favorable report on the resolution of Representative Mann of Illinois by the house suffrage committee.

A similar resolution was offered in the senate today by Senator Jones of New Mexico, retiring chairman of the senate woman suffrage committee, and supporters plan to urge quick action.

ALLOWANCES FOR RAILROAD FARE DISCHARGED MEN

WASHINGTON, May 20.—The director of finance having practically completed payment of the \$50.00 bonus, involving about 1,400,000 claims, is now settling additional travel allowance due enlisted men of the army under section 3 of the act approved February 28, 1919, which authorized travel pay to enlisted men honorably discharged since November 11, 1918, at the rate of 5 cents per mile to actual bona fide home or residence, place of original muster into the service, at the option of the soldier.

The comptroller of the treasury by decisions rendered April 17 and May 3, 1919, has authorized the war department to make settlement of all claims for the 1 1/2 cent difference from place of discharge to place of entry into the military service, also the claims for additional allowance to actual bona fide home or residence at date of discharge when such bona fide home or residence can be determined from the affidavit of the soldier and verified by information contained in his original service record. The zone finance officer, Washington, D. C., has been designated to settle these claims with the above restrictions. Applications should be addressed as follows: Zone Finance Officer, Lemon Building, Travel Allowance, Washington, D. C.

A blank form of application, which includes the necessary affidavit for the additional travel allowance, may be obtained from any army recruiting officer, Red Cross, or other agencies organized to aid soldiers. This affidavit must be accompanied by a true copy of soldier's discharge certificate, certified as such by a recruiting officer, or the original discharge certificate, the latter to be returned with check. While payment will be made on the original discharge certificate, claimants are advised that the use of the copy will eliminate the possibility of the loss of the original. No further correspondence is necessary except in case of change in address.
