GOOD CITIZENSHIP AND THE TREATY.

WE are indebted to that excellent periodical, the Oregon Voter, for the following:

What are the chief obstacles to good citizenship? Viscount Bryce, former British ambassador to the United States, says there are three of them—Indolence, selfish personal interest and party spirit.

The first, he says, is the most common, the second the most noxious and the third the most excusable yet also the most subtle. The destructive force of the last two is effectively demonstrated in the present peace treaty situation.

If selfish personal interest and party spirit had been eliminated the peace treaty would have been ratified six months ago. Nor has the fault been all on one side. We are in receipt of a letter from a member of the New York state assembly, a republican, but a great admirer of President Wilson and a man of unusually keen insight, of which the following is an extract:

"You ask about Lodge and the Peace Treaty. It would take a five day journey to express my feeling of national humiliation and disgust with all the leaders on both sides. Intolerance, partisanship, ignorance, selfishness and insincerity or worse have been the controlling forces. The appeals to patriotism have been shallow and narrow. The republicans may be divided into three classes (1) Those who sincerely desire the League of Nations with modifications enough to protect some of our traditional doctrines; (2) those who are thoroughly opposed to any League of Nations (Borah, Johnson, Knox, Sherman and half a dozen others) and (3) those who are really indifferent to the issue and consider party advantage the main object. These last are led by Lodge, who seems to have forfeited all claim to statesmanship and shown himself merely a scholarly politician."

"The democrats so far have only developed two types (1) the few bold anti-leaguers like Reed, Thomas and Walsh and (2) those who surrender their independence to the president's orders.

"There is a hope that some independent pro-leaguers will develop,—perhaps Underwood will be one. Of course the chief object of Lodge has been to put the president and the democrats in the hole, and in this he has succeeded, in part by his own skill and in part by the thorough incompetence of the democrats, who allowed it to happen. The Knox-Borah group of course have stood by Lodge in this game, though they would not stand by him (I don't think he tried to make them) in voting for the treaty with reservations.

"The democrats have missed a chance to drive right through the division point in the republican ranks, and so far they have weakly allowed the republicans to define the issue as Americanism, on which the republicans can appear to stand together, instead of making it the treaty on which the republicans are hopelessly divided.

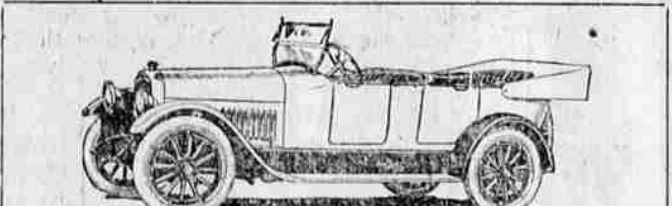
"The chief villain in the play however is the president, who is most to be blamed because he has assumed to take the highest moral ground, and who has been alienating support from the League of Nations by his self sufficiency and by his amazing arguments. He has been inconsistent, illogical, disingenuous as well as intolerant. Whether it is his temporary state of health or his permanent twist of mind,—I don't know but I call him now the actual worst enemy of the League covenant."

There is nothing indolent, selfish or partisan about the writer. Right or wrong, he comes under Viscount Bryce's definition of good citizenship.
