ASHLAND CLUB TO ELECT A NEW SET OF OFFICERS

ASHLAND, April 30.—"The old officers and trustees have agreed to resign." This refers to the commercial club, but it does not imply by any means whatever that it is going out of business. This action will be taken in line with a pledge made during the late membership drive, and is preliminary to the election of a new deal throughout if the membership so desire. In outlining the next step in the expansion movement it is planned to allow a new board, if a change is made in its entirety, absolute freedom as to action, untrammelled by prejudice or precedent in dealing with new problems as they arise. Like the British cabinet, when circumstances indicate a change desired, the board will resign, and let their successors take up the work of formulating a program which will reflect the expression of the citizens direct. The membership fee is to be left as heretofore, one dollar per month, the collection to be at least in quarterly installments to facilitate handling the financial situation to best advantage. This week both membership and budget teams are engaged in the "cleaning up" process not only securing quotas in full, but far exceeding original estimates.

Intimate friends here realized her serious condition months ago, yet hoped to hear of an improvement due to change of scene and climate. 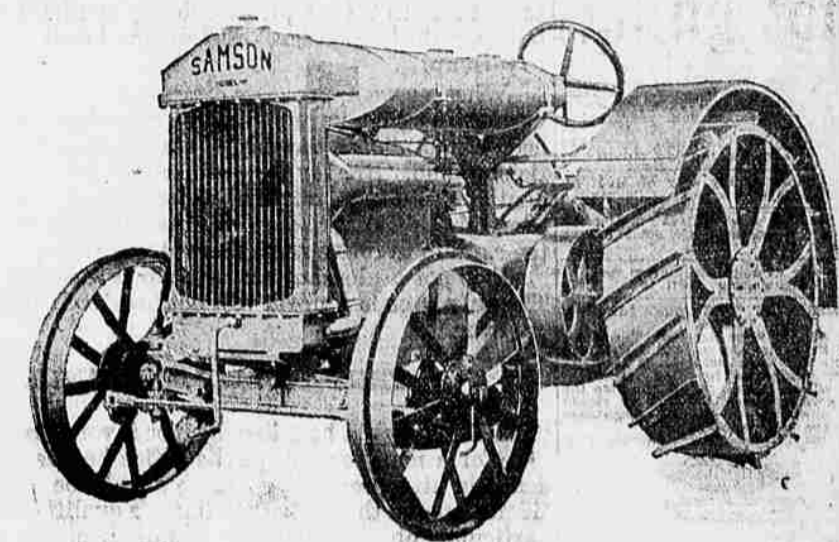
