

FAIL TO PASS RESOLUTION OVER VETO

HOUSE FAILS TO OVERRIDE WILSON VETO

Twenty-nine Less Than Required Two-thirds Majority Secured on Motion to Pass Peace Resolution Over President's Veto—Wilson Gives Endorsement to Democratic Platform Adopted in Virginia Opposing the Lodge Reservations.

WASHINGTON, May 28.—An effort to override President Wilson's veto of the republican peace resolution failed today in the house. The vote was 219 in favor of overriding the veto, to 152 against, or 29 less than the required two-thirds majority.

Two republicans, Representatives Kelly of Michigan and Fuller of Massachusetts, voted to sustain the president's veto while seventeen democrats joined the republican majority in an effort to override it.

WASHINGTON, May 28.—The platform adopted by Virginia democrats last week was endorsed today by President Wilson as "in full accord with my own views, especially the statement which sets forth the attitude of the party on the League of Nations and the pressing problems of peace, finance and reconstruction."

WASHINGTON, May 28.—Repeal of all war time legislation was proposed today in a joint resolution introduced by Representative Connally, democrat, Texas. The repeal would be effective on final passage of the resolution.

STRIKER'S RIOT R. I. MILL, 2 WOUNDED

BRISTOL, R. I., May 28.—Two strike sympathizers were wounded with pistol shots and three factory guards injured with stones during a riot today outside the plant of the National India Rubber company. The trouble started with the arrival of women clerks and other employees whose work had not been stopped by a strike. Women among the strike sympathizers pulled the stenographers' hair and several of the latter were roughly handled.

FRENCH WOMEN SEND MEMORIAL DAY MESSAGE OF SYMPATHY TO U. S. SISTERS

WATER POWER BILL UP TO PRESIDENT AFTER LONG FIGHT

WASHINGTON, May 28.—The conference report on the long-pending water power bill was approved today by the senate and the measure now goes to the president. The vote was 45 to 21.

The bill which is designed to bring about development of the water power resources of the nation under direction of a federal commission, has been before congress in one form or another for twelve years. Last session both houses passed a similar measure, but failure of the senate to adopt the conference report, prevented final passage.

MORE PROFITEERS SUGAR INDICTED

NEW YORK, May 28.—Several indictments charging profiteering in sugar were returned in federal court here today. One indictment charged the Economy Wholesale Grocers company and Abraham Gladstone of Chicago with having sold in New York on May 1, 59,000 pounds at 24 cents. They are alleged to have bought the sugar for 15 1/2 cents.

PUT N. Y. HAIR CUTS DOWN TO 35 CENTS

NEW YORK, May 28.—Prices of shaves and hair cuts in New York will be cut to 15 and 35 cents, respectively, according to Leon cut-hairer Yoknein ssande taing Worthal, general organizer of the International Barber's union. New barber shops, he said, will be opened by the barbers union or individual union members.

RED ARMY ADVANCING UPON KIEV

Bolsheviki Force Back Poles to Second Line of Defense on Extended Front—Armistice With Japanese in Siberia—Armenians Crush Bolshevik Uprising—Lloyd George to Meet Emissaries From Soviet Government.

LONDON, May 28.—The bolsheviki are advancing in the Kiev region and are engaged in fighting on the second fortified line of the Poles northeast of that city, it is announced in Thursday's official statement by the soviet government, received by wireless from Moscow today.

The statement says the fighting line runs ten miles north of Brovart village. This village lies about ten miles directly east of Kiev.

LONDON, May 28.—Hostilities between the Russians and Japanese in Siberia ceased May 25, according to a Reuter dispatch from Vladivostok dated Wednesday. The dispatch also reports the arrival of the Russo-Japanese armistice commission at Khabarovsk.

ARMENIANS ACTIVE CONSTANTINOPLE, May 25.—(By the Associated Press)—Armenians have crushed the bolshevik uprising against their government in Erivan, and a loyal Armenian army now is in control of Alexandropol, according to a message received from the Armenian capital by M. Pekzatian, Armenian diplomatic representative at Tiflis. General Khachadorian, an Armenian commander, who recently revolted and who was in charge of an armored train which made bolshevik control of Alexandropol possible, was killed during the fighting.

ANGORA, Asia Minor, May 18.—(By the Associated Press)—Protests against alleged mistreatment by M. Tardieu, French governor of the province of Adana, and Armenians associated with the French in that district since French occupation forces moved in last March have been received from Moslems there by Mustafa Kemal Pasha, leader of Turkish nationalists here.

A long list of atrocities the Turks are said to have suffered, especially at Kozan, accompanied the protests.

PARIS, May 28.—French governmental authorities have been in constant touch with Adana and declared this morning that no disorders had been reported.

LLOYD GEORGE MEETS REDS LONDON, May 28.—Premier Lloyd George will meet Gregory Krassin, Russian bolshevik minister of trade and commerce this week, says "The Times," which also mentions a rumor "circulated through channels notoriously in touch with the premier's entourage," that both the subject of negotiations and the persons engaged in them "would be more widely extended than at present acknowledged."

M. Krassin will propose says the newspaper to put notes of Russian gold stamped with the seal of the old Russian government on the English market. The Times adds:

"By receiving Russian gold, stolen by the soviet, we would be virtually recognizing the soviet government. It is impossible to disassociate the two ideas of trade relations and official recognition."

HENRY SCHULDERMAN KICKED OUT; PLACE IS GIVEN TOM HANDLEY



SALEM, Ore., May 28.—Henry J. Schulerman has been removed from the office of state corporation commissioner by Governor Olcott. The governor has appointed State Senator T. M. Handley of Tillamook in Schulerman's place.

Announcement that he had asked Schulerman to resign was made by Governor Olcott last night, and the change dates from yesterday. Alleged opposition to the administration on the part of Schulerman is the cause of Schulerman's removal from office, the governor announced.

Mr. Schulerman was first appointed corporation commissioner by Governor Withycombe in May, 1915 and was re-appointed in December, 1916. His present term would have expired January 1, 1921.

Mr. Handley has served two terms in the lower house of the legislature, one regular term in the state senate and was a member of the senate at the special session last January.

LIFE TERMER AT FOLSOM ESCAPES HAIL OF BULLETS

SACRAMENTO, Cal., May 28.—Deputies from the sheriff's office in Sacramento joined prison guards today in the search for Carl Otto, a life term prisoner who escaped from Folsom yesterday when he overpowered the engineer of a switch engine and smashed thru the prison gate. Otto was sentenced from San Francisco for burglary.

J. Quijada and George Clifford made the dash with Otto but were at once recaptured by guards. Otto gained the underbrush under fire of guards from the prison walls, but was seen to stumble just before he disappeared from view. In 1917 Otto escaped from San Quentin prison.

When the prisoners reached the open yesterday they set ablaze the contents of an oil tank and set fire to the underbrush to create a smoke screen that would shield them from the guards' fire as they made the final dash.

\$5,000,000 CHEST FOR MR. M'ADOO

Hearst Reporter Tells Campaign Investigation Committee McAdoo Has Been Underwritten for Gigantic Sum—Refuses to Give Source of Information—Harding Papers in Ohio Went to Wood When Wood Ads Came In.

WASHINGTON, D. C., May 28.—(By Associated Press). Harry M. Daugherty, campaign manager for Senator Harding, republican, of Ohio, was recalled today before the senate investigating committee. The witness said two Ohio newspapers, the State Journal and the Columbus Dispatch, had supported Senator Harding at first, but later had supported General Wood. Senator Reed sought an explanation.

"I would be willing to go this far," Mr. Daugherty said. "There was a very active campaign made around Columbus for General Wood."

"It is true that very large expenditures were made on advertising in that Ohio campaign?" Senator Reed continued.

"There were expenditures of that kind—too expensive for us, and I didn't go into it," Mr. Daugherty replied.

5 Million for McAdoo Louis J. Lang, a reporter of the New York American, identified himself as the writer of an article purporting to tell of a \$5,000,000 underwriting for a fund to back a campaign to bring about McAdoo's nomination at San Francisco.

He refused to disclose the source of his information.

"A member of the democratic national committee was with my informant when I was told the story," Mr. Lang said.

Chairman Kenyon announced that several democratic national committees had been subpoenaed to appear during the investigation.

Mr. Lang discussed a meeting of the democratic national executive committee at Atlantic City last September. He said that plans were made to raise \$10,000,000 for a democratic national campaign. Thomas F. Chadbourne and B. M. Baruch were at Atlantic City at the time, he said.

Mr. Lang testified that he had been informed that a member of the national committee had stated that Frederick A. Wallace, a deputy police commissioner of New York was representing Mr. Baruch in collecting finances for the McAdoo campaign and that the \$10,000,000 financing as planned at Atlantic City contemplated Mr. McAdoo's nomination by the democratic convention.

"Members of the national committee," Lang said, "had corroborated the story later."

The Invisible McAdoo WASHINGTON, May 28.—The senate campaign investigating committee made further efforts today to get light on what Chairman Kenyon described as "this invisible McAdoo boom."

Angus W. McLean of North Carolina, a director of the war finance corporation was examined. He denied that he was "a sort of southern manager" for Mr. McAdoo's campaign and attempted to read a prepared statement.

M'NARY SUGAR BILL FAVORABLY REPORTED BY SENATE COMMITTEE

WASHINGTON, May 28.—By a vote of 6 to 3, the senate agriculture committee today ordered a favorable report on the McNary bill providing for an export embargo on sugar.

Those supporting the bill were Senators McNary, of Oregon, Capper of Kansas, Kenyon, Iowa and Norris, Nebraska, republicans, and Harrison, Mississippi and Kendrick, Wyoming, democrats. Senators Smith of Georgia, Smith of South Carolina and Randall of Louisiana, democrats, opposed it.

Before taking final action the committee amended the measure so that it would not except sugar sent to the United States by foreign countries or their nationals to be refined. Early senate consideration of the bill is planned by Senator McNary.

TURKISH TREATY IS MORE SEVERE THAN REPORTED

WASHINGTON, May 28.—Terms of peace imposed upon the Turks, more rigorous than any previous summaries have indicated were revealed to the Greek chamber of deputies last week in Athens by Premier Venizelos, a summary of whose address was received today by the state department.

"The Turkish treaty," according to Venizelos, "accords to Turkey only local autonomy, which may in due time, and should the people so determine, be converted into independence."

In the small southeastern area of Europe in which Turkey is left a foothold, Venizelos declared, her forces are limited by the treaty to 700 men.

Constantinople is retained by the sultan, the Greek premier explained, with the reservation that "he will not violate the conditions of the peace treaty."

The Turkish army is limited to a militia of 35,000 men to be organized by Europeans, 15 per cent of officers of which must be foreigners. Distribution of the militia shall be dependent upon the advice and decision of the inter-allied commission.

H. L. PITTOCK WILL DECLARED VALID

PORTLAND, Ore., May 28.—The will of the late Henry L. Pittock, publisher of the Portland Oregonian, contest of which by a daughter was made in the circuit court here this week, today was declared valid by Circuit Court Judge George W. Tazewell. The instrument disposed of an estate appraised at \$8,000,000. Undue influence on the part of executors was alleged by Pittock's daughter, Mrs. Caroline Leadbetter.

NEW YORK CLOTHING HOUSE FINED \$31,000 FOR PROFITEERING ON SUITS

SYRACUSE, N. Y., May 28.—The sale of another suit for \$45, the cost price being fixed at \$23.50. The sale of a suit costing \$17.82 for \$45. The sale of a suit of clothes for \$29.50, the cost price of the suit having been \$11.75. The sale of a suit costing \$23.25 to a millionaire for \$60. The fine, as imposed by Judge Manton, is the largest that has been passed in the United States following a conviction for profiteering.

GARY SAYS CAPITAL IS TOO TIMID

U. S. Steel Chairman Tells Steel Institute That American Employers Too Backward in Proclaiming Their Rights and Insisting Upon Proper Consideration—Agitators Are the Worst Profiteers—Stir Up Trouble to Benefit Themselves.

NEW YORK, May 28.—Employers in America—referred to as the capitalistic group—heretofore have been backward in proclaiming their rights and insisting upon proper consideration, Elbert H. Gary, chairman of the United States Steel corporation, declared here today in opening the annual meeting of the American Iron and Steel institute.

"The present so-called labor strikes involving riot and injury to property and person, are instigated as a part of the campaign to disturb and demoralize the social and economic conditions of the country," said Mr. Gary.

Mr. Gary deprecated class legislation. In America, he said, those who are seeking to establish classes are composed of a comparatively small minority of the population who have adopted the word "labor" with the concealed design of forming a class which they hope finally will attract a majority of the people and thus enable them to obtain legislation which would ultimately destroy the constitution.

"Agitators who are trying to create trouble between employes and their employers," he said, "as a rule are insincere and selfish. * * * Their business is better * * * when others are in trouble. They promise reforms, but their methods lead to trouble and loss to others. In this list are included a few writers, lecturers, public speakers and self-appointed labor leaders, so-called."

IRISH RESOLUTION IS REPORTED OUT

WASHINGTON, May 28.—A resolution "viewing with grave concern" conditions in Ireland and "expressing sympathy with the aspirations of the Irish people for a government of their own choice," was reported out today by the house foreign affairs committee. The vote was 11 to 7.

The resolution was offered by Representative Mason, republican, Illinois as a substitute for his resolution proposing virtual recognition of the provisional Irish republic. Its adoption ended a long and bitter fight in the committee.

Gompers Allen Debate. NEW YORK, May 28.—Samuel Gompers and Governor Henry J. Allen of Kansas will debate here tonight on the merits of the recently enacted Kansas industrial court law. No official decision will be made. Judge Alton B. Parker will preside.
