

### DEATH CLAIMS C. F. BURKE, WELL KNOWN CITIZEN

Clarence Frederick Burke, one of the best known and most highly respected young men of Medford, passed away at the home of his parents, Mr. and Mrs. Fred Burke, No. 233 South Riverside, Sunday, June 6, at 6:20 a. m., from a nervous breakdown brought on by a too close application to work and study, from which he had been suffering for some time. He was 29 years old. Mr. Burke had been employed at the West Side drug store for a number of years prior to the world war, and quit this employment to enlist in the Naval Reserve, March 24, 1917, before the United States had entered the war. He served during the war, much of this time at sea on a mine sweeper winning two promotions. He was mustered out of service as a chief pharmacist's mate on June 25, 1919, since which time he had been employed at a Klamath Falls drug store until recently when he came home to resume his former position with the West Side pharmacy. But his last illness coming on, prevented his assuming this position.

A peculiar feature of Mr. Burke's death was that he died on the same day and at the same hour on which he was born. His birthplace was Cortland, New York, and he came to this city with his parents when a young boy. He was a graduate of the Ashland normal school, and was a charter member of the Medford lodge of Elks. He is survived by his parents and sister, Miss Ruby Burke, who also served during the war in the Naval Reserve, and now holds a civil position at Seattle.

Public funeral services will be held at the Elks temple at 1 p. m. Wednesday to which the Elks and their friends are invited. At 4 p. m. that day private services will be held at the family home, from which the body will be escorted to the cemetery by the Elks where the Elks burial ritual will be observed.

### WOMEN DEMOCRATS ATTEND CONVENTION

NEW YORK, June 7.—Led by Mrs. John Sherwin Crosby, called "The Mother of New York Women Democrats," a special train carrying 54 women delegates and alternates to the National Democratic convention in San Francisco, will depart from New York, June 19. This will be the first expedition of its kind in the United States. Many of the women will be accompanied by their husbands, children or other relatives. The party will be augmented by delegates from other states at various points en route to Chicago and, after the convention, the members will visit Pike's Peak, Colorado Springs, and the Grand Canyon of the Colorado, Riverside, Hollywood and Los Angeles and the Catalina Islands. The return home will be by way of the Canadian Rockies, reaching New York on the evening of July 11.

The delegates-at-large from New York are Elizabeth Barbury and Harriet May Mills and the alternate-at-large are Mrs. Maurice Connolly, of Corona, L. I., and Mrs. Nellie Hewitt, of Carthage, N. Y.

### OPEN ROAD TO CRATER LK. FOR SHRINER HOST

Indications are that by the 25th of this month one will be able to reach Crater Lake by only having to walk three-fourths of a mile or less. Everything will be done to open up the snow drifts and clear the road to the lake, as far as possible, in order to accommodate the many Shriners from all parts of the country returning from the Shrine convention at Portland who desire to visit this world wonder.

Superintendent Sparrow of Crater National Park with a small force of men and teams expects to leave tomorrow to clear the road from White Horse creek, which is three or four miles within the park and eight miles from the lake. His party will be joined at Prospect by James Grieve and his teams and force of men, and together the two parties will break the road from White Horse to Anna Springs camp or park headquarters, and south on the Klamath side, on which Mr. Grieve has the contract for constructing several miles of road.

C. J. Seymour, United States highway engineer, was able to drive his auto through the latter part of last week from Prospect to White Horse Creek without trouble, encountering only several small snow drifts. But there is more snow and his drifts between White Horse and Anna Springs camp, and between the camp and the lake there are huge drifts of snow. But Superintendent Sparrow, while he promises nothing, hopes to have the road open to within three-quarters of a mile of the lake by June 25, from which visitors can easily walk that distance to the lake.

E. C. Faber recently purchased from the Woods heirs, the store room on the west side of his store, and is now sole proprietor and owner of the entire building which he has long occupied.

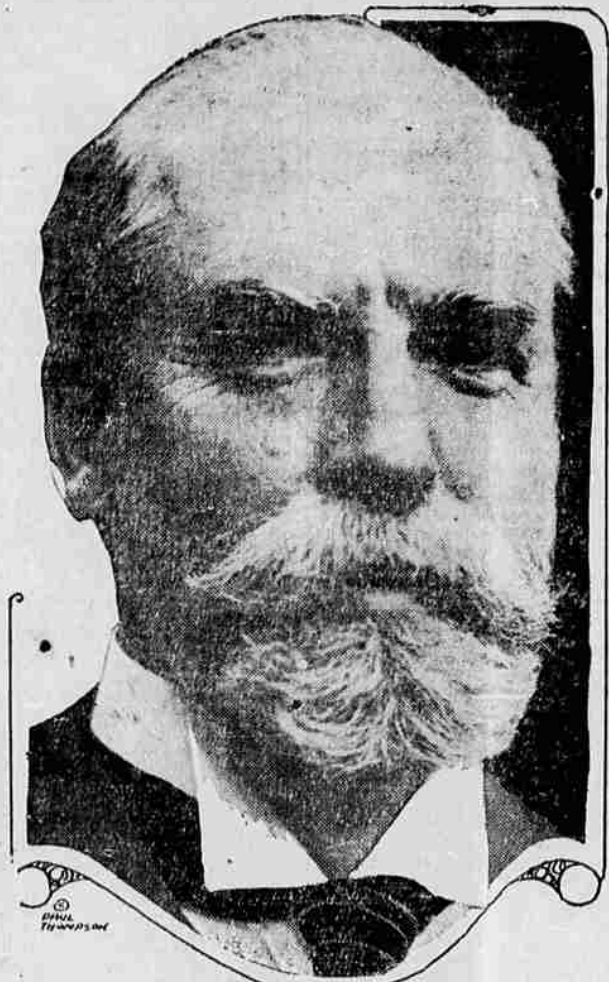

### CAROLINA WILL IGNORE VOTE. STATE PRIMARY

CHICAGO, June 7.—National Committeeman Morehead of North Carolina today denounced the state primary there as "a farce" and declared that any agreement among the candidates as to its significance would have no binding effect on the delegates. He declared that the complete returns of the primary could not be available before June 19.

The New York delegation organized today and elected Senator Wadsworth chairman, Charles D. Hilles was chosen national committeeman, succeeding Herbert Parsons.

The entire program of the leaders was carried through without a sign of friction, although an overnight change of plans regarding committee membership caused some comment. Senator Calder, who it was stated yesterday had been picked for membership on the committee on permanent organization and was not mentioned today and the place was given to William Barnes, former national committeeman.

No explanation of the change was made by the leaders, but it was recalled that Senator Calder's hostility to an official of the republican state administration—Comptroller Eugene M. Travers, culminated last week in a full page newspaper attack charging the comptroller with official incompetency. Copies of the paper containing the charges were placed in every seat of the special train that brought the delegation to Chicago.

### RELIEVES HOUSE SHORTAGE; SUPPLIES HOUSES BY TRUCK

The ship-by-truck idea has been employed recently in many novel undertakings, but it remained for Lawrence Stewart of Wichita, Kans., to requisition it in its most unusual form. Stewart jacked up a three-room house at Towanda, placed a couple of pairs of wheels under it, hitched on a motor truck, and after the outfit had made a short trip over country roads, Wichita, where a house shortage exists, was one house the richer. The venture was so successful that Stewart says he will give another house the same journey.

### Pioneer House Burns.

COTTONWOOD, Cal., June 7.—A house built in 1846, declared to have been the oldest dwelling in Shasta county, was destroyed recently by fire. It formerly was ranch headquarters for one of the early day Spanish grants extending from the present site of Redding to Cottonwood.

### Yellowstone Season Opens.

MISSOULA, Mont., June 7.—The tourist season is getting well under way, according to indications here. During the first week after the opening of the local offices of the bureau of the Yellowstone trail, 41 cars, carrying a total of 120 passengers, were registered.

### Rabbi Wise to Lecture.

MOSCOW, Idaho, June 7.—Rabbi Stephen S. Wise of New York, will deliver two addresses before the University of Idaho summer session which opens here June 14, according to announcement by Dean J. G. Eldridge, summer session director.

### BELGE CAPITAL GAY AND FREE, MONEY TO BURN

ANTWERP, June 7.—The cafes of Antwerp, where American "jazz" music resounds nightly until the early morning hours and champagne corks pop continuously at 50 to 100 francs a pop, are so crowded even now with tourists, sailors in for a shore celebration, and local spendthrifts that their proprietors wonder what more can happen when Antwerp is crowded with visitors to the Olympic games.

There are no spirits sold—except surreptitiously—but the wine flows so continuously in the gilded cabarets, and the beer so continuously in the sailors "estaminets" down near the docks, that the noise and dancing know no bounds.

Some of the dock saloons have been especially rechristened since Antwerp became the chief American port on the continent, to catch the trade of the American sailor and make them feel as if they were down by the docks at home in the anti-prohibition days.

One finds American sailors reaching out their unpracticed feet for the bar rails in "Dirty Dick's Place," or "Sailor Jim's" down by the docks, consuming large schooners of beer that look like the pictures on the frosted windows of "the biggest beer in town."

There are just as many merchant sailors in the expensive cafes, spending freely and dancing hard.

American consular and other Antwerp authorities are awake to the necessity of establishing some kind of recreation halls for the merchant sailor here, to take the place of the cafes, but, they told the correspondent, there seems as yet no way of doing it.

"Big recreation halls, with plenty of music and light beer would serve the purpose splendidly," one consular official said. "Jack is bound to spend his money when ashore."

### SUIT OVER SEWARD SITE DISMISSED

SAN FRANCISCO, June 7.—A judgment of the United States district court of Alaska by which J. E. Bellaine was given \$30,000 damages against W. J. Boland, W. A. Staver and F. C. Jemmett for alleged malicious prosecution of a title suit over land comprising the town-site of Seward was revised today by the United States circuit court of appeals. The higher court held at Ballaine's testimony that the value of his property declined 50 per cent as a result of the title suit brought against him in the name of the Alaska Northern Railway company was speculative and that he must establish actual damages.

### Wolves Raid Cattle.

BELT, Mont., June 7.—John Beale's ranchman of this section, reports the loss of 16 head of stock by wolves, 12 of cattle and four horses. The ravages of the wolves continued late into the spring.

### BEN HILL FLED MEXICO CITY IN A MILK WAGON

MEXICO CITY, June 7.—One of the exciting incidents preceding the revolt against President Carranza was the escape of General Benjamin Hill, chief lieutenant of General Alvaro Obregon, who fled from the capital hidden in a pile of sacks in a milk wagon.

General Hill vanished from the capital on the same night as did General Obregon April 13. The wagon in which Hill was hidden was stopped by the police in the suburbs of the capital because it did not carry a light. While the driver was bribing the policeman to pass the lightless vehicle, General Hill dropped out of the back of the wagon and hid in the shadow of a building until the policeman was mollified. Then the general crawled back into the wagon and continued his flight.

Mystery surrounding the fate of Roberto Cejudo, to testify in whose trial General Obregon was summoned to the capital, furnished one of the tragic high lights of the Carranza evacuation. With General Arnulfo Gonzales, captured by Carranza government agents near Nuevo Laredo on April 30, and the aged rebel General Gaudencio de la Llave, Cejudo was taken from the military prison of Santiago Tlatelolco here the night of May 6 when the Carranza adherents fled. Whether he was taken on the Carranza trains the next day and escaped, or whether he was executed, together with the two others, remains a mystery. None of them have been located altho several other generals, arrested prior to the evacuation, have returned to Mexico City.

Cejudo was arrested, with his staff and 150 followers, at Jalapa, V. C., on March 28, after he had surrendered, received amnesty, been given the rank of general in the Mexican army and placed in command of a district near Jalapa, where previously he had led a revolt against the Carranza government for six years. He was charged with surrendering merely to secure arms and munitions with which to aid Felix Diaz.

The Carranza government charged that he had offered to aid Obregon but Obregon, in an interview given the Associated Press, branded the Cejudo charges as a scheme to bring him to Mexico City, involve him in charges of treason and block his campaign for the presidency.

### DRY LAW HELD VALID.

same as other provisions of that instrument.

"6. The first section of the amendment—the one embodying the prohibition—is operative throughout the entire territorial limits of the United States, binds all legislative bodies, courts, public officers and individuals within those limits and of its own force invalidates any legislative act—whether by congress, by a state legislature, or by a territorial assembly—which authorizes or sanctions what the section prohibits.

"7. The second section of the amendment—the one declaring 'the congress and the several states shall have concurrent power to enforce this article by appropriate legislation'—does not enable congress or the several states to defeat or thwart the prohibition, but only to enforce it by appropriate means.

"8. The words 'concurrent power' in this section do not mean joint power or require that legislation thereunder by congress be effective, shall be approved or sanctioned by the several states or any of them; nor do they mean that the power to enforce is divided between congress and the several states 'along the lines which separate or distinguish foreign and interstate commerce from intrastate affairs.

"9. The power conferred to congress by that section, while not exclusive, is territorially co-extensive with the prohibition of the first section, embraces manufacture and other intra-state transactions as well as importation, exportation and interstate traffic, and is in nowise dependent on or affected by action or inaction on the part of the several states or any of them.

"10. The power may be exerted against the disposal for beverage purposes of liquor manufactured before the amendment became effective, just as it may be against subsequent manufacture for those purposes. In either case, it is a constitutional mandate or prohibition that is being enforced.

"11. While recognizing that there are limits beyond which congress cannot go in treating beverages as within its power of enforcement, we think those limits are not transcended by the provision of the Volstead act, wherein liquors containing as much as one half of one per cent of alcohol by volume and fit for use for beverage purposes are treated as within that power. Jacob Ruppert vs. Caffey, 251 U. S., 264."

CHICAGO, June 7.—Levy Meyer of Chicago, who argued the case for the distillers in the supreme court, said on hearing of the decision: "I advanced every possible legal argument. The avenue of the courts is now exhausted."

### 800 FINE STEERS STAMPEDE, FOOD FOR THE SHARKS

HAVANA, June 7.—Virtually all of 800 fine steers aboard the American steamer St. Charles were drowned and devoured by sharks which infest the waters off Morro Castle, when the animals stampeded and plunged overboard Saturday afternoon. A comparative few swam ashore and are now wandering about the suburbs.

When sanitary officers boarded the ship on her arrival they found bodies of 130 dead steers on the vessel. They ordered the ship to put to sea and discharge the carcasses. While the crew was engaged in this onerous task the animals became stampeded. They rushed up and down the decks and plunged into the sea where the tigers of the deep awaited them. Four were seen to strike the water almost simultaneously, and in an instant they were dragged beneath the surface, only a trail of blood telling their fate.

The crew of the St. Charles is in terror, and harbor authorities are having difficulty in obtaining men to enter the hold and remove the remainder of the cargo. Only fifty carcasses had been thrown overboard when the stampede occurred.

### RAIN BLESSING ON OREGON CROPS

PORTLAND, Ore., June 7.—Copious showers throughout the Willamette valley Sunday and early today have given assurance of bountiful crops, according to the weather bureau here. The downpour, which began falling early Sunday morning, continued during the day and night, the precipitation in Portland for the 24 hours ending at 5 a. m. today being .66 inches.

The precipitation was general through the entire Willamette valley and coast range districts.
