

DELAYED REPORTS REVEAL HEAVY LOSS FROM BLOW

PORT TOWNSEND, Wash., Feb. 8.—Additional details of the storm of last week, which inflicted several million dollars damage to the west slope of the Olympic peninsula in Jefferson and Clallam counties, reached here today.

The Lacey Lumber company estimated that standing timber worth \$2,000,000 was uprooted on its extensive holdings. However, a large part of this was lost. One report was that one-third of the timber on the west slope in Clallam county was torn down by the wind, which settlers described as the worst they have ever experienced.

Twenty-six houses in one farming community in Clallam county were blown down, and sixteen Indian cabins at LaPush were demolished. Many heads of cattle were killed, but the loss in this regard cannot be estimated.

There were no casualties so far as known, but fears are expressed for the safety of the family of D. Brandenberg, a settler living 25 miles southeast of Forks. There are five children in the family. None of them had been located.

Hundreds of elk are said to have been killed, settlers reporting that nearly all of one herd of 200 were slain by falling trees.

It was said here today on the word of a settler that early estimates of \$10,000,000 property loss will probably be substantiated when a full list of the losses is tabulated.

The area that was devastated is one of the most isolated parts of the nation. Communication is possible only over a single highway extending from Port Townsend to Mora, on the Pacific coast. This highway was entirely blocked by the storm; so that settlers coming here for aid were five days in hewing their way.

A party which was sent out from here with food and clothing for the 100 families made homeless and destitute by the hurricane. They were equipped to cut their way through the fallen debris. It will be at least three days, it is estimated, before they can reach the storm swept area.

The timber which was uprooted is among the best in the northwest. Some of it is owned by private individuals and companies and part of it is the property of the state of Washington and of the federal government. Narrow creeks were reported for fifty loggers employed at the Erickson camp. Trees came tumbling down upon their bunk cars in the height of the storm. Several men were painfully injured.

"It looked like the path of a Kansas cyclone," Leroy Smith, one of the two settlers who reached here last night, said. "It was the hardest storm I ever saw."

Because wires are all down the real facts of the disaster are not known. Damage to the Indian fishing villages along the coast is problematical.
