

SHERIFF NOT ON C. H. OWEN'S BOND, PHONE TO BLAME

Due to a misunderstanding over the telephone with the county clerk's office at Jacksonville Monday noon by which it was understood that Sheriff Terrill had gone on C. H. Owen's \$5000 bond, this newspaper erroneously published this fact.

Mr. Owen has not yet secured bond, but that document it is announced will be forthcoming by Wednesday. By law the sheriff of a county could not go on the bail of an accused person even though he so desired. Sheriff Terrill announces that he has had Owen in his custody since Saturday. The sheriff makes the following explanation as to the situation:

"When Judge Calkins lowered Owen's bail Saturday from \$25,000 to

\$5000 he placed Owen under my surveillance in order to allow him ample time to get a surety bond, deeming it only fair to do this inasmuch as several local men when they were arrested on similar charges to that against Owen, had been allowed to go under their own recognizance. The law forbids me to go on any prisoner's or accused person's bond.

"I have had Owen under surveillance all the time since Saturday, either personally or through a deputy, at the Hotel Medford and elsewhere, and I stand responsible for his safe custody. Owen does not want to get away. He is anxious to stay here and fight the charge against him.

"His attitude ever since his arrest at Salt Lake City has been to get back to Medford as soon as possible to establish his innocence of the charge. In Salt Lake City he at once volunteered to waive extradition papers and even offered to pay his own railroad fare and that of an officer if he be allowed to hurry back to Medford at once."

The message from Jacksonville was taken by a reporter for the Tribune and was then corroborated over the phone by an employe in the Tribune office. But both apparently mistook "call the sheriff" for "by the sheriff."

PARKHURST TO MAKE 5-MONTH SEASON AT LAKE

Great things are ahead for the tourists and other visitors at Crater Lake this season according to an interview with Alfred Parkhurst in the Roseburg News Review published in that paper yesterday.

"Mr. Alfred Parkhurst, manager of the hotel and transportation system for Crater Lake National park, with his son, Asa L. Parkhurst, were the guests at the Hotel Umpqua Saturday, enroute from Medford to Portland. Mr. Parkhurst announces that E. E. Larrimore, one of the best hotel men on the coast will be manager of Crater Lake Lodge this season.

"The accommodations at the rim of Crater Lake for 1921 will be three times as extensive as those used in the 1920 season, and will consist of fifty tent houses, six eight-room cottages, a comfort station with baths and hot and cold running water. The indications are that the tourist travel to Crater Lake will be heavier than in any previous year and Mr. Parkhurst is making plans to meet the situation fully and satisfactorily.

"A hotel with a store and automobile service station, is to be established at Rogue River Gorge twenty miles below Crater Lake. This station as soon as it is in operation will enable tourists to reach Crater Lake over the snow as early as May first and "winter sports in summer" will be the feature of the early part of the season, making Crater Lake a five month season, instead of the present three months under the present system.

"Mr. Parkhurst reports the roads in excellent condition from Medford north and the travel is unusually heavy for this time of year. There is still 12 feet of snow at the rim of Crater Lake, and the season will open this year as usual on July first."

HARDING DETAILS POLICY

and I know in my own heart there is none who would wish to embarrass the executive in the performance of his duty when we are all so eager to turn disappointment and delay into gratifying accomplishment. * * *

"The weariness at home and the disappointment to the world would have been compensated in the proof that this republic will surrender none of the heritage of nationality but our rights in international relationship have to be asserted; they require establishment in compacts of amity; our part in readjustment and restoration cannot be ignored and must be defined.

"With the super-governing league definitely rejected and with the world so informed, and with the status of peace proclaimed at home, we may proceed to negotiate the covenanted relationships so essential to the recognition of the rights of our own nation and play our full part in joining the peoples of the world in pursuit of peace once more. Our obligations in effecting European tranquility, because of war's involvements, are not less impelling than our part in the war itself. This restoration must be wrought before the human procession can go onward again. We can be helpful because we are moved by no hatreds and harbor no fears. Helpfulness does not mean entanglements and participation in economic adjustments does not mean sponsorship for treaty commitments which do not concern us and in which we will have no part.

Cooperate with Powers

"In an all-impelling wish to do the most and the best for our own republic and maintain its high place among nations and at the same time make the fullest offering of justice to them, I shall invite in the most practical way the advice of the senate, after acquainting it with all the conditions to be met and obligations to be discharged along with our rights to be safeguarded. Prudence in making the program and confident cooperation in making it effective cannot lead us far astray. We can render no effective success to humanity until we prove anew our own capacity for cooperation in the co-ordination of powers contemplated in the constitution and no covenants which ignore our associations in the war can be made for the future. More, no helpful society of nations can be founded on justice and committed to peace until the covenants re-establishing peace are sealed by the nations which were at war. To such accomplishment—to the complete re-establishment of peace and its contracted relationship, to the realization of our aspirations, for nations, associated for world helpfulness without world government, we shall address ourselves, fully mindful of the high privilege and paramount duty of the United States in this critical period of the world."

Discussing re-adjustment of taxation, President Harding said the country did not expect and would not ap-

prove a shifting of tax burdens, but was more interested in "wiping out the necessity for imposing them." The government, he said was committed to the repeal of the excess profits tax and to abolish the "inequities and unjustifiable inequalities in the present tax system. Current government expenditures were now running at the rate of \$5,000,000,000 annually, he said, but added that it would not be safe to pruned receipts from internal taxes below \$4,000,000,000 for the fiscal years of 1922-23.

Discussing tariff revision, the president reaffirmed his belief in the protection of American industry.

"It is our purpose," he said, "to prosper America first. The privileges of the American market to the foreign producer are offered too cheaply today and the effect of much of our own productivity is the destruction of our self-reliance which is the foundation of the independence and good fortune of our peoples. Imports should pay their fair share of our cost of government. Agriculture, the president said, was menaced with prices at pre-war normals and being further endangered by high cost of transportation from farm to market through the influx of foreign farm products."

Definite Action Later

While he urged emergency tariff revision immediately, he spoke of permanent revision later and said:

"The mature revision of our tariff laws should be based on the policy of protection resting that selfishness, which turns to greed, but ever concerned with that productivity at home, which is the source of all abiding good fortune."

Deflation, the president told congress, might well receive its attention because while reduced costs in basic production had been recorded, deflation had failed to reach the mark where it could be "proclaimed to the great mass of consumers."

Congress, he said, might help speed price readjustment by "suitable inquiry."

Discussing the railroad question, President Harding said there would be "an avowed foundation on which to rebuild" if it could be understood that "congress was no sanction for government ownership," and "does not levy taxes upon the people to cover deficits in a service which should be self-sustaining."

Reduce R. R. Rates

Railway rates and costs of operation, he said, must be reduced because freight rates had mounted until "commerce is halted and production discouraged."

Development of good roads and inland waterways, the president said, were collateral subjects with the transportation question and besides endorsing federal aid to highways, he urged congress to formulate a consistent program.

Discussing the merchant marine,

the president declared for a "great" one and told congress that if present laws gave advantages to competitors of American merchant marine, "the spirit of American fair play will assert itself to give American carriers their equality of opportunity."

He added he would report to congress if intelligent and efficient administration under existing laws made established service impossible.

Aid the Press

The president devoted a portion of his address to wireless and cable developments, declaring for prohibition of private monopolies tending to prevent development of needed facilities. Especially desirable, he said, were ample services, "at reasonable rates for the transmission of press matter" so that "the daily press of all countries may be put in position to contribute international understanding by the publication of news."

Dealing with aviation the president declared for its encouragement for military and civil purposes, recommended the establishment of a bureau of aeronautics in the navy department and continuation of the army air service as "a co-ordinate combatant of the army," to be used in co-operation with other agencies to

establish national trans-continental airways.

Aid Service Men

In recommending an efficient co-ordination of the various agencies having to do with the welfare and assistance of soldiers and sailors the president made no mention of the bonus question. He recommended the creation of a department of public welfare, making it plain there was no purpose by the federal government "to invade fields which the states have occupied."

In recommending speedy consideration of the army and navy appropriation bills the president declared that while the government was in accord with the wishes to eliminate the burden of heavy armament and was ready to co-operate with other governments to approximate disarmament it would not "entirely discard our agencies for defense until they removed the need to defend." He made no specific declaration as to the size of the army nor the navy except to say that the naval program could "carry no threat after the latest proof of our national unselfishness."

The remaining portions of the president's address were devoted to the discussion of foreign affairs.

The Main St. Methodist Church, south, have engaged Mr. George Wilson to conduct a series of singing and voice culture in the chorus lessons in the church at Corner of Main and Oakdale one night every week. The first lesson will be given this evening, beginning at 7:30. There will be no charge to anyone wanting to avail themselves of the instruction and the pleasure of singing both secular and sacred glees and choruses, as the church is furnishing the singing books and paying for the lessons for the purpose of helping to build up the church and community singing, partly in preparation for the chorus of 300 voices which the Bultin Lewis revival party are asking of the community for the meeting which begins in May.

Prompt action will be necessary to save millions of feet of western yellow pine stumpage in southern Oregon and northern California, according to A. J. Paenicke, insect specialist of the forest service, who is leaving Portland this week for the region infested with pine bark beetle, to get a line-up on the approximate cost of control on government lands to serve as a basis for presentation of an emergency appropriation bill in congress by Colonel William B. Greeley, United States forester. The infested area includes Klamath, Lake and Jackson counties in Oregon, northern California, together with the Crater and Fremont national forests in Oregon, the Shasta and Modoc national forests in California and the Klamath Indian reservation. Several hundred thousand acres are involved.

Commitment at this time to the penitentiary of W. H. Johnson, former Jacksonville banker, will result in the incurrence of much otherwise unnecessary expense to the state banking department, according to a statement made in Salem yesterday by Frank C. Bramwell, state superintendent of banks. Johnson will be called as a witness in several bank cases, each trip necessitating the services of a guard with railroad fare and expenses of both men to be borne by the banking department.

A welcomed improvement in the business district is the painting of the former Rogue River Fruit & Produce association building, which structure was recently purchased by the Portland Flour Mills company which will make use of the warehouse part. The offices in the front of the building are now the headquarters for this district of the Oregon Growers Cooperative association.

DEPT OF JUSTICE ACCEPTS PLAN OF SWIFT & CO. TO DISPOSE OF STOCKYARDS

WASHINGTON, April 12.—A new plan under which Swift and company and Armour and company are to divest themselves of their interests in stockyards and stockyard terminal railroads was agreed to today by the department of justice and immediately approved by Justice Stafford of the District of Columbia supreme court.

Under the plan the companies must deliver their stock in the yards and terminals to the Illinois Trust and Savings bank at Chicago within thirty days for administration by two trustees, Henry W. Anderson of Richmond, Va., and George Sutherland of Salt Lake City until sold, which must be within a year.

"The legal principle of course, was up to the department of justice," Justice Stafford said after he had signed the plan.

The trustees are to receive salaries of \$10,000 a year each and will have power to interfere in the management of any stock yard or railroad if in the opinion of both either the Sherman act or the terms of the decree are being violated.

The plan sets forth that the defendants are to proceed to sell their stock with due diligence with reports of all sales submitted to the court for its approval. These reports must contain the price and the name of the supposed purchasers and must be accompanied by affidavits that the proposed purchasers are in no way connected with the defendants.

In the event that any of the stock remains unsold at the end of the year, the defendants may obtain an extension of time upon a showing made to the court of diligence in their efforts to dispose of stock at a fair and reasonable price.
