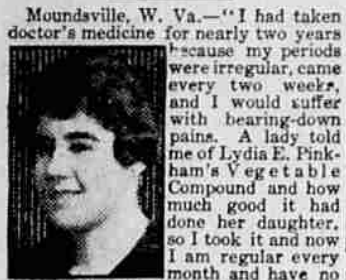

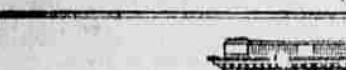

SCENERY SOCIETY ASKS PROTECTION SISKIYOU GRADE

The ruthless destruction of the scenic beauties of the Siskiyou along the Pacific highway was a subject that received consideration at the Scenic Preservation association meeting at Central Point yesterday. Private owners of timber lands are practically cutting their tracts clean of timber and shrubs and the officers of the association were directed to call the attention of the state highway commission to the depredation now going on there.

Miss Homes, county superintendent of schools, called attention to the request that had come to her office from the state superintendent for additional copies of her instructions which she gave to the schools of Jackson county to create a sentiment among the children against the destruction of our scenery. Through this means a state-wide campaign may be inaugurated to teach the children that the scenery should be preserved in its natural state.

Grandma Obenchain of Central Point who is very close to ninety years of age and who came to the Rogue River valley when the roadway between Central Point and Jacksonville was lined with trees, deplored their destruction and stated that the work of the association should have commenced years ago as much permanent damage has already taken place.

It was decided that the next meeting be held on May 20 at Jacksonville and that each attendant provide a basket lunch for himself. The meeting at Central Point was well attended and the residents of that community entered into the spirit of the undertaking which is of country-wide importance.

JUMPS FROM MOTOR BOAT, IS DROWNED

ABERDEEN, Wash., April 15.—J. Gamber, San Francisco, jumped overboard from the motorboat Pacific yesterday morning and was drowned in an attempt to swim 150 yards to shore ten miles south of Copalis beach. The attempt followed four days of huffing. S. Cardy, Gamber's partner and a Mexican, John Sanchez, stuck to the motorboat and at ebb tide reached shore in the dory they were towing. The party left Seattle Sunday in the thirty-foot motorboat for San Francisco.

LOS ANGELES PHILHARMONIC HERE APRIL 29

The concert of the Philharmonic orchestra of Los Angeles on Friday night, April 29, at the Page Theatre will offer to our music lovers a novel treat. Headed by Walter Henry Rothwell, who ranks in the forefront of American and European conductors this wonderful musical organization, consisting of seventy-five artists, picked from the leading orchestras, has achieved nation-wide fame.

Much of the success of the Philharmonic orchestra of Los Angeles must be attributed to the munificent generosity of its founder, Mr. W. A. Clark, Jr., who spent during the first two seasons close to \$400,000 on its perfection. This remarkable multimillionaire music-lover gave carte blanche to manager and conductor, so that they were able to engage the highest paid orchestra players thus assuring for the ranks of the orchestra instrumentalists who in reality may be classed as soloists.

Six eminent soloists accompany the orchestra and are featured in the programs, Elizabeth Rothwell, dramatic soprano, Richard Buhlig, pianist; Sylvain Noack, violinist; Ilya Bronson, cellist; Emile Ferré, violinist; and Alfred Kastner, harpist. In order to produce the best tonal effects, the orchestra is carrying a specially constructed soundboard on its five weeks' tour.

MINERS REFUSE TO RETURN, BUT CRISIS IS OVER

LONDON, April 15.—A conference between delegates of the miners' federation of Great Britain and representatives from all coal districts in the United Kingdom, at which the coal strike situation will be considered, was today fixed for next Friday, April 22. In the meantime work will not be resumed in any of the coal fields affected by the miner's strike.

LONDON, April 15.—Labor forces of the United Kingdom are today apparently broken into sections as a result of the refusal of the National Union of Railway Men and the National Federation of Transport Workers yesterday to continue their support of the strike called by the miners' federation of Great Britain on April 1.

Opinion prevails in some quarters that the action of the railroad workers and the transport men means the death warrant of the "triple alliance". This view is not held universally, but, without doubt the split which developed yesterday will have a serious effect upon the rank and file of labor.

Crushing Labor Defeat
"Yesterday was the heaviest defeat that has befallen labor within the memory of man," begins the laborite Herald's comment on the sensational breakaway of the railroad men and transport workers. "It is no use trying to minimize it. The workers have not stood together, and they have reaped the reward."

The newspaper declares that Frank Hodges, secretary of the miners' organization, made a tactical mistake by altering the old formula of the union during his address before members of the house of commons on Thursday night.

"The old machinery has failed," the Herald said. "This is not the end, it is the beginning."

Whether the miners' federation, in its turn will split up as predicted in some quarters remains to be seen. Mr. Hodges has the support of a strong minority, it is known. The hands of the present executives of the organization are tied but the new conference of delegates which has been called may consent to modify its instructions so that negotiations may proceed.

Labor Bluff Called
Characteristic of editorial comment on the situation is an editorial issued in the Morning Post.

"The bluff was called and it failed," the newspaper declares. "These powerful trades unions must be taught that it is not their business to govern the country."

In the meantime the stoppage of coal mining continues and it is pointed out in various quarters that the situation is still serious. Announcement is made on behalf of the government that efforts to reach a solution will not be relaxed. King George has loaned from his castle cellars twenty-five tons of coal to Windsor coal merchants for distribution among residents until the supply is again normal. Reports from provincial centers mention the bewilderment and bitter disappointment felt in the extremist sections of the miners, railroad men and transport workers at the failure of the "triple alliance" strike.

HEARING FOR GOLD HILL 'YEGGS' SET FOR MONDAY P. M.

Peter Stroff, alias "Dutch Pete," and Frank Kodat, who are alleged to be two burglars who broke into the Gold Hill bank earlier in the week and who were arrested later in Medford, were arraigned on the charge of burglary in Justice Talor's court Friday afternoon and their preliminary hearing was set for Monday at 10 a. m. The bail bond of each was fixed at \$2000, and in default of bail they are still prisoners at the county jail. The prisoners have retained Frank J. Newman as their attorney.

While the authorities are giving no additional details as to the burglary and their arrest, nor of the evidence which they claim to have against the prisoners, they assert they have a sure case against Stroff and Kodat. Stroff's name has heretofore been published as Peter Lister. This is due to the fact that "Dutch Pete" a short time after his arrest basely deceived a Mail Tribune reporter when asked by the latter what his real name was, by replying "Pete Lister."

ported from the Aycock community, near Tusculum, and three from Ralph, Tuscaloosa county. More than 40 persons were injured at the two places.

At Birmingham 10 persons were injured. A hundred homes were damaged in the northern and western suburbs. Damage estimated at \$30,000 was done at Rickwood Field, property of the Birmingham Baseball association. Telegraph and telephone lines over the area were practically paralyzed by the disturbance which covered a wide area and lasted through most of last night and until afternoon today.

Every available doctor and nurse from this city, supplemented by citizen workers, Boy Scouts and corps of ambulances, answered calls for help, which reached here shortly before the wires failed. The path of the storm is one of desolation today and tales of the devastation wrought brought by relief workers who spent the night in the wrecked districts promises to exceed first reports.

AUSTRIA TO TAX MEN WHO DIDN'T FIGHT THE FOE

BUDAPEST, April.—Austrians who did not see service in the war are to be compelled to pay a special tax, the proceeds of which is to be devoted to the care of disabled Hungarian soldiers or the dependents of those who were killed in the war.

Hungary has about 250,000 disabled fighting men and, including the orphans, widows and refugees, the government has to provide for more than 900,000 persons. This number is about one-eighth of the entire population of Hungary.

More than 4,000 families who fled from Transylvania when that section of Hungary was annexed to Rumania by the peace treaty still are living in railway cars in the various yards in this city. When one family manages to find rooms in Budapest, the vacated car is immediately claimed by newly arrived refugees.

Through the efforts of American welfare missions, about 75,000 children are being fed in Budapest alone. Complete outfits of clothing have been distributed to them many times.

Approximately half the shoes now manufactured contain a percentage of paper.

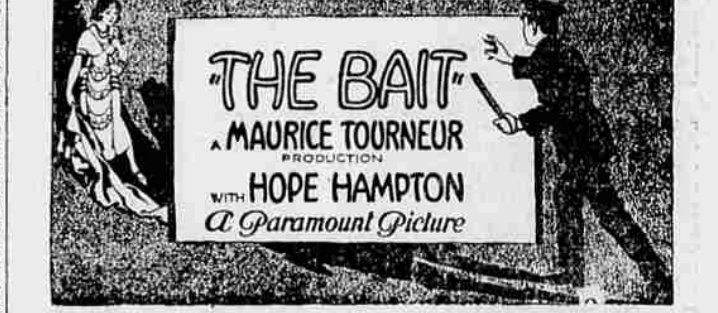
