

GERMANY WILL PAY PER TERMS ENTENTE NOTE

Accepts Unconditionally All Asked—New Cabinet Sends Notes to Allies—See Rise of Poland When Disarmament Clause Is Obeyed.

LONDON, May 11.—(By the Associated Press)—Germany's unconditional acceptance of the entente reparations was delivered to Prime Minister Lloyd George by Dr. Stahmer, German minister to Great Britain today.

BERLIN, May 11.—(By the Associated Press)—Germany's reply to the allied ultimatum, accepting the terms laid down by the allied supreme council in London is confined to a repetition of the exact terms of the decisions of the allies with regard to guarantees, disarmament, the trial of German war criminals and financial conditions. The reply states that Germany adheres unconditionally to these conditions.

This reply was sent to the allied capitals after the cabinet, headed by Dr. James Wirth, the new chancellor, had received what amounted to a vote of confidence in the reichstag last night.

BERLIN, May 11.—Germany's new cabinet today began preparation of the government's formal note to the entente accepting the terms laid down by the supreme allied council in London. Dr. Julius Wirth, the new chancellor received what amounted to a vote of confidence in the reichstag last night, that body approving of the ministry's decision to accept the allied ultimatum. The vote stood 221 to 175, giving the Wirth government a margin of 46.

The notes cast for acceptance of the entente terms were from the centrist democratic, independent and majority socialists. The nationalists, German peoples party, communists and the Bavarian peoples party were opposed to the plans of the ministry, as announced by the new chancellor. In his address, Dr. Wirth emphasized the tremendous burden Germany would assume in agreeing to meet the entente terms but insisted the alternative of French occupation of the Ruhr valley would completely cripple Germany's industrial life and demoralize the country.

The allied demands, in brief, were payment by June 1 of the 1,000,000,000 gold mark due May 1; trial of German officers and soldiers accused of crimes during the war; complete disarmament of the military, naval and aerial arms of Germany's service, and the ultimate payment of \$32,750,000 in reparations. The reparations obligation would be paid in installments of approximately \$48,000,000 a year, in addition to 25 per cent of the value of Germany's exports.

It has been indicated that representations would be made in Dr. Wirth's answer to the entente that compliance with the disarmament clauses of the council's ultimatum might be attended by danger, especially on the part of frontiers, where the Poles have engaged in a serious insurrection with the intention of taking possession of Upper Silesia.

RELIGIOUS PAGEANT HONORS MANNING

NEW YORK, May 11.—The Rev. Dr. William T. Manning today was consecrated tenth bishop of the Protestant Episcopal diocese of New York.

Only about 3,000 clergy and laity were able to witness the ceremony in the cathedral of St. John the Divine, but outside a crowd several times as large watched the procession file into the edifice.

One of the largest gatherings of clergy in the history of Protestant Episcopal churches in America formed a pageant of rich color. Garbed in the rich vestments of their high rank, more than 450 churchmen, including 33 bishops marched with slow and solemn step into the great house of worship.

HIGH JAPAN NAVAL CHIEF TO VISIT

WASHINGTON, May 11.—Admiral Urio, ranking officer of the Japanese navy, is coming to the United States to attend the fortieth reunion at Annapolis next month of the naval academy class of 1881 of which he was a member. He is the only living Japanese graduate of the naval academy and had as his classmates Secretary of War Weeks and Admiral Henry B. Wilson. Weeks and Admiral Henry B. Wilson were in command of the Atlantic division of the United States fleet.

Chicago Assassin Leaves \$20 for Flowers for Victim

SLEW TAXI MAN WHILE HE BEGS BABY'S PHOTO

Four Army Deserters Talk Willingly of Coldblooded Crime—Half Breed Indian Directed Murder—Wanted Auto to Escape Camp Lewis.

TACOMA, May 11.—Four deserters from Camp Lewis will be arraigned tomorrow morning on the charge of murdering Karl Timbs, taxicab driver, Sunday night. The men have confessed the crime, according to officials, but it has not been decided whether to arraign them for first or second degree murder. Hanging is a possible penalty in the first degree.

The soldiers, Sergeant George Sharp and Privates Carl Perrin, James Sparks and Edward Filion, calmly talked to officers and newspaper reporters of their crime today. Sharp, age 23, recited how Timbs' car was hired so the soldiers could desert. He said Filion struck the fatal blow after Sparks lost his nerve. Filion confessed he wielded the rock that caused Timbs' death.

Sharp also told how he stole chloroform at Camp Lewis and used it upon their victim after he was struck. He said he attempted to give Timbs enough of the drug to keep him unconscious for eight hours.

The last words of Timbs were: "Don't take the baby's picture," Sharp said. The words referred to a photograph of Timbs' 14 months old baby which he always carried.

Sharp confessed he directed the plot. He is a half-breed Cherokee Indian. He claimed to have enlisted in the army when he was fifteen years of age and said he served in France with the fourth division. The other confessed slayers are recent army recruits, Filion is from Windsor, Ont., and Sparks and Perrin from Illinois.

All the men were athletes in their organizations at camp.

QUEENSTOWN, Ireland, May 11.—Queenstown was isolated from the mainland through the blowing up of Belvidere bridge today. The bridge connected the mainland of county Cork with the island on which Queenstown is situated.

CHILD LABOR IN U. S. INCREASES

WASHINGTON, May 11.—Increase in the number of child employees in the United States has been almost exactly proportionate to the increase in total population in the last eight years, according to the United States department of labor. Statistics compiled by the children's bureau show that 75,194 minors took out permits in twelve representative cities in the country to go to work in 1920. This compares with 57,169 in 1913, an increase of 13 per cent.

INDICT PAIR IN OREGON TIMBER LAND SCANDAL

38 Salem Residents Bilked—Going to Secure Valuable Holdings—Vancouver, Wn., Civic Leader Under Cloud—Used Mails to for Scheme.

PORTLAND, Ore., May 11.—Carlos L. Byron of Seattle and John W. Todd of Vancouver, Wash., were under arrest today on federal indictments in connection with alleged frauds in making locations of land for clients, according to an announcement by District Attorney Lester W. Humphreys. Arrest of Byron in Seattle was reported to Humphreys by Assistant United States Attorney N. M. Makin of Seattle, he said.

Todd was arrested yesterday at Vancouver. According to Humphreys thirty-eight residents of Salem, Ore., were defrauded on contracts by which Byron agreed to obtain locations for them on valuable timber land. The alleged victims were professional men, school teachers and business men. Humphreys said he had information of 132 such contracts with total losses aggregating \$20,000.

Humphreys said Byron had been convicted here and in Seattle of land fraud operations, and that the alleged Salem operations were carried on while he was out on bond pending appeal.

VANCOUVER, Wash., May 11.—General denial of land fraud charges set forth in a secret indictment recently returned against him was made today by John W. Todd, president of the Vancouver Rotary club. Todd is a farmer living near this city, and is not a school principal as has been reported. Todd was charged in the indictment with having used the mails with intent to defraud by promising to locate clients upon valuable land in Oregon and Washington, charging fees of from \$300 to \$500 for so doing.

Todd, who formerly was a resident of Salem, said he had not defrauded his acquaintances in that city. Todd said his part in transactions consisted merely of introducing an associate to his friends. Todd is out under \$5000 bonds.

CAPITOL IS GLAD GERMANY MEETS ENTENTE TERMS

WASHINGTON, May 11.—Administration officials expressed satisfaction today over the decision of the German government to accept the reparations terms of the allies.

It is known that an invasion of the Ruhr valley by the allied forces would have been regarded by the United States with deep concern.

American government economists appeared to be convinced of Germany's ability to meet the obligations imposed and they professed to see in her decision promise of an economic revival that would cause a happy reaction throughout the world.

With the indemnities question out of the way, marked relief was shown and it was indicated that the state department expected to proceed more rapidly with the consideration of the numerous problems connected with the development of its foreign policy along the general lines of insistence upon equal opportunity and the recognition of American rights throughout the world.

Pay of Methodist Preachers Increase, 1920 Record Year

CHICAGO, May 11.—The average annual salary the Methodist Episcopal church pays its ministers is \$1154, according to a statement made by Dr. Joseph D. Hingley, corresponding secretary at the annual meeting of the board of conference claimants of the church today. Three years ago the average salary was \$869, he said.

"This has been the best year for preachers' pensions in the history of the Methodist Episcopal church. Total money paid for pensions in 1920 was \$2,010,970," declared Dr. Hingley.

JAP OMOTOKYO LEADERS JAILED, RICH RADICALS

KYOTO, Japan, May 11.—Leaders of the radical "omotokyo" cult have been placed under arrest, with many of their principal followers, following a police raid on the headquarters of the organization at Ayabe, near here. They are charged with distributing alarmist literature calculated to disturb the public.

Police officials who conducted the raid broke into a secret temple at Ayabe and there found 2,000,000 yen in specie and several hundred swords. An investigation is declared to have shown that the famed deity of "omotokyo" enshrined in the temple consisted merely of pebbles wrapped in paper. Subterranean passages were found leading to the residence of Waniaburo Deguchi, adopted son of the woman who was founder of the cult, it is said, and in his home were found chests laden with diamonds and rubies valued at \$1,000,000. Firearms were also found stored in the building the police declare.

The workers sent out by the cult have declared that failure of the nation to adhere to "omotokyo" as the revealed religion would mean the total destruction of Japan in half a century.

EMERGENCY TARIFF BILL PASSED

WASHINGTON, May 11.—The senate today passed the emergency tariff and anti-dumping bill, retaining all amendments recommended by the finance committee, but rejecting those individually proposed.

The vote was 63 to 25. The Knox amendment, continuing war time control over imports of dyestuffs, was accepted 61 to 25.

Seven democrats, Senator Broussard, Louisiana; Jones, New Mexico; Kendrick, Wyoming; Myers, Montana; Pittman, Nevada; Randall, Louisiana and Shepard, Texas, voted with the republicans in passing the bill. Another democrat, Ashurst, Arizona, who was absent, was announced as a supporter. Only one republican, Senator Moses of New Hampshire, voted against the bill.

POLISH REBELS ACCEPT TERMS SILESIA MESS

Korfantry and Allies Reach An Agreement—French Troops Near Grascowitz Engage in Artillery Duel—Fear Germany Will Complicate.

LONDON, May 11.—It is reported that negotiations between the inter-allied commission in Upper Silesia and Adalbert Korfanty, leader of the Polish insurgents in that area, resulted last evening in the suspension of hostilities, says a dispatch to the Central News from Warsaw today.

It was agreed, according to this report, that the insurgents would occupy a line of demarcation agreed upon and remain in the stipulated positions pending final settlement of the Upper Silesian question, which is still pending in allied councils, where it rested following the taking of the recent plebiscite in this area in dispute between Poland and Germany. The industrial territory, which has been largely overrun by the Poles, therefore would retain the Polish occupancy.

OPPELN, Silesia, May 11.—(By the Associated Press)—French troops engaged in an artillery duel with insurgent Poles near Grascowitz south of this city yesterday. The Poles replied to the French fire with several small field pieces. A number of slightly wounded French soldiers have been brought here and other wounded Frenchmen have been brought in by motor lorries from other towns in the disturbed area. It is rumored that a German officer, who formerly held a high position in the army, has taken charge of German operations in Silesia and inter-allied officials here fear there will be serious developments in the next few days unless the Poles indicate their intention to begin a withdrawal. In this city there has been arriving a continuous stream of wounded German refugees and the situation has grown more intense. The German civilian guards have completed their organization. The officers say they have sufficient rifles and will feel safe if they can secure artillery.

Allied officials arriving here from Katowitz, report the Poles held them up and took them to Polish headquarters. Eventually the officials were given passes signed by the Polish commissar, which permitted them to pass the insurgent lines.

WASHINGTON, May 11.—Suspended schedules proposing substitution of a 35 per cent for a 33 1/5 per cent increase in class and commodity rates between eastern and southern territory and the southwest were ordered cancelled today by the inter-state commerce commission.

The commission sustained, however, increases proposed between points in the southwest and points in defined territories east of the Indiana-Illinois state line and the Mississippi river, Cairo, Illinois and south, originally established and which before the rate increases of 1920 were maintained on the basis of the lowest combination of local rates to and from the Mississippi river crossings or other rate basing points.

On traffic between the southwest and points in the defined territories located in the eastern group, the commission said, the result of the increases would be an addition over the rates in effect before the general increase of approximately 1 2/3 per cent in the haul between the southwest and St. Louis and 5 2/3 per cent in the haul between St. Louis and points in the defined territories in the eastern group. The exact percentage of increase depends on the extent to which the joint rates fail to reflect the lowest available combination.

FRENCH DEBTS TO BE PAID IN FULL

PARIS, May 11.—France intends to pay what she owes, said a high official of the French foreign office this morning, in connection with various reports from New York.

"The French government," he continued, "will take no steps whatever regarding the modification, reduction or cancellation of her debt to the United States."

Charlie Chaplin Burns Legs; Famous Pants With Patches Lost

LOS ANGELES, May 11.—Charlie Chaplin, who was burned about the legs yesterday when he stumbled over an acetylene blow torch in the studio where he was working, is suffering no serious effects, but will be unable to work for several days, it was said today at his home. The comedian was said to regard the destruction of a pair of patched pants familiar to millions of film patrons, as the worst feature of the accident.

AGED MAN GIVES AFFIDAVIT TO CLEAR MOONEY

A. E. Lundin, Contractor, Bellingham, Produces New Evidence in 'Frisco Bomb Plot—Saw Men Leave Suitcase, Neither Was Mooney.

BELLINGHAM, Wash., May 11.—An affidavit to the effect that Thomas J. Mooney was not responsible for the explosion which killed several persons in San Francisco during a preparedness parade July 22, 1916, was made here today by A. E. Lundin, aged 72, by occupation, a railroad contractor.

The affidavit was obtained by Don C. Parker, an attorney, in the interests of the San Francisco labor council, and will be presented at a hearing on the motion for a new trial for Mooney, which is set for May 23.

Lundin, in his affidavit, says he and a friend were together in a saloon between 12 and 1 p. m., July 22, 1916. As they emerged they saw two men come from the direction of Market street and leave just outside the saloon a large black suitcase and then enter the saloon. A few minutes later an explosion occurred. When he saw a photograph of Mooney in a newspaper last fall, Lundin says he remarked to his wife that it was not a likeness of either of the men who had the suitcase, both of whom he described as being very dark and small, one being about five feet five inches in height and weighing 135 to 140 pounds, and the other about 5 feet nine inches tall.

Lundin says he did not know with whom to confer regarding the case until recently when he saw the name of Mooney's counsel in a newspaper. In his affidavit Lundin says he is a naturalized American citizen, born in Sweden, and that he was a resident of San Francisco in 1916.

GERMAN YIELDING AID TO STOCK

NEW YORK, May 11.—Acceptance by Germany of the ultimatum of the allies prompted moderate covering of short contracts at the opening of today's stock market. Coppers, which were among the new features of strength during yesterday's session, extended their gains by fractions to a point and oils also hardened. Within the first half hour, however, the market reversed its course on heavy selling of the steels. Crucible and Republic were conspicuously weak, losing two and 3/4 points respectively. Sugars and tobaccos also developed a heavy tendency. Foreign exchange, as indicated by preliminary quotations made no marked response to Germany's surrender.

HIROHITO GIVEN KEY TO LONDON

LONDON, May 11.—(By Associated Press.) Crown Prince Hirohito of Japan who arrived here Monday for a three weeks' visit to England was officially welcomed to London today by Lord Mayor Roll and the city authorities.

With the Prince of Wales and an escort of cavalry, Prince Hirohito proceeded from Buckingham palace to the Guildhall through cheering crowds. The historic edifice was crowded as Prince Hirohito, accompanied by the Duke of Connaught, the Duke of York and the Prince of Wales entered. The Japanese prince was given an enthusiastic ovation and was markedly pleased with his reception.

WHITELASH USED ON COLONEL WHO KEPT BERGDOLL

War Department Promoted Col. Hunt, While on Trial for Letting Rich Slacker Go—Witness Insists No Special Favor Shown Him.

WASHINGTON, May 11.—Reiterated charges that Colonel John E. Hunt, commanding the disciplinary barracks at Governor's Island, was "whitewashed" by a military court martial in connection with the escape of Grover C. Bergdoll, draft dodger, were made by Representative Johnson, democrat, Kentucky, today when the house investigating committee resumed its inquiry.

"I purpose to prove this by the report," Mr. Johnson said after the record of the court martial was admitted to the committee with the approval of Colonel Hunt, who was again on the stand.

"The judge advocate (of the court) was no friend of mine," Colonel Hunt said, "and he prosecuted the case vigorously."

There was a sharp cross-fire on the point that Hunt had been promoted while charges against him were pending, but the witness insisted he was promoted by the usual operation of military law. Mr. Johnson inquired if announcement of the promotion in the midst of the trial was made to influence the court.

"I am certain it was not made for that purpose," Hunt replied.

When Bergdoll set out from Governors Island to search for his pot of gold, he wore a regulation army uniform with infantry hat band indicating that he was in regular service. Sergeant John O'Hare, in command of the party, told the committee.

"Bergdoll was dressed exactly as I was," said the sergeant. "I had been told he was a bad actor, to keep an eye on him but before leaving I asked Colonel Hunt if I was to handcuff the prisoner and he said no that it would be too conspicuous."

O'Hare gave a detailed account of the stopover at Philadelphia, including a motor ride in the parks with Bergdoll driving; a trip to a burlesque theater with the entire party sitting in a box, and the sudden appearance of a bottle of gin at the Bergdoll home. York, the other sergeant, took a drink but O'Hare told Bergdoll, he testified, "to stay off that stuff."

O'Hare, who has been in the service twenty years, declared it was the first time he had ridden in an automobile. Judge Romig, who previously had visited Washington to get \$105,000 out of the treasury was general boss of the Philadelphia stop-over O'Hare said paying for the theater tickets and giving directions as to where the party should go.

HIGH WAGES HALT RAIL BUILDING, CONGRESS TOLD

WASHINGTON, May 11.—Stagnation in railroad building in the United States must be attributed to the disparity between the cost of construction and the return to the investor, Julius Kruttschnitt, chairman of the board of directors of the Southern Pacific today declared in resuming his testimony before the senate interstate commerce committee which is inquiring into the railroad situation.

"In 1920 only \$62,284,000 went as a return to those who paid for the properties while sixty times as much went to those employed on the railroads," he said.
