YANKS TAKE LEAD WITH A 3-1 VICTORY

MEUSEL AND HOYT STARS FIFTH GAME

Ex-school Boy Chalks Up 2nd Victory in World Series—Giants Get 10 Hits, But Meusel's Quick Arm Shuts Off Scores—Series Now Stands 3-2

POLO GROUNDS, New York, Oct. 10.—(By the Associated Press)—The Yankees stubbed the barb of defeat into the Giants' sides this afternoon and walked off the field with their third victory for the American league champions. The score was three to one and the Yankee heroes in the toppling of the Giants were Waite Hoyt, who pitched his second win over the National league pennant winners and Bob Meusel, whose steel whip broke up two Giant batting rallies by lightning throws.

Fire at Benson Hotel Does \$10,000 Damage Guests Flee, Nighties

PORTLAND, Ore., Oct. 10.—Guests at the Benson hotel here were routed from their beds early today by a fire which started on the top floor in the tailor establishment of the hotel. Occupants of rooms were warned and fled in negligence and such clothing as they could hastily assemble. Damage principally due to water was estimated at \$10,000.

PROPOSE REPEAL ALL TAXES ON TRANSPORTATION

Senate Finance Committee Also Decides for Repeal \$2000 Exemption for Corporations With Net Income Over \$25,000.

WASHINGTON, Oct. 10.—Amendments to the tax bill proposing repeal of all transportation taxes, including those on oil by pipe line and on parcel post packages, a maximum surtax rate of 50 per cent and increased estate taxes were approved today by majority members of the senate finance committee.

The majority also approved amendments for retention of the corporation capital stock tax and for repeal of the \$2000 exemption allowed corporations in the case of corporations having annual net incomes in excess of \$25,000. A flat tax of \$6.40 a gallon on distilled spirits also was agreed upon but with a proviso that there would be a rebate of \$4.20 a gallon where it was shown to the satisfaction of the commissioner of internal revenue that the spirits were used for manufacturing or medicinal purposes.

MOSCOW READY TO TURN KAMCHATKA OVER TO JAPANESE

TOKIO, Sept. 10.—Secret negotiations between Japan and the soviet government of Russia have been in progress for some time, according to the Kokumin, which is regarded as a military organ. Japanese Minister Kawakami at Warsaw has been carrying on the conversations with Moscow, says the Kokumin which adds that conclusion of a trade agreement between Moscow and Tokio is the prime object of the negotiations, with the desire for a settlement of the Nikolaievsk incident, in which Japanese troops and subjects were massacred as another matter of considerable importance.

Aerial Speed Cop Kansas City. KANSAS CITY, Mo., Oct. 10.—Visiting airmen are to be watched from the clouds by an aerial policeman during the three days of the forthcoming national convention and aviation circus of the American Legion.

Between \$40,000 and \$50,000 was realized and turned over to the greatest pitcher of all times, at Saranac Lake, N. Y., where he is suffering from tuberculosis. A National baseball, autographed by President Harding and Matty, shown in the illustration, was auctioned off and brought \$750. J. K. MOORE, GOLD HILL PIONEER PASSES AWAY

GOLD HILL, Ore., Oct. 10.—(Special.) John Kimmor Moore, 85 years old, residing on his original homestead in the Gold Hill district for over 52 years passed away Saturday at 4 p. m. of infirmities incident to old age. Deceased was born in Tennessee, Feb. 14, 1837, and came to Jackson county, Oregon in 1869. He was a nephew of C. C. McClelland, one of Rogue River valley's earliest settlers and Gold Hill's oldest man, being past ninety years of age. Free Tolls Panama Canal Passed By Senate, Vote 47-32

WASHINGTON, Oct. 10.—The senate today declared for free transits of American coastwise vessels through the Panama canal by passing the Borah bill for tolls exemption. The vote was 47 to 32.

FATHER DENNIS RUSSELL DIES BROKEN HEART

ROSEBURG, Ore., Oct. 10.—Another tragedy stalked into the Brumfield case today when two brothers and a sister of Dennis Russell, for whose alleged murder Dr. R. M. Brumfield is on trial for his life, received word that their aged father had died. The relatives said grief over their brother's death undoubtedly was the cause of the death of their father, who they said had been failing ever since the body was found in the wreck of Dr. Brumfield's car.

The defense this morning challenged two prospective jurors, and early this afternoon another, leaving the defense with two peremptory challenges. The state challenged one, and had two more challenges to use.

Two more tentative jurors were put in the box as the result of the morning's questioning.

ROSEBURG, Ore., Oct. 10.—Eighteen of the third panel of 25 were on hand when court opened today to resume the effort to obtain a jury to try Dr. R. M. Brumfield for the alleged murder of Dennis Russell, the laborer whose headless body was found beneath Dr. Brumfield's wrecked automobile July 13.

Dr. Brumfield complained this morning that mice had overrun his cell, and that he had to spend most of the night fighting the rodents. He asked jail attendants for traps.

John Brumfield, brother of the dentist, arrived here yesterday from Princeton, Ind., and W. Victor Brumfield, of Broton, Minn., another brother, has also arrived.

GIANT DIAMOND FOUND IN ARKANSAS FIELD

LITTLE ROCK, Ark., Oct. 10.—The largest diamond mined in Arkansas field in Pike county, was found late last week, officials of the mining company announced today. The stone weighs 20.25 carats in the rough and is estimated to be worth \$10,000.

Consumption of Ice Cream Is Increased 100,000,000 Gallons

MINNEAPOLIS, Oct. 10.—The possibility of the return of the ten cent ice cream sundae, as well as lower prices for other dishes will be discussed at the annual convention of the National Association of the Ice Cream Manufacturers which opened a three day session here today. Figures showed ice cream consumption increased 100,000,000 gallons since prohibition went into effect.

FEDERAL JURY DISCHARGED IN F. HOOD CASE

Unable to Agree On Verdict in Case Involving Theft of Government Cattle—Civil Action Against Ivan Kilgore Is Started

A jury in the federal court was unable to agree in the case of Fred Hood and his cousin, Charles Hood, Jr., both Klamath Indians, and were discharged by the court, after long deliberation. The redmen were accused of stealing and selling five head of government stock. They will be probably re-tried at the next term of court. This was the last of the Indian cases before the present term of court, and the aborigines have returned to their tepees on the reservation.

The civil action of the government against Ivan E. Kilgore, prominent Klamath county stockman and member of a pioneer Oregon family was begun in court this morning. The government is asking for actual damages of \$108, and punitive damages of \$125 for alleged violation of the grazing laws in the Fremont national forest reserve. The government is assisted in the prosecution of the case by W. S. Baker of the department of agriculture.

The government charges that Kilgore allowed his cattle to graze on the land without a permit and after warnings, and that his motive in prosecuting is to protect the small stockman.

Attorney Manning for the defense, in his opening statement to the jury said that the evidence would show that a personal motive was back of the case, "a ranger giving Mr. Kilgore considerable trouble," owing to a quarrel. Attorney Manning also stated that Kilgore had paid a fine of \$24 for violation of the grazing regulations under protest.

The first witness was Gilbert T. Brown, supervisor of the Fremont national forest, with headquarters at Lakeview, Oregon.

The case is expected to go to the jury late this afternoon.

SENTENCE MINISTER TO LIFE IN PRISON

LAKEPORT, Cal., Oct. 10.—A sentence of life imprisonment was imposed today on John A. Spencer, former clergyman, convicted October 8, of first degree murder in connection with the death of his wife, Mrs. Emma Spencer, July 27. He served notice that he would make no appeal. He will be taken to San Quentin prison tomorrow. Before being sentenced Spencer made the following statement: "Before the bar of justice I have been declared guilty but before the bar of Heaven I am known to be innocent. My wife in Heaven knows I am innocent."

LEGION STANDS FALL, FORTY-FIVE HURT

DECATUR, Ills., Oct. 10.—Forty-five persons were injured, five seriously when ten sections of the grandstand seats erected for an American Legion parade of Illinois veterans attending the state convention collapsed just before the parade passed. There were no fatalities.

CRIME WAVE ON AGAIN, 3 BANKS JIP'ED

Banks in California, Kansas City and Missouri Held Up—Kansas City Banker Shot—Over \$100,000 Taken—Suspect \$150,000 Robbery in Sacramento, Caught.

KANSAS CITY, Oct. 10.—The State Bank of Muncie, Kas., was robbed this morning and in an exchange of shots between the robbers and bank officials it is reported L. E. Worthington, cashier of the bank, was shot. Telephone wires between here and Muncie have been cut, presumably by the robbers.

ST. LOUIS, Mo., Oct. 10.—Two men held up Robert Hardeman this morning, messenger for the Grand bank and escaped with a satchel containing \$17,650 in cash and \$51,650 in non-negotiable paper. The robbery was committed on a crowded street car, near the heart of the busy downtown section.

After obtaining the satchel the bandits compelled the conductor to stop the car and open the door. They escaped in a waiting automobile.

LOYALTON, Cal., Oct. 10.—Two posses today were hot on the trail of the two bandits, who last Tuesday robbed the Bank of Loyalton of between \$20,000 and \$25,000, according to announcement of Mont Berg, president of the bank, who today said the bandit trail was found again yesterday. The trail elings close to the summit of the Sierras and seldom leaves rocky ground, the two fugitives—Mahoney and McLain—apparently keeping to the hard ground in the hope they would finally shake off their pursuers.

Berg today said the chase was becoming so hot that a capture might be effected. He said posse members were expecting a battle with the bandits when they are overhauled.

Mail Bandit Caught

SEATTLE, Oct. 10.—John Haanstra, former railway mail employe at Oakland, Cal., was today held here in lieu of \$10,000 bail following his appearance before United States Commissioner Robert W. McClelland on a charge of having sold a \$500 bond alleged to have been part of the loot obtained in the theft of a mail sack containing \$150,000 in bonds and securities at Sacramento, Cal., last May 19.

Haanstra was arrested by local authorities at Kalama, Wash., last Wednesday on the request of Western officials who had traced him north from California. He is specifically charged with having sold one of the bonds alleged to have been stolen at Sacramento, at Weed, Cal., last week. So closely was the prisoner guarded by federal authorities that the fact of his arrest did not become known until last night.

According to officers, Haanstra was unable to explain how he came in possession of nine \$100 bills and five \$50 bills, found when he was captured. They said he declared he had been traveling about the country for some time, buying and selling used automobiles.

Postoffice Inspector George E. Lewis, of San Francisco, questioned Haanstra closely today in an effort to trace the stolen bonds, only one of which, the one he is alleged to have sold at Weed, has been recovered. He protested that he knew nothing of the robbery. Inspector Lewis said there apparently was no connection between Haanstra and Roy Gardner, mail bandit, now a fugitive from the federal penitentiary at McNeil Island, Wash.

ROYAL JAP MIDDIES ARRIVE AT PANAMA

PANAMA, Oct. 9.—The Japanese school ship Izumo and Yakumo, commanded by Admiral Saito, arrived at Balboa today with 250 midshipmen aboard, including two imperial princes. Elaborate entertainments have been prepared by the canal zone officials for the visitors.
