FOCH, HONORED, BIDS FAREWELL, AND SAILS HOME

Every Honor Land Could Bestow Given Marshal—Many Gifts from People and Legion—Carries Germanium from Indiana to Plant on Soldier's Grave.

NEW YORK, Dec. 14.—(By the Associated Press.)—Ferdinand Foch, gray and slight, but bearing with him every honor that America could bestow, one of alien citizenship, bade farewell to cheering throngs here today and sailed away to France.

Since coming to America in October, Marshal Foch has traveled nearly 5000 miles from ocean to ocean, made more than 500 speeches.

His luggage included a score and a half of parchments, attesting he had been accorded honorary degrees by America's leading universities and colleges.

IRISH FACTIONS FUSS O'ER POINT IN PEACE TERMS

DeValera Raises Technicality and Calls Down Delegates—Mike Collins Resents—King George Makes Speech, and Ulster to Stand Aloof.

DUBLIN, Dec. 14.—The question of ratification or rejection of the Anglo-Irish agreement by the Dail Eireann has been postponed until Thursday, when a public session will be held and the deputies will debate the matter and come to a decision.

Meanwhile the Dail in secret session this afternoon was discussing the dispute between the delegates to the London conference who were the signers of the agreement, and Eamonn de Valera, the republican president, and his adherents on this issue, as to whether the delegates had the power to conclude the agreement.

At the argument during the hour's public session Mr. De Valera asserted the delegates had not obeyed the instructions of the cabinet, a charge which both Michael Collins and Arthur Griffith resented.

It was a question of whether the delegates had failed to report to the cabinet before signing the agreement, Mr. De Valera insisted this was an important point, but Mr. Griffith claimed it was not a material one, for while he and his colleagues had power to sign an agreement they had no authority to conclude one.

President De Valera argued that the treaty should not have been signed without it having been referred to Dublin. One reason why he had not been a delegate himself, he explained, was that an opportunity for delay might be afforded.

One of the tensest moments of the debate was when Michael Collins declared emotionally: "I have been called a traitor. Let the Irish people decide whether I am or not."

UNRAEL TANGLE OF WOOD MEASURES

CURIOUS HOLD OF DOCTOR ON LADY ENDED BY BULLET

Mrs. Raizen, 29, Killed Dr. Glickenstein, 48, After Long Relations, and Attack Last Saturday—Tells Life Secrets With Dry Eyes.

NEW YORK, Dec. 14.—Pleading eight years of suffering as her justification, Mrs. Charles H. Raizen today faced arraignment in Brooklyn court on charges of killing Dr. Abraham Glickenstein, aged 48, in his Bedford avenue office last Saturday.

Surrendered to the police by lawyers representing her father and husband last night, Mrs. Raizen, who is 29 years old and the wife of a toy manufacturer to whom she was married last May, told her story to District Attorney Harry Lewis.

With dry eyes and an air of self-control superior to that of any of her auditors, she revealed the secrets of a life which had been made nearly unbearable by the physician, whose life she had ended with a bullet.

She had known Glickenstein most of her life. He was her family's general practitioner in the lower east side of Manhattan, where she, then Lillian Schaffner, and her parents, as well as Glickenstein, lived.

MOSCOW, Dec. 14.—(By the Associated Press.)—Wastlike appeals have been issued to the Russian bolshevik army and navy by Leon Trotzky, minister of war and marine. These appeals, sent out by wireless, demand increased preparedness for hostile action, and declare that Japan "hoping to strengthen her Siberian position at the Washington conference," has launched an attack against the Far Eastern republic.

HANSON PLAN IS HELD VALID BY COURT DECISION

Judge Calkins Hands Down Decision Upholding Medford Council—Delinquent Sales Legal—Many Points Decided in Suit of Grace Wilson—Deeds to Property to Be Issued in Spring.

Chief Judge E. M. Calkins handed down a decision last Saturday in favor of the city of Medford in the case of Grace M. Wilson vs. City of Medford, N. A. C. 4811 of Oregon.

Judge Calkins further held that the assessment liens against plaintiff's property were valid and enforceable liens. It was also held by Judge Calkins that the Refunding Improvement bonds, issue of 1919, and the improvement bonds, issued by the city under the Hancock act, were general obligation bonds of the city and that the special benefit assessment liens were not waived by the city by reason of the fact that these bonds were issued under the Hancock act.

It was further held that the sales of property for delinquent installments of assessments by the city treasurer of the city of Medford under the provisions of this charter amendment were valid and legal sales. JAP SMUGGLER IS KILLED IN RAID

ABERDEEN, Dec. 14.—No new arrests have been made today and no new clues have developed in the drug raid federal officers made last night on the Japanese steamer Shiohei Maru at Hoquiam, which resulted in the killing of Eddie Nagama Kaya, alleged notorious Japanese smuggler. Officials suspect that another Japanese was wounded during the gun battle that ensued when the raiding officials faced guns in the hands of four Japanese, following the delivery to the officials of nine cans of drugs of an estimated retail value of \$100,000, but no other arrests have been made.

FREIGHT CUTS NO PROSPERITY AID

WASHINGTON, Dec. 14.—Sweeping reductions in transportation charges at the present time would not assist a full resumption of business activity and would be injurious to the railroads, Howard Elliott, chairman of the board of the Northern Pacific and a director of the New Haven declared in the opening statement made before the inter-state commerce commission today in its general investigation of railroad rates.

PARIS, Dec. 14.—Georges Carpentier has grown a mustache, a correspondent of the auto informs the world after interviewing the French pugilist prior to his departure for England to meet Cook, the Australian fighter, on January 17. A photograph accompanying the article confirms this statement, and also shows Georges to be somewhat thin and drawn, but cheerful, after his recent illness, which halted his training for some time. His weight, which dropped to 160 pounds at one time, was 174 the day the correspondent saw him.

MILITIA CALLED OUT TO QUELL WILD AMAZONS

American Legion Guard Union Head to Prevent Kidnaping—Wild Women Blow Up Boiler—March Up and Down Crawford Coal Fields.

PITTSBURGH, Kan., Dec. 14.—Three companies of Kansas National Guard have been ordered mobilized for immediate transportation for Pittsburgh to quell the rioting women marchers in the Kansas coal mine field, it was announced here today.

The state adjutant general issued the order, it was stated, after Sheriff Mill Gould had asked Governor Allen for troops to handle the situation.

PITTSBURGH, Kan., Dec. 14.—Following instant reports that a mob of women marchers was headed toward Pittsburg, and that the seizure of Van A. Bittner, representative of the International Miner's union here, was planned, a squad of American Legion men was hastily formed for duty at a hotel which is headquarters for Bittner. In the lobby was a stack of rifles.

PITTSBURGH, Kan., Dec. 14.—Two blasts heard all over the north part of Crawford county wrecked a steam shovel of the Menghini Coal company early today. The plant was under lease by the company to a number of miners and had not been operated for two or three weeks.

IDENTIFY BODY OF MURDERED VETERAN

MOLLALA, Or., Dec. 14.—Positive identification by Judge Grant Dinick of Oregon City of the body of Everett F. Davis, former army lieutenant, found Monday in a cabin on Davis' homestead near here, removed doubts as to whether the body was that of Davis.

The coroner's jury late yesterday returned a verdict finding Davis had come to his death by a blow from an axe in the hands of an unknown person. No further clues have developed. Authorities were awaiting word from Davis' father at Bellefontaine, Ohio, for disposal of the body.

Name German Envoy.
PARIS, Dec. 14.—A dispatch from Berlin today quotes the Zeitung Am Mittag as saying it understands the naming of Dr. Andreas Hermes, the minister of food, as German ambassador at Washington, has been decided upon.

POPP MARKS OPENING OF PARLIAMENT

Royal Pageant and Golden Wheeled Cabs Greet Dignitaries—Erin Peace in Balance—Lloyd George Speech Cheered—Most Momentous Westminster Session.

LONDON, Dec. 14.—(By the Associated Press.)—While ratification of the peace treaty between Great Britain and Ireland was being urged by speakers in the house of commons this afternoon, Prime Minister Lloyd George entered the house and was received with a storm of cheers. He was observed again as he rose to speak on the agreement. No agreement ever concluded between two peoples had received so universal a welcome, he declared.

LONDON, Dec. 14.—(By the Associated Press.)—The special session of parliament today to consider the Irish peace settlement, which probably will rank among the most momentous in the history of Westminster, was opened at noon with the reading of the speech from the throne in the house of lords by King George. It was attended by all the brilliant display of pageantry marking state occasions with gorgeous arrayed guardsmen lining the way from Buckingham palace to parliament square, a colorful avenue through which rolled the golden coaches bearing their majesties and dignitaries of state, preceded, flanked and trailed by the glittering environment of the royal household.

The traditional "address" to be moved in both the house of lords and the commons, probably Friday, records appreciation of the speech from the throne and contains the assurance of parliament's approval of the settlement terms and its readiness to make effective the articles of agreement.

Members of the conservative party in the house of commons who sympathize with Ulster's position have decided to move an amendment to the address, replying to the king's speech, and press it to a decision.

"My lords and ladies of the house of commons: "I have summoned you to meet at this unusual time in order that the articles of agreement, which have been signed by ministers and the Irish delegation and at once be submitted for your approval. No other business will be brought before you at the present session.

SPRING WEATHER EASTERN OREGON, GARDENS ARE UP

PENDLETON, Or., Dec. 14.—Springlike weather has followed the recent blizzard which covered Eastern Oregon with a thick blanket of snow. Monday the maximum temperature was 70 degrees, and the lowest the mercury went was 40.

One resident reported finding volunteer peas and lettuce in his garden here. One green pea vine was 16 inches long, and there was a dozen vines which measured six inches.

The same kind of weather prevailed in the eastern part of the state 25 years ago, old settlers declare. A snow measuring four feet in depth fell that year in November, and the remainder of the winter was very mild. A three-foot snow fell last month.
