A NEGLECTED LAW.

DISTRICT ATTORNEY BRADY of San Francisco is right. He says it is more important to prosecute persons for perjury, than persons charged with felony. So he has started action against two witnesses for the defense in the Arbuckle, trial, who have been indicted for perjury by the grand jury.

Nothing would do more for the cause of justice, and more to purify the legal atmosphere of America, than a few conspicuous perjury convictions. Nothing has done more to lower public respect for the courts than the scandalous increase in flagrant disregard of the witnesses' oath to tell the truth.

There is scarcely a trial held in any court today, where perjury is not committed. Everyone knows this. One side or the other in nearly every action of importance, convicts either itself or the other side of telling what isn't true. For almost invariably the testimony absolutely conflicts.

In the recent Mary Pickford case in New York city, the judge told the jury that one side or the other committed perjury. But the jury returned its verdict and no further action was taken.

The difficulty in securing a conviction in a perjury case is well known. But indifference on the part of the legal profession and court officers, has been largely responsible for this condition.

District Attorney Brady has inaugurated a policy, which if consistently adopted and vigorously pursued, may well lead to a reform movement throughout the country.

Putting a few lying witnesses in the penitentiary, where they belong will do more than anything else, to remove this disgraceful blot on the character of criminal jurisprudence in this country.
