

# DR. KAPP OFFERS TO SURRENDER TO AID VON JAGOW

BERLIN, Mar. 8.—(By Associated Press.) Dr. Wolfgang Kapp, who led the revolution in March, 1920 which resulted in the temporary overthrow of the Weimar government, has offered to surrender for trial with the understanding he be given safe conduct and not be placed under arrest. His proposal has been forwarded to the supreme court at Leipzig from an unnamed port in Sweden.

The insurgent leader has been domiciled in Sweden since his flight from Germany. The news of Kapp's willingness to stand trial was made public through the Dresden Nachrichten which prints a letter from Kapp in which he charges that the conviction of Trautmann von Jagow, former chief of police of Berlin, "was a legal error."

According to the letter Kapp proposes to demonstrate this by standing trial on the same charge, thereby virtually obtaining a re-hearing for Von Jagow.

"Honor and conscience demand that I come forward in defense of the condemned man," the letter said.

The letter was signed by Kapp, who identified himself as "royal Prussian privy administration councillor."

## PHOENIX SCHOOL NOTES

The Teachers' council met at the high school building Saturday, March 4th.

Miss Homes has divided the county into twelve councils, this being called the central council. These councils take the place of local institutes. Miss Homes thinks that they will be much more efficient than the old plan.

The following program was followed out with much interest and benefit: Mrs. Ferns of the Ferns Valley school explained how she taught geography. Mrs. Ferns stated that she taught two counties at the same time.

She brought out the fact that when an oral lesson came up that the pupil had to read well before allowed to quit. Not how much, but how well.

Miss Carver of the Ashland schools lectured on the subject of physical training. Miss Carver said many good things, she said correct teaching of physical training should make for clean habits and clean living; she gave an example of her work, showing how easily a teacher could give an exercise in the class room.

Miss Homes explained the uniform Jackson county drill, which she expects to have all the schools put on some time in May at Ashland.

The Teachers' council elected the following officers: J. R. Tyrrell, chairman, Miss Edith Fish secretary and treasurer.

Gorgeous—that's the adjective. "Peacock Alley"—that's the picture. By way of criticism I need only quote one of the screen-show titles: "Cleo, the beautiful, famed like a radiant jewel."

Mae Murray is the star. Once you remember, she was "The Gilded Lady." Now she is the flaming star, the radiant jewel, the dancing darling, Cleo.

"Peacock Alley" must be placed well in the front rank of the best recent productions on account of the lavishness of production, the interesting scenes from the dancer's life in Paris and New York. The beauty and ability of the star herself, the general excellence of the acting and particularly on account of the use of colors in the presentation of the introductory scenes.

Thus far the colored photography of the screen has ranked in artistic value about on a par with the use of colors in the tinting of photographs, though scientific advances may at any time remove the unnaturalness of effect. The "Peacock Alley" pictures in color do show advancement. They display good judgment and not too much ambition, with well-directed attractiveness in giving absolutely life-like radiance to the "gorgeous" Miss Murray.

The story of "Peacock Alley" merely serves as a basis for the work of Miss Murray and the beautiful scenes, for in itself it has no great dramatic force. Monte Blue plays the youthful hero in a well chosen cast that includes Edmond Lowe, formerly of the Alcazar.—San Francisco Examiner.

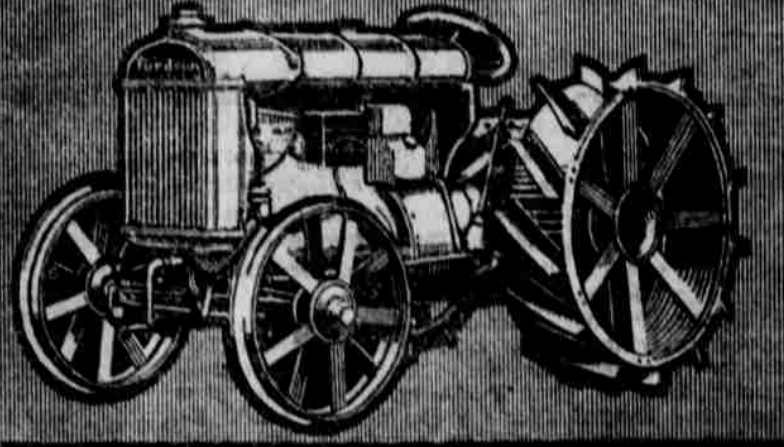

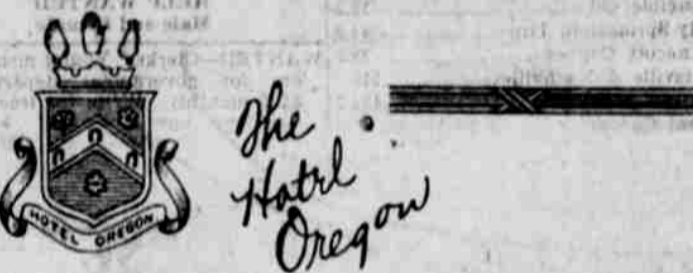
