I asked to see the pears, and the day we landed in Calcutta he took me down to his cold storage plant. "I found some Hood River Spitzenberg in excellent shape and several, 5 I think, cases of Gold Crest brand Winter Nellis pears packed by Guy Conner. They were in perfect condition although the paper wraps were entirely wet. He spoke very highly of them. It may be truly said that Rogue River pears go to all parts of the world. "If you ever have a choice of steamers to travel on choose a shipping board boat."

NEW YORK, Mar. 16.—More than 3,000,000 men, women and children, members of the Presbyterian church in all parts of the United States will abjure many of life's minor pleasures for a week, so that they may contribute in money to church work. It was announced today. This is to occur from March 19-26 to be known as "self denial week" and was suggested by Dr. Henry Sewarngen, moderator. The money donated as a result of the self denial is to be given to the funds for missionary, educational and benevolent boards.

Refuse Mediation in Klamath F. Walk Out

PORTLAND, Ore., Mar. 17.—Although no direct response has been received by W. F. Woodward, chairman of the state board of conciliation, from the mayor of Klamath Falls, in response to Woodward's offer of mediation in the lumber strike, letters received by Woodward from other sources, he said, today indicate that the employers in the mills there would not seek arbitration at this time.

FREEDING POLITICAL PRISONERS CAUSES STORM, CONGRESS

WASHINGTON, Mar. 16.—Declaration by Representative Meyer London, socialist, New York, that if he had the power, he would release all prisoners convicted of violence because of sincere opposition to war, started a wery row today before the house judiciary committee.

Appearing in support of his resolution which would recommend to President Harding amnesty for 113 prisoners, Mr. London and several other witnesses were trying to speak at once when above the din, he shouted his opinion.

There was a ripple of applause from the crowd, largely composed of women. "By that you stand here and advocate violence," Representative Yates, republican, Illinois, declared, but Mr. London disclaimed such intentions.

Alexander S. Lanier, a Washington lawyer, who was present in the interest of one of the I. W. W. prisoners, attacked war time slakers who he asserted, had attempted to overthrow the selective draft and obstruct the government "through the cloak of religion."

Urging adoption of the London resolution, Albert Silver, associate director of the American Civil Liberty union, declared that none of the prisoners for whom an appeal was made had committed overt acts except in speeches and in the writings during war times.

Representative Burke, Cockran, democrat, New York, who recently interceded with the department of justice for a pardon for Daniel O'Connell of San Francisco, told the committee the political agitator's importance should not be magnified by keeping him in prison. A bill granting amnesty to the 113 ought to be passed in the interest of the government, regardless of those involved, he declared, adding that in Ireland a "jail sentence was a passport to respectability."
